Explanatory note

The object of this Regulation is to exclude the New South Wales Grains Board from the definition of *authority* for the purposes of Part 2C of the *Public Authorities (Financial Arrangements) Act 1987*, which regulates guarantees. As a result, the repayment of certain financial accommodation obtained by the New South Wales Grains Board will not be subject to a Government guarantee under Part 2C.

This Regulation is made under the *Public Authorities (Financial Arrangements) Act 1987*, including the definition of *authority* in section 3 (1), section 3 (4) and section 43 (the general regulation-making power).

[1] Clause 57A Entities excluded from definition of “authority”

Insert after clause 57A (2B):

- (2C) The New South Wales Grains Board (constituted by the *Grain Marketing Act 1991*) is prescribed as not being within the definition of *authority* in section 3 (1) of the Act for the purposes of Part 2C of the Act.

[2] Clause 57A (3)

Omit “(2), (2A) or (2B)” wherever occurring. Insert instead “(2), (2A), (2B) or (2C)”.
