### Veterinary Surgeons Amendment (Fees) Regulation 2001

under the

Veterinary Surgeons Act 1986

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Veterinary Surgeons Act 1986*.

#### Explanatory note

The object of this Regulation is to amend the *Veterinary Surgeons Regulation 1995* (the Principal Regulation) so as to alter certain fees payable under the *Veterinary Surgeons Act 1986* relating to veterinary surgeons and veterinary hospitals.

This Regulation also:

- (a) adds new fees to the Principal Regulation as follows:
  - (i) the fee for the inspection of the register of veterinary surgeons or the register of specialists,
  - (ii) the fee for providing a duplicate certificate of registration,
  - (iii) the fee for the Board of Veterinary Surgeons to provide a Letter of Professional Standing in respect of a person registered under the Act, and
- (b) removes from the Principal Regulation the distinction relating to registration and annual roll fees payable by persons employed under Part 2 of the *Public Sector Management Act 1988* or the *Zoological Parks Board Act 1973* and other persons not employed under those Acts.
