Clause 1 Kiama Local Environmental Plan 1996 (Amendment No 60)

Kiama Local Environmental Plan 1996 (Amendment No 60)

under the

Environmental Planning and Assessment Act 1979

1 Name of plan

This plan is *Kiama Local Environmental Plan 1996 (Amendment No 60)*.

2 Aims of plan

This plan aims to amend *Kiama Local Environmental Plan 1996 (the 1996 plan)*:

- (a) to rezone part of the land to which this plan applies for business and residential purposes, and
- (b) to amend certain provisions of the 1996 plan to restrict subdivision of existing large lots in rural and environmental protection (scenic) zones, and
- (c) to provide for the development of several sites in accordance with requirements in the 1996 plan and with regard to a master plan prepared to guide the development of those sites, and
- (d) to allow, with the consent of the Council of the Municipality of Kiama, the carrying out of development for the purpose of an existing motel and restaurant to be converted to serviced apartments.

3 Land to which plan applies

- (1) To the extent that this plan rezones land, it applies to certain land near Bong Bong Street, at the corner of Hothersal and Gipps Streets and in Farmer Street, Kiama, as shown edged heavy black on Sheets 1–3 of the map marked “Kiama Local Environmental Plan 1996 (Amendment No 60)” deposited in the office of the Council of the Municipality of Kiama.
- (2) To the extent that this plan restricts subdivision of existing large lots, it applies to land zoned Rural “A” and Rural Environmental Protection (Scenic) under the 1996 plan.

- (3) To the extent that this plan enables development of certain sites after consideration of a master plan, it applies to land at the corner of Manning and Terralong Streets, Kiama (known as “Commonwealth Bank Corner”), to the east of Manning Street, Kiama (known as the “New ‘Church Lane’ Sub-Precinct”), at the corner of Jupiter and Morrow Streets, Gerringong (known as the “Boat Harbour Mixed Residential Precinct”), and at Belvedere Street, Kiama, as shown edged heavy black and diagonally hatched on Sheets 5, 6, 7 and 8, respectively, of that map.
 - (4) To the extent that this plan permits an additional use, it applies to land in Fern Street, Gerringong, as shown edged heavy black on Sheet 9 of that map.
 - (5) This plan does not apply to land shown as “deferred matter” on Sheets 1 and 4 of that map, which has been excluded from this plan under section 68 (5) of the *Environmental Planning and Assessment Act 1979*.

47AA Definitions

In this Part:

master plan means an instrument and supporting diagrams, or a number of instruments and supporting diagrams, that outline proposals and principles to guide master plan development of a master plan site.

47AB Development of master plan sites

- (1) Despite any other provision of this plan, master plan development may be carried out with development consent on a master plan site, but only if:
 - (a) the development complies with the development requirements specified for the site in Schedule 5, and
 - (b) the consent authority has taken into consideration the master plan for the site as adopted by the Council for the time being in accordance with this Part.
- (2) Provisions or instruments identified in Schedule 5 as comprising the initial master plan for a master plan site are taken to have been adopted by the Council with the approval of the Minister in accordance with this Part as a master plan at the commencement of this Part, but nothing prevents the amendment or replacement of any such master plan in accordance with this Part.
- (3) *State Environmental Planning Policy No 1—Development Standards* does not apply to any development standard imposed on master plan development by a development requirement specified in Schedule 5, except as provided otherwise in that Schedule.
- (4) *State Environmental Planning Policy No 71—Coastal Protection* does not require a master plan to be adopted by the Minister under that Policy before consent is granted for master plan development of a master plan site.
- (5) The Council must make a copy of each master plan, as adopted by the Council for the time being, available for inspection at the office of the Council during ordinary office hours.
- (6) Nothing in this Part prevents development from being carried out on a master plan site in accordance with the other provisions of this plan, subject to the conditions of any consent granted for master plan development.

47AC Amendment or replacement of master plans

- (1) A master plan for a master plan site, as adopted by the Council for the time being, may be amended, or revoked and replaced, by a subsequent master plan adopted by the Council in accordance with this clause.
- (2) A master plan may be amended or revoked and replaced only if the master plan as proposed to be amended or the replacement master plan will illustrate and demonstrate proposals for the following:
 - (a) the use or uses to be carried out on the development site, including the use of buildings,
 - (b) design principles drawn from an analysis of the development site and its context,
 - (c) desired future locality character,
 - (d) the location of any development, considering the natural features of the site, including coastal processes and coastal hazards,
 - (e) the scale of any development and its integration with the existing landscape,
 - (f) impact on, and improvements to, the public domain,
 - (g) phasing of development,
 - (h) public access to and along the coastal foreshore,
 - (i) pedestrian, cycle and road access and circulation networks,
 - (j) subdivision pattern,
 - (k) infrastructure provision,
 - (l) building envelopes and built form controls,
 - (m) heritage conservation, including both Aboriginal and European heritage,
 - (n) remediation of the site,
 - (o) provision of public facilities and services,
 - (p) car parking provision,
 - (q) provision of open space, its function and landscaping,
 - (r) conservation of natural waters, including their riparian corridors, water quality and use,
 - (s) identification and conservation of native flora and fauna and their habitat on the site, including any threatened species, populations or ecological communities,
 - (t) conservation of fish and aquatic animals and their habitats.

- (3) A draft master plan prepared to amend, or to revoke and replace, a master plan must be publicly exhibited by the Council for not less than 28 days and a copy must be sent to the Director-General.
 - (4) After considering any written submissions made to it within that time, the Council:
 - (a) with the approval of the Minister, may adopt the draft master plan either with or without alteration, or
 - (b) may reject the draft master plan.
 - (5) The Minister is taken to have approved adoption of a draft master plan if, within 28 days after a copy of it was sent to the Director-General, neither the Director-General nor the Minister has made any written response to the Council concerning adoption of the draft master plan.
 - (6) Before adopting a draft master plan that has been altered, the Council must re-exhibit it with the alterations:
 - (a) if the Minister has required re-exhibition, or
 - (b) if the Council is of the opinion that the alterations are sufficiently significant to require re-exhibition.
 - (7) When the Council adopts a draft master plan, it must:
 - (a) notify the Minister, the person who prepared the master plan (if it was not the Council) and any person who made a written submission about it of the adoption of the master plan, and
 - (b) advertise the adoption of the master plan in a newspaper circulating in the locality, and
 - (c) make a copy of the adopted master plan available for inspection at the office of the Council during ordinary office hours.

[5] Schedule 4 Development for certain additional purposes

Insert at the end of the Schedule:

- Lot 900, DP 616677, No 1 Fern Street, Gerringong, as shown edged heavy black on Sheet 9 of the map marked “Kiama Local Environmental Plan 1996 (Amendment No 60)” —development of the existing building (that was used before the commencement of this item as a motel and restaurant) for the purpose of serviced apartments that do not include residential accommodation for permanent residents.

1 Commonwealth Bank Corner master plan site

Land fronting Manning Street and Terralong Street, Kiama, as shown edged heavy black and with diagonal hatching on Sheet 5 of the map marked “Kiama Local Environmental Plan 1996 (Amendment No 60)”.

Master plan development for this site

Development for the purpose of mixed tourist, commercial, retail and residential uses that meets the *Kiama Town Centre Charrette Objectives* (in so far as they relate to this master plan site) and the *Design Brief for Commonwealth Bank Corner*, copies of which are available at the office of the Council.

Initial master plan

The section titled *Indicative Design for the Commonwealth Bank Corner* and other provisions that relate to this master plan site in the report titled *Kiama Town Centre Charrette 25–29th July 2002—A report on the Charrette Outcomes* (the ***Kiama Charrette Report***), copies of which are available at the office of the Council, comprise the initial master plan for this site.

Development requirements

The following requirements apply to master plan development on this site:

- (a) lots must be consolidated to create a single lot with not less than the minimum area required for this site by the Kiama Charrette Report,
- (b) the single lot must be occupied by a significant building in which the mixed tourist, commercial, retail and residential uses will be carried out,

- (c) the building may have a maximum building height of 4 storeys above ground level, subject to there being terraces not less than 3 metres wide along more than half of the top floor punctuated by corner and centrally disposed habitable towers aligning with the street-front property lines of the building as described in the Kiama Charrette Report,
 - (d) the building must include a hotel with a reception area and related restaurants, cafes and shops at street level,
 - (e) the building must be designed so that people visiting the building will have access to indoor and outdoor areas on the top floor and so that use of the top floor will encourage such access (for example, a restaurant or function room would be a suitable use for the top floor),
 - (f) the architectural design of the building must have regard to the heritage value of the streetscapes of the streets to which it has frontage. The building must have a traditional and reasonably symmetrical exterior that, in the opinion of the consent authority, makes a landmark contribution to Kiama's character. There must be double verandahs over the footpaths of both Terralong and Manning Streets that are at least 2 metres deep. All window and door openings and spacings between verandah posts must have greater height than width and be vertically aligned between floors as described in the Kiama Charrette Report,
 - (g) a basement storey for car parking is to be located below ground level with some unenclosed on-site parking at grade behind the location of the L-shaped building shown in the Kiama Charrette Report "indicative design".

For the purpose of allowing development to be carried out in accordance with the above development requirements, *State Environmental Planning Policy No 1—Development Standards* applies to a maximum floorspace ratio set by clause 21 to the extent that compliance with that development standard would be unreasonable or unnecessary to achieve the setbacks shown for buildings on this site in the Kiama Charrette Report "indicative design".

2 New “Church Lane” sub-precinct master plan site

Land to the east of Manning Street, Kiama, as shown edged heavy black and with diagonal hatching on Sheet 6 of the map marked “Kiama Local Environmental Plan 1996 (Amendment No 60)”.

Master plan development for this site

Development for the purpose of mixed uses, including shops, commercial premises and serviced apartments and residential apartments above the ground level storey, that meets the *Kiama Town Centre Charrette Objectives* (in so far as they relate to this master plan site) and the *Design Brief for Church Lane*, copies of which are available at the office of the Council.

Initial master plan

The section titled *Indicative Design for Church Lane* and other provisions that relate to this master plan site in the report titled *Kiama Town Centre Charrette 25–29th July 2002—A report on the Charrette Outcomes*, copies of which are available at the office of the Council, comprise the initial master plan for this site.

Development requirements

The following requirements apply to master plan development on this site:

- (a) the building may have a maximum building height of 4 storeys above ground level, subject to top floor terraces being provided to residential or serviced apartments facing streets for at least half those street frontages,
- (b) the building must include shops and commercial premises, serviced apartments, visitor accommodation and home based businesses or church-related uses at the street level with residential or serviced apartments above,
- (c) the architectural design of buildings must have regard to the heritage value of the streetscapes of the streets to which they have frontage. The building must have a traditional and reasonably symmetrical exterior that, in the opinion of the consent authority, makes a sympathetic contribution to Kiama’s visual character. There must be verandahs at least 2 metres deep at ground level. All window and door openings and spacings between verandah posts must have greater height than width and be vertically aligned between floors,

- (d) On-site parking at grade is to be minimised and must be located behind buildings rather than in front of them. Below ground basement parking is to be provided for residential development.

For the purpose of allowing development to be carried out in accordance with the above development requirements, *State Environmental Planning Policy No 1—Development Standards* applies to a maximum floorspace ratio set by clause 21 to the extent that compliance with that development standard would be unreasonable or unnecessary to achieve the setbacks shown for buildings on this site in the Kiama Charrette Report “indicative design”.

3 Boat Harbour Gerringong mixed residential precinct master plan site

Land fronting Coal, Jupiter and Morrow Streets, Gerringong, as shown edged heavy black and hatched on Sheet 7 of the map marked “Kiama Local Environmental Plan 1996 (Amendment No 60)”.

Master plan development for this site

Development for the purpose of a residential flat building.

Initial master plan

The instrument titled *Mixed Residential Housing Precinct Boat Harbour Gerringong*, prepared by PRM Architects + Town Planners and dated 25 November 2002, copies of which are available at the office of the Council, amended to the extent necessary to allow development on this site to comply with any inconsistent development requirements specified below, comprises the initial master plan for this site.

Development requirements

The following requirements apply to master plan development on this site:

- (a) buildings are to be grouped in the locations shown in the instrument titled *Mixed Residential Housing Precinct Boat Harbour Gerringong*,
- (b) the number of dwellings is not to exceed 49,
- (c) building height is not to exceed:
 - (i) 3 storeys where the lowest storey is identified in the initial master plan as providing basement underground car parking, and

- (ii) 2 storeys plus loft room in a building identified for the purpose in the initial master plan and situated on another part of the site, and
 - (iii) 2 storeys elsewhere on the site,

 - (e) a new public street (identified in the initial master plan as "Harbour Link Road") having an overall road reserve width of 8 metres must be provided through the site, in the same or approximately the same location as shown in the initial master plan,
 - (f) part of the site must be dedicated to the Council for public road widening purposes in Morrow Street to provide a variable width street enabling two-way vehicular movement, car parking and a pedestrian footpath,
 - (g) all requirements of this plan and of development control plans that apply to development for the purpose of multiple dwelling housing in Zone No 2 (a), except to the extent, if any, those requirements:
 - (i) are inconsistent with any other of the development requirements included in this item, or
 - (ii) would prevent master plan development for this site from being carried out.

4 Belvedere Street master plan site

Lot 5, DP 628003, Belvedere Street, Kiama (which also has frontage to Garden Avenue), as shown edged heavy black and with diagonal hatching on Sheet 8 of the map marked "Kiama Local Environmental Plan 1996 (Amendment No 60)".

Master plan development for this site

Development for the purpose of residential flat buildings comprised of groups of buildings.

Initial master plan

The instrument titled *Garden Avenue Housing*, prepared by BHI Architects and dated September 2003, copies of which are available at the office of the Council, amended to the extent necessary to allow development on this site to comply with any inconsistent development requirements specified below, comprises the initial master plan for this site.

- (a) buildings are to be grouped in the locations shown in the instrument titled *Garden Avenue Housing*,
- (b) the number of dwellings is not to exceed 40, and the single detached lot shown on the master plan drawings that is accessed from Garden Avenue is taken to be required to be used for public purposes, including a public pedestrian access linking to the unformed Thomson Street road reserve and then to the adjacent Stead Reserve,
- (c) building height is not to exceed 2 storeys,
- (d) all requirements of this plan and of development control plans that apply to development for the purpose of multiple dwelling housing in Zone No 2 (a), except to the extent, if any, that those requirements:
 - (i) are inconsistent with any other of the development requirements included in this item, or
 - (ii) would prevent master plan development for this site from being carried out,
- (e) the consent authority is satisfied that the design of the turning head in Garden Avenue south will ensure minimum adverse impact on the creek corridor,
- (f) at least 2 of the dwellings resulting from carrying out the development are designed with a floor plan suited to the needs of seniors or people with a disability,
- (g) the consent authority is satisfied that environmental restoration and management of the creek corridor will be adequate, and that limited public access will be provided, as referred to in the *Garden Avenue Development Strategy Report*, copies of which are available from the office of the Council.

1 Name of plan

This plan is *Tweed Local Environmental Plan 2000 (Amendment No 46)*.

2 Aims of plan

This plan aims to amend *Tweed Local Environmental Plan 2000* so as:

- (a) to change the interpretation of building height to reflect finished ground level rather than natural ground level, and
- (b) to change the definition of *storey* so that a storey that exceeds a specified height is counted as two storeys.

3 Land to which plan applies

This plan applies to all land to which *Tweed Local Environmental Plan 2000* applies.

4 Amendment of Tweed Local Environmental Plan 2000

Tweed Local Environmental Plan 2000 is amended as set out in Schedule 1.

 - (a) the amendments made to Schedule 1 to this plan by *Tweed Local Environmental Plan 2000 (Amendment No 46)* do not apply to the determination of the application, and

Omit the definition. Insert instead:

storey

means:

- (a) the space between two floors, or
- (b) the space between a floor and any ceiling or roof immediately above it, or
- (c) foundation areas, garages, workshops, storerooms and the like, excluding access paths to basement areas, where the height between the finished ground level and the top of the floor immediately above them exceeds 1.5 metres in height.

A storey which exceeds 4.5 metres for residential buildings is counted as two storeys.

A storey which exceeds 5 metres for commercial buildings is counted as two storeys.

For the purpose of counting the number of storeys in a building, the number is to be the maximum number of storeys of the building which may be intersected by the same vertical line, not being a line which passes through any wall of the building.

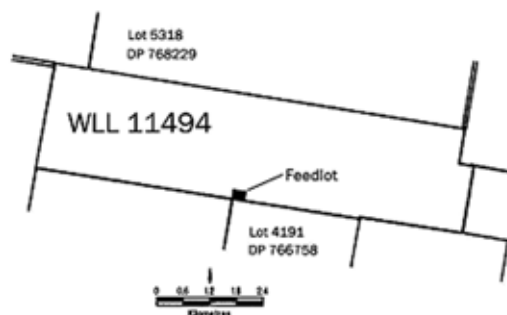

Explanatory note

The aquatic ecological community in the natural drainage system of the lowland catchment of the Darling River is listed as an endangered ecological community under the *Fisheries Management Act 1994 (the Act)*.

However, the Act enables the Minister to make an order authorising a class of persons to carry out an activity that may result in harm to an endangered species, population or ecological community or damage to its habitat. While such a proposed order is being assessed under the Act, the Minister may make an interim order lasting up to 6 months to allow an existing activity to be continued. The Act also provides for the remaking of an interim order.

The object of this interim Order is to remake the *Fisheries Management (Continuation of Activities in the Lowland Darling River Catchment) Interim Order 2004 No 2* (which took effect on 4 July 2004 for a period of 6 months) to allow certain recreational and commercial fishing activities in the natural drainage system of the lowland catchment of the Darling River to continue for a further period of 6 months.

The activities the subject of this interim Order may only continue subject to compliance with any applicable fishing regulatory controls imposed by or under the *Fisheries Management Act 1994*.

The recommendation of the Fisheries Scientific Committee referred to in this interim Order is available for inspection at all NSW Fisheries Offices and on the Internet at www.fisheries.nsw.gov.au/fsc/recomend.htm.

This interim Order is made under section 221IG of the *Fisheries Management Act 1994*.

Fisheries Management (Continuation of Activities in Lowland Darling River Catchment) Interim Order 2005 No 1

under the Fisheries Management Act 1994

1 Name of interim Order

This interim Order is the *Fisheries Management (Continuation of Activities in Lowland Darling River Catchment) Interim Order 2005 Number 1*.

2 Commencement and duration

This interim Order:

- (a) takes effect on 4 January 2005 and
- (b) ceases to have effect 6 months after that day.

3 Continuation of existing activities

(1) The activities referred to in subclauses (2) and (3) may continue in the Lowland Darling River Catchment subject to compliance with any applicable fishing regulatory controls.

(2) A recreational fisher may take from the Lowland Darling River Catchment any of the following species of fish, may possess any such species of fish taken from the Lowland Darling River Catchment, or may carry out any routine activity in connection with any such taking or possession:

- (a) *Paratya australiensis* (freshwater shrimp),
- (b) *Macrobrachium australiense* (freshwater prawn),
- (c) *Caridina mccullochi* (freshwater shrimp),
- (d) *Cherax destructor* (yabby),
- (e) *Tandanus tandanus* (freshwater catfish),
- (f) *Gadopsis marmoratus* (river blackfish),
- (g) *Maccullochella peelii peelii* (Murray cod),
- (h) *Macquaria ambigua* (golden perch),
- (i) *Bidyanus bidyanus* (silver perch),
- (j) *Nematalosa erebi* (bony bream),
- (k) *Lelopotherapon unicolor* (spangled perch).

(3) A person holding a commercial fishing licence that has a Class A: Yabby and carp endorsement (transferable) in the inland restricted fishery may:

- (a) take *Cherax destructor* (yabby) from the Lowland Darling River Catchment, or
- (b) possess or sell yabby taken from the Lowland Darling River Catchment, or
- (c) carry out any routine activities in connection with any such taking, possession or sale.

(4) In this clause:

applicable fishing regulatory controls means requirements imposed by or under the *Fisheries Management Act 1994* that apply to or in respect of the activities concerned.

inland restricted fishery has the same meaning as in the *Fisheries Management (General) Regulation 2002*.

Practice Direction Number 1 of 2005

Court Appointed Experts – Practice Direction

THIS Practice Direction commences on 1 February 2005.

1. The purpose of this Practice Direction is to give guidance to parties and to expert witnesses as to the process of appointment of experts by the Court in proceedings in Classes 1, 2 and 3, how such experts are to conduct themselves and prepare their evidence, provide it to the parties and give evidence at any hearing. If a party believes that in the circumstances of a particular appeal the process should be varied from that contemplated in this Practice Direction the proposed variation should be raised with the other parties and the Court.
2. Expert evidence is commonly given in proceedings in classes 1, 2 and 3 of the Court’s jurisdiction. It may involve the identification of facts as well as the expression of opinions following analysis of the facts. In an endeavour to reduce costs and to ensure that the Court has the benefit of evidence from a person who is not engaged by only one party, the Court has adopted procedures which provide for the Court to appoint experts.
3. For this purpose the Land and Environment Court has adopted Part 39 of the Supreme Court Rules 1970, which makes provision for the Court to appoint an expert to inquire into and report on any question in the proceedings. The rules make provision for the appointment of the expert, provision of a report, the remuneration of the expert and the receipt of the expert’s report into evidence.
4. Pre-Hearing Practice Direction No 17 makes provision for expert evidence and the appointment of experts by the Court. This Practice Direction should be read in conjunction with Pre-Hearing Practice Direction No. 17. Where there is conflict between this Practice Direction and Practice Direction No 17 this Practice Direction prevails. In due course Practice Direction No 17 will be revised.
5. At the first call over, or as soon as possible thereafter, the Court will consider whether it is appropriate to appoint a person as the court expert to give evidence with respect to any issue or issues in the proceedings. Before a person

is appointed it is expected that the parties, or their legal advisers, will have agreed with the expert the basis upon which that person will be remunerated and the quantum of the remuneration. If there is no agreement on the basis for remuneration of the expert the Court will determine it. The basis for remuneration may provide for a capped fee arrangement, an hourly rate or a combination or variation of these arrangements.

6. It will be necessary for the parties or their legal advisers to approach experts to discuss their possible appointment by the Court, identify their availability and agree upon the appropriate remuneration. However, a party must not seek the preliminary views of the expert on any question before offering that person's name as an expert. If such an enquiry is made by a legal practitioner it may constitute professional misconduct or contempt of court and may disqualify the expert from giving evidence.
7. If an expert is approached for appointment that person must disclose to the party making the approach whether he or she has had any prior dealings with the applicant or respondent, the landowner or the developer of the project or otherwise in relation to the project itself. If the expert has concerns that he or she may not be able to bring an impartial mind to the issues in dispute, this must be disclosed to the party making the approach.
8. The Court expects that the basis for remuneration of the expert will be that which the expert normally charges when undertaking court work for individual parties. The Court will not fix a level of remuneration which is greater than that person's usual rate of charging and may require evidence of the expert's usual rate before making the appointment. The parties are jointly and severally liable for the expert's fees and the expert must look to the parties for payment. The legal profession owes the usual obligation to an expert which a practitioner has engaged for payment of the expert's fees. If requested by the parties appropriate arrangements will be made for the expert's fees to be paid into court and held pending the resolution of the matter. As an alternative the parties could agree that each party's share of the fees will be held in an appropriate account on trust and paid out when owing to the expert. It would be preferable for the parties to confirm the fee arrangement with an expert in writing.
9. The evidence of an expert appointed by the Court will, subject to the objection of any party, be received as evidence in the proceedings. It will be considered by the Court together with any other evidence relating to the relevant issues.
10. A Court expert may approach any party, at any time, to obtain information, but must inform the other parties. Any party may also approach the expert with relevant information, but must inform the other parties.
11. To ensure that the expert is both perceived to be and remains independent from any party, discussions about the issues in the matter or any communication of the opinion of the expert should only occur when a representative of each party is involved in the discussion. Communication about incidental matters eg requests for basic information such as the relevant planning controls, plans, survey material, copies of other reports and the like may take place with one party provided the other parties are informed as to the information sought and the response which was given. Wherever possible such communication should be by email and copied to the other parties. Experts appointed by the Court are to conduct themselves in a manner which maintains the confidence of the parties and any objectors in their independence.
12. Although the Court will decide whether an expert or experts should be appointed the Court expects the parties to agree on the particular person or persons to be appointed. Failing agreement the Court will make the appointment. Where there is no agreement the parties shall provide a list of up to three experts acceptable to that party and the fee arrangement which each expert requires.
13. As soon as convenient after an expert has been appointed the parties must provide the expert with copies of all relevant documentation in relation to the project including, plans, relevant correspondence and reports which may be of assistance to the expert appointed by the Court. Each party must inform the other party, or parties of the information which they have provided to the expert and, where appropriate, provide the other party with copies of documents. The parties must ensure the expert is informed of any directions made by the Court relevant to the tasks requiring completion by that expert.
14. The Court may direct the expert to report orally to the parties and subsequently provide a written report. In some cases, only an oral or written report may be required. If, after reviewing the oral or written report of the expert, a party intends to seek leave to call another expert at the hearing that party shall immediately notify the Court and the other parties that an application is to be made. The Registrar shall then arrange for the Chief Judge to appoint a judge or commissioner to hear the matter and arrangements will be made for the application for leave to be heard at the earliest convenient date. If leave is granted, the Court will, if possible, give directions which ensure that, if a hearing date has been fixed, it is not lost. The communication with the Registrar and any application thereafter may be made by telephone or e-court if this is convenient. A written motion will not be required. The Court encourages the use of these processes which can save time and expense for parties.
15. In summary, the obligations of an expert appointed by the Court include the following:
 - (a) To receive and review written documentation provided by the parties to the proceedings.
 - (b) If required by a party or parties, or if the expert believes it to be necessary, to meet with a representative of each party for the purpose of obtaining any information relevant to the issue or issues requiring report by the expert. Such meetings should only occur in the presence of a representative of each party unless the parties otherwise agree.
 - (c) If the expert is of the opinion that it is necessary, visit the site in the presence of the parties or with their knowledge, and make any inquiries, including visiting objectors' properties, necessary to enable the expert to report to the Court.
 - (d) Experts should address objectors concerns, if any, even when these are not identified separately in the Statement of Issues.

- (e) If so directed by the Court, or if otherwise appropriate in the expert’s opinion, provide an oral report to the parties indicating the view the expert has reached in relation to the issue or issues, on which the expert has been directed to report, such report to be made on or before any date appointed by the Court. If the expert believes an issue could be satisfactorily resolved by an amendment of the plans or by the imposition of suitable conditions this should be stated in any oral or written report.
- (f) If so directed by the Court, to provide a written report to the Registrar of the Court and provide a copy to each party, such report to be provided on or before any date appointed by the Court. The report shall express the views the expert has reached in relation to the issue or issues on which the expert has been directed to report in order to assist the Court to determine the proceedings. The report is to be prepared with appropriate efficiency, having regard to the issues in dispute and the nature and likely cost of the proposed development.
- (g) Unless advised to the contrary, be available on the date fixed for the hearing of the matter to attend the view and give oral evidence and, if required, be cross-examined. If necessary further directions will be given during the hearing as to the need for further attendance by the expert. An expert appointed by the Court must be available to give evidence even when the outcome of the matter has been agreed between the parties.
- (h) If an expert is unsure about any aspect of his or her responsibilities, he or she should contact the Registrar for advice. The Registrar may be contacted on telephone number 9228 8388.

- (1) The making of this Order by the Wine Grapes Marketing Board under Section 5 of the Wine Grapes Marketing Board (Reconstitution) Act 2003 is specifically authorised for the purposes of section 51 of the Trade Practices Act 1974 of the Commonwealth and the Competition Code of New South Wales.
- (2) The making of this Order does not limit or remove any obligations parties to this Order may have under the Wine Grapes Marketing Board (Reconstitution) Act 2003.

5. Definitions

In this Order:

Act means the Wine Grapes Marketing Board (Reconstitution) Act 2003.

Board means the Wine Grapes Marketing Board established by the regulation set out in Schedule 1 of the Wine Grapes Marketing Board (Reconstitution) Act 2003.

Board's area of operations means the City of Griffith and the local government areas of Carrathool, Leeton and Murrumbidgee

complying contract means:

- (a) a contract that fixes:
 - (i) the prices to be paid for consignments of MIA wine grapes delivered during the current calendar year only, or the manner in which those prices are to be calculated, and
 - (ii) the date or dates by which those prices, or the various instalments of those prices, will be paid,
 being a contract entered into before the first Monday in December of the previous calendar year, or
- (b) a contract that fixes:
 - (i) the prices to be paid for consignments of MIA wine grapes delivered during both the current calendar year and one or more future calendar years, or the manner in which those prices are to be calculated, and
 - (ii) the date or dates by which those prices, or the various instalments of those prices, will be paid,
 being a contract entered into at any time before the first delivery of winegrapes under the contract, or
- (c) a contract the subject of an approval in force under section 13 of the Act.

consignee means a person to or for whom a consignment of MIA wine grapes is delivered.

consignor means a person by or from whom a consignment of MIA wine grapes is delivered.

constituted grower means for any calendar year, the class of primary producers for which the Board is constituted includes all growers within the Board's area of operation who, during the previous calendar year, harvested more than 20 tonnes of MIA wine grapes, but does not include:

- (a) in the case of a corporation:
 - (i) a grower that is also a winery, or

- (ii) a grower in which a winery has a controlling interest, or
- (b) in the case of an individual:
 - (i) a grower who is also a winery, or
 - (ii) a grower who is a director of a corporation that is a winery and who (as a grower) supplies the winery with all of the MIA wine grapes that he or she harvests.

duly contracted delivery means a consignment of MIA wine grapes that is delivered pursuant to a complying contract.

EFT means electronic funds transfer.

MIA wine grapes means any variety of grapes grown in the Board's area of operations for use for processing into wine, must, juice or wine spirit.

6. Application of sections

- (1) Section 7, 8 and 9 of this Order applies to the Terms and Conditions of Payment for all MIA wine grapes delivered to consignees by consignors that are not a duly contracted delivery.
- (2) Section 10 of this Order applies to the Terms and Conditions of Payment for the rates levied by the Wine Grapes Marketing Board under the Agricultural Industry Services Act 1998, in relation to deliveries of all MIA winegrapes from constituted growers within the Board's area of operations.

7. Terms and Conditions of Payment for the year 2005

- (1) The purchase price for all MIA wine grapes purchased shall be paid by consignees to the Board or as directed by the Board as noted in the timetables in this section and where appropriate in accordance with Section 9 of this order.
- (2) Payments made by consignees directly to the Board pertaining to deliveries of MIA wine grapes delivered to consignees by consignors.

- (1) Interest shall apply on all late payments made for purchased MIA winegrapes whether the consignee has been directed by the Board to make payments directly to consignors or not at the rate prescribed under section 95 (1) of the Supreme Court Act 1970 for payment of interest on a judgement debt, plus 5 per cent.
- (2) Payments made in accordance with this section shall occur in accordance with instruction of the Board.
- (3) Any money due to the Board, including any money that becomes payable as a consequence of the revocation of a direction under section 10 of the Wine Grapes Marketing Board (Reconstitution) Act 2003 may be recovered as a debt.

9. Manner and timing in which payments are to be made

- (1) Notwithstanding any previous section in this Order this clause applies to payment by all consignees accepting deliveries of MIA wine grapes from consignors otherwise than pursuant to a direction by the Board. Payments are to be:
 - (i) Paid as a valid bank cheque made out to the Wine Grapes Marketing Board and received by the Board by 12 midday of the due date, or
 - (ii) Transferred to the Board's nominated banking account by EFT so as to cause all funds to be cleared by the due date. A confirmation of the transaction must be forwarded by facsimile to the Board on the same day.
- (2) Notwithstanding any previous section in this Order this clause applies to all payments made to consignors by consignees accepting deliveries of MIA wine grapes from consignors pursuant to a direction under the Act by the Board:
 - (i) Made available as a cheque made out to the consignor for pickup by consignors by 12 midday on the due dates, or
 - (ii) Transferred by EFT to consignor's nominated banking account so that funds are cleared by the due dates. A confirmation of the transaction must be forwarded to the grower on the same day, or
 - (iii) Sent as a cheque made out of the consignor via Australia Post to consignors post marked on the date directed.
- (2) No payments made available for consignor pickup are to be retained by the consignee for greater than 24 hours.

- (3) Revocation of a Board direction may result from non-compliance of the manner within this Order.

10. Calculation and payment of Wine Grapes Marketing Board levies

- (1) Levies are applicable on deliveries of MIA wine grapes on all constituted growers.
- (2) The leviable rate for 2005 is \$3.90 per tonne (fresh weight) of winegrapes.
- (3) In the case of a consignee receiving Board direction to make payments to consignors directly the levy amount shall be deducted by the consignee from the payment for deliveries of MIA wine grapes and then remitted to the Board in the following timetables and structure.

- (4) Payments of levies by consignees in accordance with Table 4: Alternate Payments of Levies to the Board are required to advise the Board in writing by 29th April 2005. No penalty or discount will be provided to the consignee for payments made in this manner.

- (5) Failure to remit levies to the Board within the timetable, structure and the approved manner may cause a revocation of a Board direction made in accordance with this Order.

- (6) All levies payable to the Board in accordance with the timetable in Subsection 3 of this Section are to be paid to the Board in the following manner:

- (i) To the Board's nominated banking account by EFT on the due dates, including a confirmation of the transaction sent by facsimile to the Board on the same day, or
- (ii) Sent as a business cheque made out to the Wine Grapes Marketing Board via Australia Post postmarked on the due dates.
- (iii) Delivered to the registered offices of the Board on the due dates.

TRAVEL AGENTS ACT 1986 LIST OF LICENSED TRAVEL AGENTS

SECTION 40 (2) of the Travel Agents Act 1986 requires the Commissioner for Fair Trading to publish in the Government Gazette from time to time a list of licence holders.

Section 40 (7) of the Act deems the supplier of travel services to an unlisted travel agent to have aided and abetted that person in carrying on business as a travel agent. Thus the supplier could be subject to the same penalty of 500 penalty units as the agent is trading without a licence.

Suppliers of travel services should not deal with an unlisted person or corporation unable to produce a travel agent's licence.
