ACTS OF PARLIAMENT ASSENTED TO

Legislative Assembly Office, Sydney, 14 April 2005

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of Her Majesty, this day assented to the undermentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 9 2005 – An Act to amend the Civil Liability Act 2002 to make further provision with respect to claims for damages for negligence for death or injury suffered by offenders in custody; and for other purposes. [**Civil Liability Amendment Offender Damages) Bill**]

Act No. 10 2005 – An Act to amend the Independent Commission Against Corruption Act 1988 to make further provision with respect to the functions of the Commission; to amend the Police Integrity Commission Act 1996 to extend the provisions of that Act relating to police officers to other members of NSW Police; and for other purposes. [**Independent Commission Against Corruption Amendment Bill**]

Act No. 11 2005 – An Act to provide for the administration and enforcement of road transport legislation; to make further provision with respect to the use of vehicles on roads and road related areas and related matters; and for other purposes. [**Road Transport (General) Bill**]

Act No. 12 2005 – An Act to apply the Water Efficiency Labelling and Standards Act 2005 of the Commonwealth as a law of this State; and for other purposes. [**Water Efficiency Labelling and Standards (New South Wales) Bill**]

The object of this Regulation is to enable registered training organisations other than the TAFE Commission to provide commercial and private inquiry agency qualifications.

This Regulation is made under the *Commercial Agents and Private Inquiry Agents Act 1963*, including section 10 (6) (a) (iii) and section 44 (the general regulation-making power).

Omit clause 10 (1) (b). Insert instead:

- (b) the prescribed qualification is a certificate (or other similar qualification) in commercial agency practice issued by the TAFE Commission or a registered training organisation approved by the Commissioner of Police.

[2] Clause 10 (2) (b)

Omit the paragraph. Insert instead:

- (b) the prescribed qualification is a certificate (or other similar qualification) in private agency practice issued by the TAFE Commission or a registered training organisation approved by the Commissioner of Police.

[3] Clause 10 (3)

Insert after clause 10 (2):

- (3) In this clause, *registered training organisation* means an education or training provider registered under the *Vocational Education and Training Accreditation Act 1990*.

The object of this Regulation is to amend the *Fair Trading (General) Regulation 2002* to ensure that provisions relating to the product safety standard for certain products and materials in children's toys are complementary with the corresponding Commonwealth provisions.

This Regulation is made under the *Fair Trading Act 1987*, including sections 26 and 92 (the general regulation-making power).

The *Fair Trading (General) Regulation 2002* is amended by omitting clause 32A (e).

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Freedom of Information Act 1989*.

Explanatory note

The object of this Regulation is to repeal and remake, without substantial change, the provisions of the *Freedom of Information Regulation 2000*.

This Regulation, like the repealed Regulation, deals with the following matters:

- (a) the declaration of specified offices as principal offices of specified public authorities,
- (b) the declaration of specified Ministers as responsible Ministers for specified public authorities,
- (c) the declaration of specified bodies as public authorities for the purposes of the Act,
- (d) the declaration of specified offices as public offices for the purposes of the Act,
- (e) the declaration of specified agencies as agencies whose documents are taken to be the documents of another agency if the documents were created by the other agency,
- (f) the annual reports to be prepared by agencies.

This Regulation also contains a provision that allows the usual 21 day period for dealing with FOI applications to be extended by 14 days if the application necessitates locating and retrieving documents from a school during a school holiday period.

This Regulation is made under the *Freedom of Information Act 1989*, including sections 6, 7, 8, 11, 59B and 69 (the general regulation-making power).

This Regulation relates to matters of a machinery nature and matters not likely to impose an appreciable burden, cost or disadvantage on any sector of the public.

This Regulation is made in connection with the staged repeal of statutory rules under Part 3 of the *Subordinate Legislation Act 1989*.

Freedom of Information Regulation 2005

Clause 1

Freedom of Information Regulation 2005

under the

Freedom of Information Act 1989

1 Name of Regulation

This Regulation is the *Freedom of Information Regulation 2005*.

2 Commencement

This Regulation commences on 22 April 2005.

3 Definition

In this Regulation:

the Act means the *Freedom of Information Act 1989*.

4 Principal offices

For the purposes of paragraph (b) of the definition of *principal officer* in section 6 (1) of the Act, it is declared that, for each public authority referred to in Schedule 1, the office specified in that Schedule in respect of that authority is the principal office.

5 Responsible Ministers

- (1) For the purposes of paragraph (c) of the definition of *responsible Minister* in section 6 (1) of the Act, it is declared that, for each public authority referred to in Part 1 of Schedule 2, the Minister specified in that Part in respect of that authority is the responsible Minister.
- (2) For the purposes of paragraph (h) of the definition of *responsible Minister* in section 6 (1) of the Act, it is declared that, for each public office referred to in Part 2 of Schedule 2, the Minister specified in that Part in respect of that office is the responsible Minister.

6 Public authorities

- (1) For the purposes of section 7 (1) (b) of the Act, each body referred to in Part 1 of Schedule 3 is declared to be a public authority.
- (2) For the purposes of section 7 (1) (c) of the Act, each body referred to in Part 2 of Schedule 3 is declared to be a public authority.

Clause 7 Freedom of Information Regulation 2005

- (3) For the purposes of section 7 (3) of the Act, each body referred to in Part 3 of Schedule 3 is declared not to be a separate public authority but is taken to be included in the agency specified in that Part in respect of that body.

7 Public offices

- (1) For the purposes of section 8 (1) (b) of the Act, each office referred to in Part 1 of Schedule 4 is declared to be a public office.
- (2) For the purposes of section 8 (2) of the Act, each office referred to in Part 2 of Schedule 4 is declared not to be a separate public office but is taken to be included in the agency specified in that Part in respect of that office.

8 Documents in certain agencies

For the purposes of section 11 (1) (e) of the Act, each agency referred to in Schedule 5 is a prescribed agency.

9 Extension of 21 day period for dealing with certain FOI applications

The necessity to locate and retrieve documents from a school where the 21 day period for dealing with the application occurs, wholly or partly, during a school holiday period is prescribed as a special circumstance for the purposes of section 59B (3) (c) of the Act.

10 Reports to Parliament

- (1) An annual report prepared by an agency:
- (a) must include the required information for the year concerned, and
 - (b) must also include an assessment of that information.
- (2) The required information must be set out in the form required by the relevant section of Appendix B to the FOI Manual.
- (3) An assessment of the required information for a particular year must include:
- (a) a comparison of that information with the required information for the previous year, and
 - (b) an assessment of the impact during that year on the agency's activities of the FOI requirements, and
 - (c) particulars of any major issues that have arisen during that year in connection with the agency's compliance with the FOI requirements, and

-
- (d) particulars of the circumstances in which there have been any investigations under the Act by the Ombudsman or any applications for review under the Act to the Administrative Decisions Tribunal or the Supreme Court, and
- (e) particulars of the outcomes of any such investigations and applications for review.
- (4) In this clause:
- FOI Manual*** means the document entitled *FOI Procedure Manual*, published from time to time by the Premier's Department (or jointly with the Ombudsman's Office). Copies of the Manual are available at the Premier's Department (and also at the Ombudsman's Office if published jointly) and the Manual is also accessible on the Premier's Department's Internet Web site.
- FOI requirements***, in relation to an agency, means the requirements imposed on the agency by the Act.
- required information*** means the information required by Appendix B to the FOI Manual.

11 Repeal and Savings

- (1) The *Freedom of Information Regulation 2000* is repealed.
- (2) Any act, matter or thing that, immediately before the repeal of the *Freedom of Information Regulation 2000*, had effect under that Regulation, continues to have effect under this Regulation.

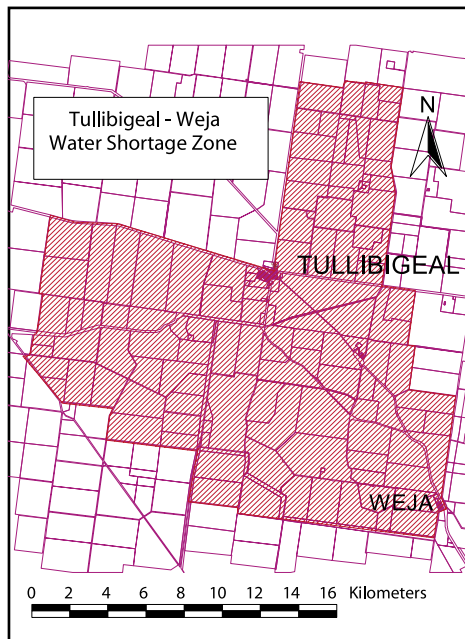

3. Nature of harm that the contaminants may cause:

The EPA has considered the matters in s.9 of the Act and for the following reasons has determined that the site is contaminated in such a way as to present a significant risk of harm to human health and the environment:

- Soil at the site is contaminated with significant concentrations of volatile and reasonably soluble contaminants (benzene and 1,2-DCA), semi-volatile and reasonably insoluble compounds (HCB and PAHs) and DDT (and its degradation products). Some of these contaminants together with TCE (a volatile and reasonably soluble contaminant) and chlorobenzene (possibly as a degradation product of HCB) are also present in groundwater.

- The risk of harm arises not so much from direct exposure of workers to the contaminated soil (as there are protocols in place to protect employees working with soil), but rather from the interaction and mobilisation of these contaminants, resulting in the potential for off-site migration of contaminants via groundwater into adjacent industrial sites and nearby waterways.
- Some of the compounds which have the potential to be mobilised off-site include probable and possible human carcinogens.
- It is reasonable to suggest that the concentration of TPHs in soil and groundwater at the site indicate the presence of separate phase contamination and a high likelihood of off-site migration.

4. Further action under the Act

The making of this declaration does not prevent the carrying out of a voluntary remediation of the site and any person may submit a voluntary remediation proposal for the site to the EPA. If the proposal satisfies the requirements of s.26 of the Act, the EPA may agree not to issue a remediation order to the person or persons bringing the proposal.

SUBORDINATE LEGISLATION ACT 1989

Staged Repeal of Statutory Rules

BY operation of the provisions of the Subordinate Legislation Act 1989, the following three regulations, administered by the Department of Juvenile Justice, are due for automatic repeal on 1 September 2005:

1. Children (Community Service Orders) Regulation 2000,
2. Children (Detention Centres) Regulation 2000,
3. Children (Interstate Transfer of Offenders) Regulation 2000.

In accordance with section 5 of the Subordinate Legislation Act 1989, notice is hereby given of the intention to make replacement regulations.

Explanatory notes

1. Children (Community Service Orders) Act 2005

The object of this proposed Regulation is to repeal and replace, with no major changes in substance, the Children (Community Service Orders) Regulation 2000. The Regulation deals with the following matters:

- (a) conditions relating to the performance of community service work, including maximum hours of work to be performed each day, the taking of tea breaks and meal breaks and requirements to be observed by offenders performing such work (Part 2),
- (b) miscellaneous matters, including service of documents and the appointment of assigned officers and supervisors for the administration of children community service orders (Part 3).

2. Children (Detention Centres) Regulation 2005

The object of this proposed Regulation is to repeal and replace, with no major changes in substance, the Children (Detention Centres) Regulation 2000.

The Regulation is required to carry out and give effect to the Children (Detention Centres) Act 1987. The proposed statutory rule provides for the general administration of detention centres, including:

- (a) the persons who may visit detainees;
- (b) correspondence with detainees;
- (c) the making of complaints;
- (d) the granting of day leave or overnight leave;
- (e) the maintenance of order in detention centres;
- (f) the conduct to be treated as misbehaviour and the procedure for dealing with allegations of misbehaviour; and parole orders.

3. Children (Interstate Transfer of Offenders) Regulation 2005

The object of this Regulation is to repeal and replace, with no changes in substance, the provisions of the Children (Interstate Transfer of Offenders) Regulation 2000. The Regulation declares other States and Territories that have enacted legislation dealing with the interstate transfer of young offenders. This enables the Minister to enter into agreements with those States and Territories for the transfer of young offenders between those State and Territories and New South Wales.
