### Explanatory note

Section 45 of the *Public Finance and Audit Act 1983* enables the Auditor-General, if requested to do so, to inspect and audit the accounts and records of financial transactions relating to statutory bodies to which section 44 of the Act applies.

The object of this Regulation is to amend the *Public Finance and Audit Regulation 2005* to remove the Superannuation Services Company Pty Limited from the list of statutory bodies prescribed under section 44 (1) of the Act.

This Regulation is made under the *Public Finance and Audit Act 1983*, including sections 44 (1) and 64 (the general regulation-making power).

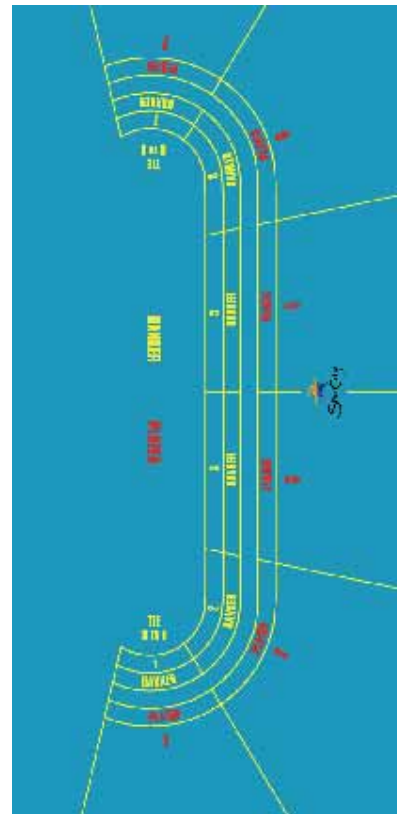

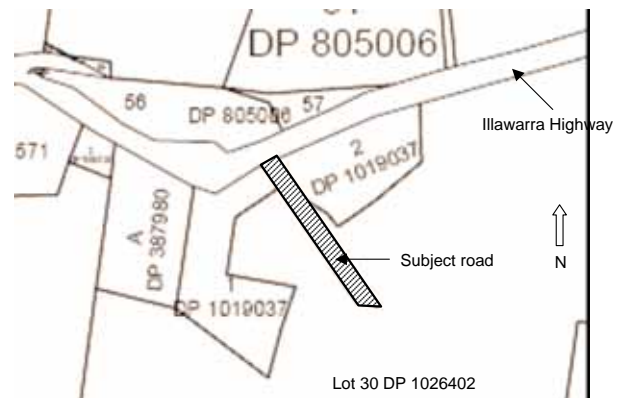
