Institute of Teachers Amendment (Annual Accreditation Fees) Regulation 2008

under the

Institute of Teachers Act 2004

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Institute of Teachers Act 2004*.

Explanatory note

The object of this Regulation is to increase from \$88 to \$92 the annual fees payable under the *Institute of Teachers Act 2004* by:

- (a) new scheme teachers who are accredited (other than at professional accomplishment level or professional leadership level), and
- (b) transition scheme teachers who are accredited at professional competence level.

This Regulation is made under the *Institute of Teachers Act 2004*, including sections 25 (Annual fee) and 52 (the general regulation-making power).

1 Name of Regulation

This Regulation is the *Institute of Teachers Amendment (Annual Accreditation Fees) Regulation 2008*.

2 Amendment of Institute of Teachers Regulation 2005

The *Institute of Teachers Regulation 2005* is amended by omitting from clause 6 (1) (a) and (b) the matter “\$88” wherever occurring and by inserting instead the matter “\$92”.

MENTAL HEALTH ACT 2007

Section 109

I, PROFESSOR DEBORA PICONE AM, Director-General of the NSW Department of Health, pursuant to section 109 of the Mental Health Act 2007 and section 43 of the Interpretation Act 1987, DO HEREBY REPEAL the Order, published in Government Gazette No 170 of 16 December 1994 at page 7504, declaring certain premises of Concord Hospital to be a hospital for the purposes of the Mental Health Act 1990 which was taken to be a declared mental health facility in accordance with clause 5(1) of Schedule 6 of the Mental Health Act 2007, and

Pursuant to section 109 of the Mental Health Act 2007 I DO HEREBY DECLARE the following premises of Concord Hospital to be a mental health facility for the purposes of the Mental Health Act 2007:

MENTAL HEALTH ACT 2007

Section 109

I, PROFESSOR DEBORA Picone AM, Director-General of the NSW Department of Health, in pursuance of the provisions of section 109 of the Mental Health Act 2007 and section 43 of the Interpretation Act 1987, DO HEREBY REPEAL the Order, published in Government Gazette No 75 of 9 June 2006 at pages 4247 and 4248, declaring certain premises of the Long Bay Prison Hospital to be a hospital for the purposes of the Mental Health Act 1990 which was taken to be declared mental health facility in accordance with clause 5(1) of Schedule 6 of the Mental Health Act 2007, and

Pursuant to section 109(1) of the Mental Health Act 2007, I DO HEREBY:

(a) DECLARE the following premises of the current Long Bay Prison Hospital:

Ward B East;
Ward C;
Ward D;
Ward R (being part of the Metropolitan Special Purposes Centre in the Long Bay Correctional Complex known as the MSPC Area 3, 6 Wing;
and
The Mental Health Unit and attached courtyards of the new Long Bay Prison Hospital
to be a mental health facility for the purposes of the Mental Health Act 2007;

(b) DECLARE such facility to be designated as a "mental health inpatient treatment" facility.
