# World Youth Day Amendment (Government Agency Co-operation) Regulation 2008

under the

World Youth Day Act 2006

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *World Youth Day Act 2006*.

#### **Explanatory note**

Section 15A of the *World Youth Day Act 2006* (Minister may direct government agencies to co-operate) provides that the Minister administering the *World Youth Day Act 2006* (currently the Deputy Premier) may direct a prescribed government agency to comply with a request, direction or decision of the World Youth Day Co-ordination Authority made or given under that Act.

The object of this Regulation is to prescribe the Council of the City of Sydney as a government agency for the purposes of that section.

This Regulation is made under the *World Youth Day Act 2006*, including sections 15A and 58 (the general regulation-making power).

#### PLANT DISEASES ACT 1924

OR96: Order under Section 13A

I, IAN MACDONALD MLC Minister for Primary Industries pursuant to section 13A of the *Plant Diseases Act 1924*, believe that this Order is necessary in order to avoid an adverse effect on trade in fruit, and by this Order I hereby authorise an inspector to enter all land or premises with a frontage to or access from a street which is within an urban 60 km an hour or less speed limit zone in the towns specified in Schedule 1 to carry out the fruit fly treatment specified in Schedule 2, to control the pest Queensland Fruit Fly, and

# SCHEDULE 2 Fruit Fly Treatment

In this Order:

fruit fly treatment means any one or a combination of the following:

- (a) Fruit fly bait spraying: A registered insecticide plus protein autolysate extract is applied to plant foliage as a spot spray from a backpack spray unit. Note: The registered insecticide is Hy-Mal® that has the active constituent "maldison". The protein autolysate extract is Pinnacle® or Natflav 500®. This pesticide is to be used in accordance with the Hy-Mal® label directions for "Fruit Fly Lure Eradication only".
- (b) Cover spray of fruit trees: A registered insecticide spray is applied to the plant foliage and fruit on fruit trees as a mist spray from a backpack spray unit or by a powered spray unit. Note: The registered insecticide is Lebaycid® that has the active constituent "fenthion".
- (c) The release of sterile Queensland Fruit Fly.

Note: This Order remains in force for 6 months from the date it is made.
