SPECIAL SUPPLEMENT

FAIR TRADING ACT 1987

PROHIBITION ORDER

SECTION 31(1)

I, LINDA BURNEY, Minister for Fair Trading,

- noting that a prohibition of the supply of goods of the kind specified in Part 1 of Schedule 1 ("the Goods") is in force under a law of the Commonwealth because the Goods are dangerous, particulars of which are specified in Schedule 2,

HEREBY:

- pursuant to section 31(1)(c) of the Fair Trading Act 1987, prohibit, from the date this Order is published in the Gazette, the supply of the Goods, except in accordance with Part 2 of Schedule 1.

SCHEDULE 1

Part 1

Balls manufactured from fire resistant material, designed to be doused in flammable liquid and ignited, and intended to be used for the purpose of amusement by kicking or throwing, including but not limited to goods supplied as "Fire Footbag".

Part 2

The Goods may be supplied for use by professional entertainers or for theatrical use only where the person acquiring the Goods is able to demonstrate such qualifications or intended use.

SCHEDULE 2

The Declaration of Unsafe Goods under section 65C(5) of the Trade Practices Act 1974 (Cth) dated 16 June 2008 relating to balls manufactured from fire resistant material, designed to be doused in flammable liquid and ignited, and intended to be used for the purpose of amusement by kicking or throwing, including but not limited to goods supplied as "Fire Footbag", except where such goods are supplied for use by professional entertainers or for theatrical use and where the purchaser is able to demonstrate such qualifications or intended use, published in the Commonwealth of Australia Gazette, No. S120, Monday 16 June 2008 (Consumer Protection Notice No. 7 of 2008).
