### ROAD TRANSPORT (GENERAL) ACT 2005

Ministerial (Heavy Vehicle Driver Fatigue Offences Transitional Arrangements) Order 2009

**1. Citation**

This Order is the Ministerial (Heavy Vehicle Driver Fatigue Offences Transitional Arrangements) Order 2009.

**2. Commencement**

This Order takes effect on the day that it is published in the *New South Wales Government Gazette*.

**3. Effect**

This Order remains in effect until it is revoked.

**4. Application**

This Order applies to a person who is liable for an offence under Clause 64, 65, 66, 68, 70, 71, 72 or 117(9) of the Road Transport (General) Regulation 2005, where the offence occurred before 1 January 2010.

**5. Declaration**

Clause 60(2) of the Road Transport (Driver Licensing) Regulation 2008 is declared not to apply in respect of a person in the circumstances specified in Clause 4 of this Order but only to the extent that the provision relates to an offence under Clause 64, 65, 66, 68, 70, 71, 72 or 117(9) of the Road Transport (General) Regulation 2005.
