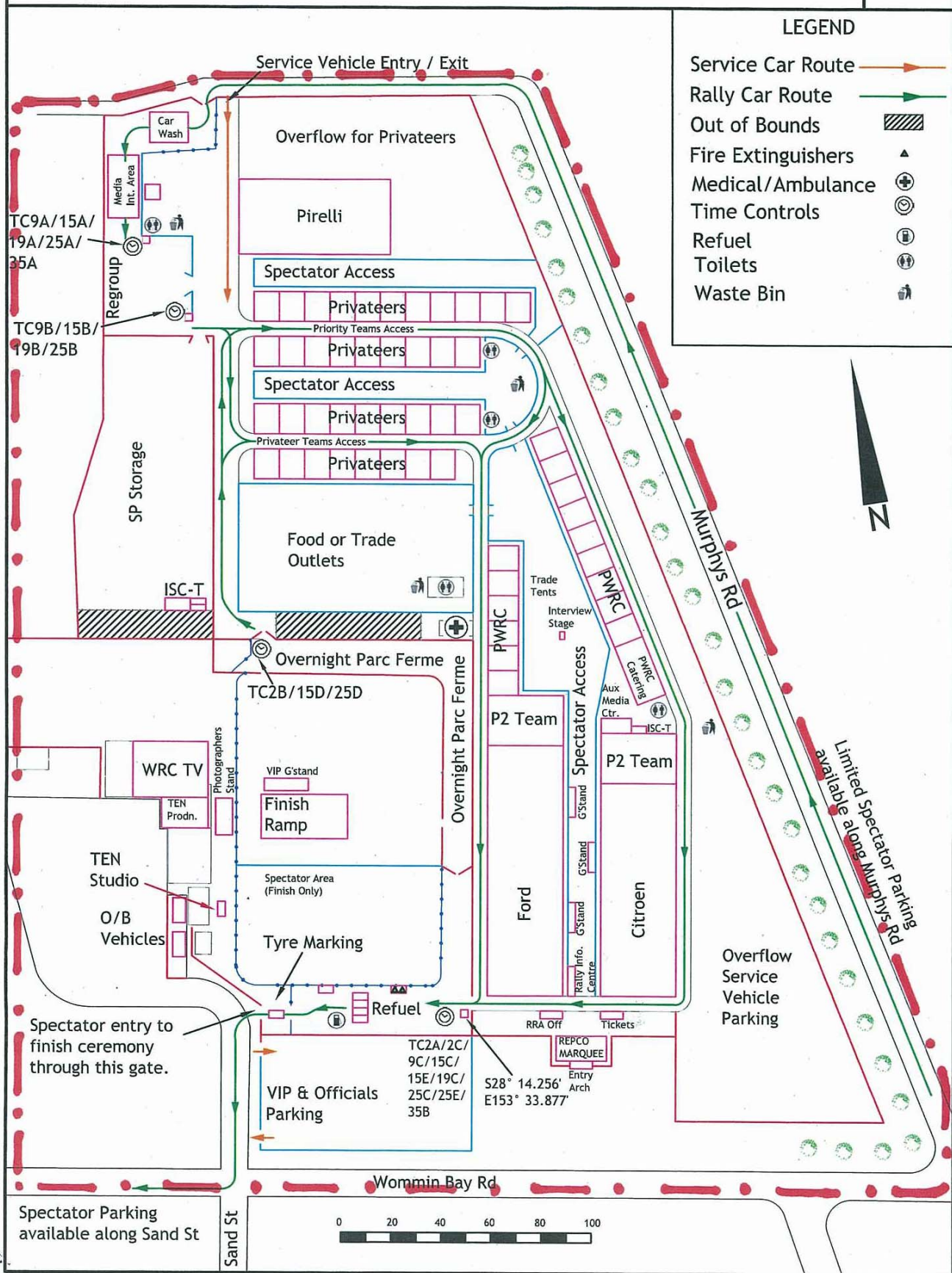

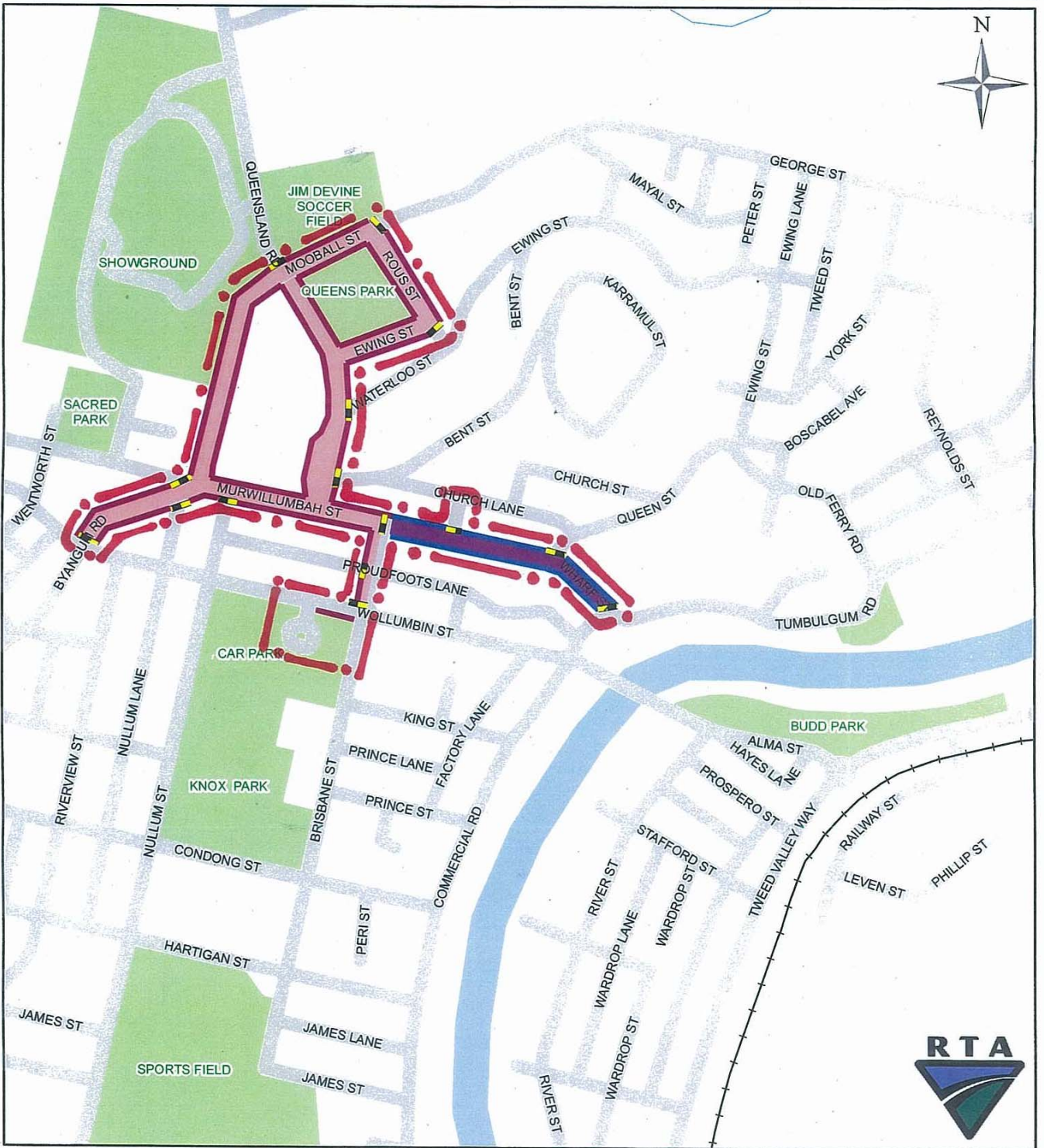
RALLY HEADQUARTERS MAP

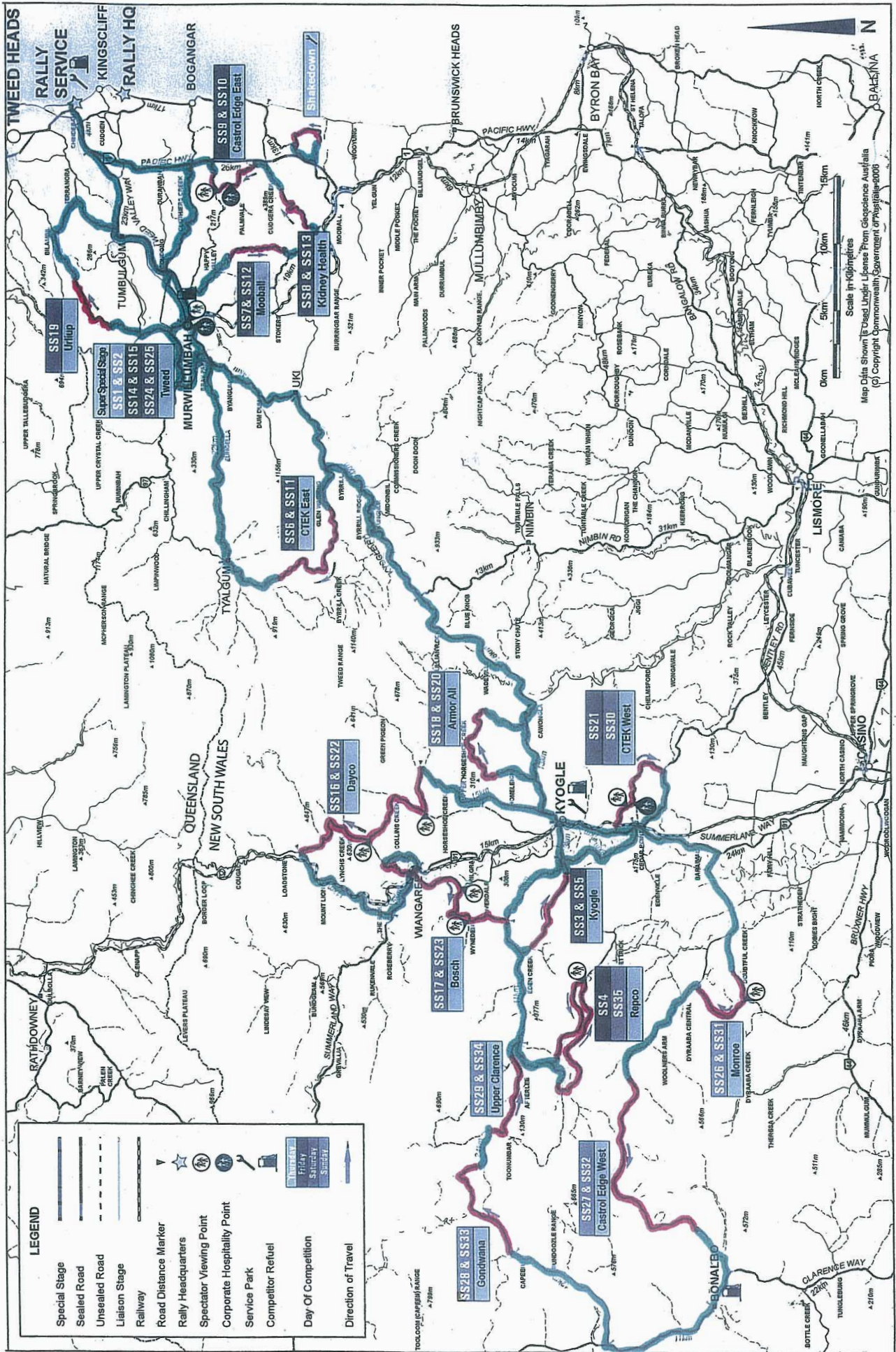

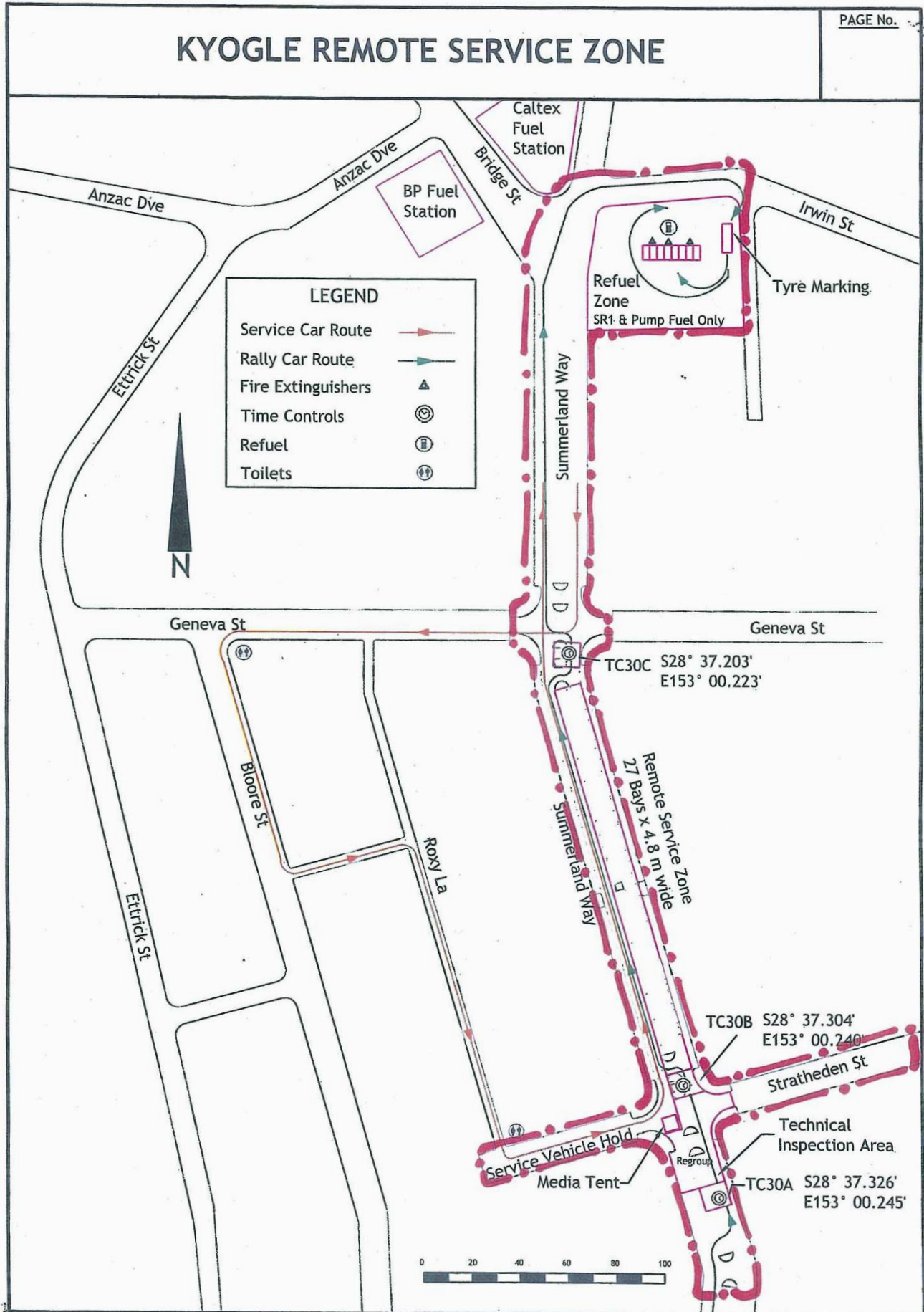

Order to authorise a person to conduct a rally event under the Motor Sports (World Rally Championship) Act 2009

I, Ian Macdonald, Minister for State Development, pursuant to section 5 of the Motor Racing (World Rally Championship) Act 2009 (the Act) do by this Order authorise Rally Australia Pty Limited (ABN 41 130 862 798) (the rally promoter) to conduct a rally event, being the Rally Australia Pty Limited event (the rally event) subject to and in accordance with the Act.

MOTOR SPORTS (WORLD RALLY CHAMPIONSHIP) ACT 2009

Order amending an Order to authorise a person to conduct a rally event under the Motor Sports (World Rally Championship) Act 2009

I, Ian Macdonald, Minister for State Development, pursuant to sections 5 and 6 of the Motor Racing (World Rally Championship) Act 2009 (“the Act”) and section 43 of the Interpretation Act 1987, do by this Order amend my previous Order (“the previous Order”) made pursuant to section 5 of the Act and dated 21 August 2009 authorising Rally Australia Pty Limited (ABN 41 130 862 798) (the rally promoter) to conduct a rally event, by inserting into the previous Order, after the words “in accordance with the Act”, the following words:

“and any conditions imposed by written notice to the rally promoter under section 5 of the Act.

I also authorise the rally promoter to carry out and dismantle temporary works in relation to which conditions have been issued by me under section 5 (2) of the Act and which are associated with the rally event within the declared rally area and the declared rally period, subject to and in accordance with the Act and any conditions imposed by written notice to the rally promoter under section 5 of the Act.”
