Notice of Final Determination

under the

Threatened Species Conservation Act 1995

The Scientific Committee established under the *Threatened Species Conservation Act 1995* has made final determinations to insert the following ecological communities as endangered ecological communities under that Act and, accordingly, Schedule 1 to that Act is amended by inserting in Part 3 in alphabetical order:

Central Hunter Grey Box—Ironbark Woodland in the New South Wales North Coast and Sydney Basin Bioregions (as described in the final determination of the Scientific Committee to list the ecological community)

Central Hunter Ironbark—Spotted Gum—Grey Box Forest in the New South Wales North Coast and Sydney Basin Bioregions (as described in the final determination of the Scientific Committee to list the ecological community)

FINAL DETERMINATION

THE Scientific Committee, established by the Threatened Species Conservation Act has made a Final Determination to list the Central Hunter Grey Box – Ironbark Woodland in the NSW North Coast and Sydney Basin Bioregions as an ENDANGERED ECOLOGICAL COMMUNITY in Part 3 of Schedule 1 of the Act. Listing of Endangered Ecological Communities is provided for by Part 2 of the Act.

The Scientific Committee has found that:

1. Central Hunter Grey Box – Ironbark Woodland in the NSW North Coast and Sydney Basin Bioregions is the name given to the ecological community that generally occurs on Permian sediments in the Hunter Valley and is characterised by the assemblage of species in paragraph 2. The community typically forms a woodland to open forest on slopes and undulating hills.
2. Central Hunter Grey Box – Ironbark Woodland is characterised by the following assemblage of species:

3. The total species list of the community is considerably larger than that given above, with many species present in only one or two sites or in low abundance. The species composition of a site will be influenced by the size of the site, recent rainfall, drought condition and by its disturbance (including fire and grazing) history. The number of species, and the above ground relative abundance of species will change with time since disturbance, and may also change in response to changes in disturbance regime (including changes in fire frequency). At any one time, above ground individuals of some species may be absent, but the species may be represented below ground in the soil seed banks or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers. The list of species given above is of vascular plant species, the community also includes micro-organisms, fungi, cryptogamic plants and a diverse fauna, both vertebrate and invertebrate. These components of the community are poorly documented.
4. Central Hunter Grey Box – Ironbark Woodland typically forms a woodland dominated by *Eucalyptus crebra* (Narrow-leaved Ironbark), *Brachychiton populneus* subsp. *populneus* (Kurrajong) and *Eucalyptus moluccana* (Grey Box). Other tree species may be present and occasionally dominate or co-dominate, and include *Angophora floribunda* (Rough-barked Apple) and *Callitris endlicheri* (Black Cypress Pine). A shrub layer may also be present and common shrub species include *Notelaea microcarpa* var. *microcarpa* (Native Olive), *Breynia oblongifolia* (Coffee Bush), *Bursaria spinosa* subsp. *spinosa* (Native Blackthorn), *Cassinia quinquefaria* (Cough Bush) and *Dodonaea viscosa* (Hop Bush). Subshrubs may also be common and include *Solanum cinereum* (Narrawa Burr), and *Phyllanthus virgatus* (Spurge) and *Maireana microphylla* (Eastern Cotton Bush) (Peake 2006). Ground cover can be moderately dense to dense, and consist of numerous forbs and grass species, and a small number of ferns, sedges and twiners. The more common species include *Cymbopogon refractus* (Barbed Wire Grass), *Aristida ramosa* (Three-awned Wire Grass), *Dichondra repens* (Kidney Weed), *Cheilanthes sieberi* subsp. *sieberi* (Poison Rock Fern), *Chloris ventricosa* (Tall Chloris), *Austrostipa scabra* (Corkscrew Grass), *Desmodium varians* (Variable Tick-trefoil), *Microlaena stipoides* var. *stipoides* (Weeping Rice Grass), *Eragrostis leptostachya* (Paddock Lovegrass), *Sporobolus creber* (Slender Rat's Tail Grass), *Calotis lappulacea* (Yellow Burr Daisy), *Lomandra multiflora* subsp. *multiflora* (Mat Rush), *Brunoniella australis* (Blue Trumpet), *Eremophila debilis* (Winter Apple), *Chrysocephalum apiculatum* (Common Everlasting), *Cyperus gracilis*, *Einadia nutans* (Climbing Saltbush), *Ajuga australis* (Austral Bugal), *Vittadinia cuneata* (Fuzzweed), *Bothriochloa decipiens* (Red Grass), and *Glycine tabacina* (Variable Glycine) (Peake 2006).
5. Central Hunter Grey Box – Ironbark Woodland has been described by Peake (2006) as Central Hunter Box – Ironbark Woodland (Map Unit 10). It has also been described by Thomas (1998) as part of *Eucalyptus crebra* – *Eucalyptus moluccana* – *Eucalyptus glauca/tereticornis* woodland (Map Unit 4.4) and by Fallding *et al.* (1999) as Ironbark Forest on Alluvium (Map Unit Q2). It shares some characteristics with, but is not part of a community described by Peake (2006) as Central Hunter Spotted Gum – Ironbark – Grey Box Forest and by Bell (2005) as Goulburn Valley Ironbark Woodland. This community also shares some characteristics with, but is not part of the Endangered Ecological

Community 'Central Hunter Ironbark – Spotted Gum – Grey Box Forest in the NSW North Coast and Sydney Basin Bioregions (Scientific Committee 2010).

6. Central Hunter Grey Box – Ironbark Woodland has been recorded from the local government areas of Cessnock, Singleton and Muswellbrook but may occur elsewhere within the Sydney Basin Bioregion (sensu Thackway and Creswell 1995).
7. Central Hunter Grey Box – Ironbark Woodland is known to contain an Endangered Population of *Cymbidium canaliculatum*, the Vulnerable species *Diuris tricolor* and *Eucalyptus glaucina*, and the Endangered species *Pterostylis gibbosa* listed under the Threatened Species Conservation Act 1995.
8. Central Hunter Grey Box – Ironbark Woodland occupies an area of less than 2000 km² based on 2 x 2 km grid cells, the scale of assessment recommended for species by IUCN (2008).
9. Land clearing, primarily for agriculture, has led to a large reduction in geographic distribution of the community. The mapped area of the community is approximately 46,920 ha which is estimated to be 32% of the pre-European distribution (Peake 2006). Mapped occurrences of the community include 27 remnants greater than 100 ha and more than 1000 small remnants less than 10 ha indicating a high level of fragmentation (Peake 2006).
10. Central Hunter Grey Box – Ironbark Woodland has been subject to intensive livestock grazing and clearing which has made it vulnerable to weed invasions. The community has been invaded by a range of woody and herbaceous weed species including *Olea europaea* subsp. *cuspidata* (African Olive), *Lycium ferocissimum* (African Boxthorn), and *Hyparrhenia hirta* (Coolatai Grass) (Peake 2006).
11. Threats to Central Hunter Grey Box – Ironbark Woodland include, clearing and weed invasion. 'Clearing of native vegetation' and 'Invasion of native plant communities by exotic perennial grasses', are listed as Key Threatening Processes under the Threatened Species Conservation Act 1995. Collectively, the effects of these threats indicate a large reduction of the ecological function of the community. Continual clearing related to open-cut coal mining and rural sub-division are potential threats to this community.
12. Central Hunter Grey Box – Ironbark Woodland in the NSW North Coast and Sydney Basin Bioregions is not eligible to be listed as a Critically Endangered Ecological Community
13. Central Hunter Grey Box – Ironbark Woodland in the NSW North Coast and Sydney Basin Bioregions is eligible to be listed as an Endangered Ecological Community as, in the opinion of the Scientific Committee, it is facing a very high risk of extinction in New South Wales in near future, as determined in accordance with the following criteria as prescribed by the Threatened Species Conservation Regulation 2002:

Clause 25

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

- (b) a large reduction in geographic distribution.

Clause 27

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

- (b) a large reduction in ecological function,
as indicated by any of the following:
 - (g) invasion and establishment of exotic species
 - (i) fragmentation of habitat.

3. The total species list of the community is considerably larger than that given above, with many species present in only one or two sites or in low abundance. The species composition of a site will be influenced by the size of the site, recent rainfall, drought condition and by its disturbance (including fire and grazing) history. The number of species, and the above ground relative abundance of species will change with time since disturbance, and may also change in response to changes in disturbance regime (including changes in fire frequency). At any one time, above ground individuals of some species may be absent, but the species may be represented below ground in the soil seed banks or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers. The list of species given above is of vascular plant species, the community also includes micro-organisms, fungi, cryptogamic plants and a diverse fauna, both vertebrate and invertebrate. These components of the community are poorly documented.
4. Central Hunter Ironbark – Spotted Gum – Grey Box Forest typically forms an open forest to woodland dominated by *Eucalyptus crebra* (Narrow-leaved Ironbark), *Corymbia maculata* (Spotted Gum) and *Eucalyptus moluccana* (Grey Box). Other tree species may be present and occasionally dominate or co-dominate, and include *Eucalyptus fibrosa* (Broad-leaved Ironbark) and *Eucalyptus tereticornis* (Forest Red Gum). A sparse layer of small trees may be present in some areas, typically including *Allocasuarina luehmannii* (Bulloak) or *Acacia parvipinnula* (Silver Streamed Wattle). The shrub layer is typically sparse or absent in some cases, through to moderately dense. Common shrub species include *Daviesia ulicifolia* subsp. *ulicifolia* (Gorse Bitter Pea), *Pultenaea spinosa* (Grey Bush Pea), *Breynia oblongifolia* (Coffee Bush), *Hakea sericea* (Bushy Needlebush), and *Bursaria spinosa* subsp. *spinosa* (Native Blackthorn) (Peake 2006). Ground cover can be sparse to moderately dense, and consists of numerous forbs, a few grass species, and a limited number of ferns, sedges or other herbs. Common species include *Cheilanthes sieberi* subsp. *sieberi* (Poison Rock Fern), *Cymbopogon refractus* (Barbed Wire Grass), *Pratia purpurascens* (Whiteroot), *Lomandra multiflora* subsp. *multiflora* (Many-flowered Mat-rush), *Pomax umbellata* (Pomax), *Glycine tabacina* (Variable Glycine), *Dianella revoluta* (Blue Flax Lily), *Laxmannia gracilis* (Slender Wire Lily), *Microlaena stipoides* var. *stipoides* (Weeping Rice Grass), *Vernonia cinerea* var. *cinerea*, *Lissanthe strigosa* (Peach Heath), *Brunoniella australis* (Blue Trumpet), *Desmodium varians* (Variable Tick-trefoil), *Dichondra repens* (Kidney Weed), *Eremophila debilis* (Winter Apple),

Calotis cuneifolia (Purple burr-daisy), *Hypercium gramineum* (Small St. John's Wort), *Chrysocephalum apiculatum* (Common Everlasting), *Opercularia diphylla* (Stinkweed), *Paspalidium distans* (Tufted Hedgehog Grass) *Themeda australis* (Kangaroo Grass), *Stackhousia viminea* (Slender Stackhousia) and *Wahlenbergia communis* (Tufted Bluebell) (Peake 2006).

5. Central Hunter Ironbark – Spotted Gum – Grey Box Forest has been described by Peake (2006) as Central Hunter Ironbark – Spotted Gum – Grey Box Forest (Map Unit 27) and as Map Unit 18 (NSW NPWS 2000; DECC 2008). It includes a part of a unit described by Thomas (1998) as *Eucalyptus crebra* – *Eucalyptus moluccana* – *Eucalyptus glaucina/tereticornis* woodland. It shares some characteristics with, but is not part of a community described by Bell (2005) as Narrabeen Residual Spotted Gum Forest from a small area near Bulga. It shares some characteristics with, but is not part of a community described by Peake (2006) as Central Hunter Grey Box – Ironbark Woodland, and also shares some characteristics with but is not part of the Endangered Ecological Community 'Central Hunter Grey Box – Ironbark Woodland in the NSW North Coast and Sydney Basin Bioregions (Scientific Committee 2010).
6. Central Hunter Ironbark – Spotted Gum – Grey Box Forest has been recorded from the local government areas of Cessnock, Singleton and Muswellbrook but may occur elsewhere within the NSW North Coast and Sydney Basin Bioregions (sensu Thackway and Creswell 1995).
7. Central Hunter Ironbark-Spotted Gum-Grey Box Forest is known to contain an Endangered Population of *Cymbidium canaliculatum*, the Vulnerable species *Diuris tricolor* and *Eucalyptus glaucina*, the Endangered species *Lepidium hyssoifolium* and the Critically Endangered species *Persoonia pauciflora* listed under the Threatened Species Conservation Act 1995.
8. Central Hunter Ironbark – Spotted Gum – Grey Box Forest occupies an area of less than 2000 km² based on 2 x 2 km grid cells, the scale of assessment recommended for species by IUCN (2008). It has been mapped as being recorded in Bellfield National Park and in the Singleton Military Area.
9. Land clearing, primarily for agriculture has lead to a large reduction in geographic distribution of the community. The mapped area of the community is approximately 18,300 ha which is estimated to be 29% of the pre-European distribution (Peake 2006). Mapped occurrences of the community include 34 remnants greater than 100 ha and more than 1000 small remnants less than 10 ha indicating a high level of fragmentation (Peake 2006).
10. Central Hunter Ironbark-Spotted Gum-Grey Box Forest has been subject to intensive livestock grazing and clearing which has made it vulnerable to weed invasions. The community has been invaded by a range of woody and herbaceous weed species including *Olea europaea* subsp. *cuspidata* (African Olive), *Lantana camara* (Lantana), *Hyparrhenia hirta* (Coolatai Grass), and *Sporobolus africanus* (Giant Parramatta Grass) (Peake 2006). Lantana (*Lantana camara*) has been demonstrated to increase following disturbances associated with fire or grazing (Gentle and Duggin 1997a). Lantana (*Lantana camara*) poses a threat through structural alteration, invasion and allelopathic suppression of tree seedlings (Gentle and Duggin 1997b).
11. Threats to Central Hunter Ironbark – Spotted Gum – Grey Box Forest include clearing and weed invasion. 'Clearing of native vegetation', 'Invasion, establishment and spread of Lantana (*Lantana camara* L. sens. lat.)', and 'Invasion of native plant communities by exotic perennial grasses', are listed as Key Threatening Processes under the Threatened Species Conservation Act 1995. Collectively, the effects of these threats indicate a large reduction of the ecological function of the community. Continual clearing related to open-cut coal mining and rural sub-division pose threats to this community.
12. Central Hunter Ironbark – Spotted Gum – Grey Box Forest in the NSW North Coast and Sydney Basin Bioregions is not eligible to be listed as a Critically Endangered Ecological Community.
13. Central Hunter Ironbark – Spotted Gum – Grey Box Forest in the NSW North Coast and Sydney Basin Bioregions is eligible to be listed as an Endangered Ecological Community as, in the opinion of the Scientific Committee, it is facing a very high risk of extinction in New South Wales in the near future, as determined in accordance with the following criteria as prescribed by the Threatened Species Conservation Regulation 2002:

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

FINAL DETERMINATION

THE Scientific Committee, established by the Threatened Species Conservation Act has made a Final Determination to list the Hunter Valley Foothills Slaty Gum Woodland in the Sydney Basin Bioregion, as a VULNERABLE ECOLOGICAL COMMUNITY in Part 2 of Schedule 2 of the Act. Listing of Vulnerable Ecological Communities is provided for by Part 2 of the Act.

The Scientific Committee has found that:

1. Hunter Valley Foothills Slaty Gum Woodland in the Sydney Basin Bioregion is the name given to the ecological community that generally occurs at the interface of Narrabeen Sandstone and Permian sediments in the Hunter Valley and is characterised by the assemblage of species in paragraph 2. The community typically forms a low to mid-high woodland. All sites are within the Sydney Basin Bioregion.

2. Hunter Valley Foothills Slaty Gum Woodland in the Sydney Basin Bioregion is characterised by the following assemblage of species:

3. The total species list of the community is considerably larger than that given above, with many species present in only one or two sites or in low abundance. The species composition of a site will be influenced by the size of the site, recent rainfall, drought condition and by its disturbance (including fire and grazing) history. The number of species, and the above ground relative abundance of species will change with time since disturbance, and may also change in response to changes in disturbance regime (including changes in fire frequency). At any one time, above ground individuals of some species may be absent, but the species may be represented below ground in the soil seed banks or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers. The list of species given above is of vascular plant species, the community also includes micro-organisms, fungi, cryptogamic plants and a diverse fauna, both vertebrate and invertebrate. These components of the community are poorly documented.
4. Hunter Valley Foothills Slaty Gum Woodland typically forms a woodland or occasionally forest, comprising a sparse to moderately dense tree stratum, occasional low tree stratum, and moderately dense to dense shrub stratum. The tree canopy is typically dominated by *Eucalyptus dawsonii* (Slaty Gum) and/or *Eucalyptus moluccana* (Grey Box). *Acacia salicina* (Cooba) and *Allocasuarina luehmannii* (Buloke) may form a low tree stratum or may be part of the upper-most canopy. Other trees which may be present include *Brachychiton populneus* subsp. *populneus* (Kurrajong), *Callitris endlicheri* (Black Cypress Pine), *Eucalyptus crebra* (Narrow-Leaved Ironbark) and *Eucalyptus punctata* (Grey Gum). The shrub layer may include *Olearia elliptica* (Sticky Daisy Bush), *Acacia cultriformis* (Knife-leaved Wattle), *Canthium odoratum* (Shiny-leaved Canthium), *Notelaea microcarpa* var. *microcarpa* (Native Olive), *Dodonaea viscosa* subsp. *cuneata* (Wedge-leaf Hopbush), *Acacia decora* (Western Golden Wattle), *Bursaria spinosa* subsp. *spinosa* (Native Blackthorn), *Myoporum montanum* (Water Bush) and *Solanum brownii* (Violet Nightshade). The groundcover is typically sparse to very sparse and is relatively species poor. It may include *Dichondra repens* (Kidney Weed), *Lomandra multiflora* subsp. *multiflora* (Many-Flowered Mat-rush), *Aristida ramosa* (Wire Grass), *Brunoniella australis* (Blue Trumpet), *Cymbopogon refractus* (Barbed Wire Grass), *Desmodium brachypodum* (Large Tick-trefoil), *Eremophila debilis* (Winter Apple), *Fimbristylis dichotoma* (Common Fringe-rush) and *Sida corrugata* (Corrugated Sida) (Peake 2006).
5. Hunter Valley Foothills Slaty Gum Woodland typically occurs in colluvial soils on exposed foothills associated with the interface of Triassic Narrabeen sandstone and Permian sediments. Hunter Valley Foothills Slaty Gum Woodland has been described by Peake (2006) as Narrabeen Foothills Slaty Box Woodland (Map Unit 7). It is also included in vegetation types described by Fallding et al. (1999) as Dawson's Box Woodland on Permian Sediments (Map Unit P1), by Bell (1998) as Permian Widden Talus Woodland (Map Unit W23), by Hill (1999) as Slaty Gum Open Forest (Map Unit OF8), and by McRae and Cooper (1985) as Woodland in Sandstone Gullies (Map Unit 4). It shares some characteristics with, but is not part of a community in the Western Blue Mountains called Capertee Slopes Slaty Gum – Grey Gum – Mugga – Callitris Open Forest (DECC 2006), nor is it part of the Narrabeen Grey Box Forests of Wollemi National Park (Bell 2005).
6. Hunter Valley Foothills Slaty Gum Woodland has been recorded from the local government areas of Singleton and Muswellbrook but may occur elsewhere within the Sydney Basin Bioregion (sensu Thackway and Creswell 1995).

7. Hunter Valley Foothills Slaty Gum Woodland in the upper Hunter Valley occupies an area of less than 2000 km² based on 2 x 2 km grid cells, the scale of assessment recommended for species by IUCN (2008). Mapped occurrences of the community include a few remnants greater than 100 ha and many small remnants less than 10 ha indicating a high level of fragmentation (Peake 2006).
8. Hunter Valley Foothills Slaty Gum Woodland is known to contain an Endangered Population of *Acacia pendula* in the Hunter Catchment listed under the Threatened Species Conservation Act 1995.
9. Threats to Hunter Valley Foothills Slaty Gum Woodland include clearing, inappropriate fire regimes, and weed invasion. Clearing for agriculture, expanding hobby farms, and mining has reduced the extent of this community (Peake 2006). Fire frequency has also increased with increased hazard reduction to reduce risk to farms and other community infrastructure in parts of the Hunter Valley (Peake 2006). Lantana (*Lantana camara*) has been demonstrated to increase following disturbances associated with fire or grazing (Gentle and Duggin 1997a). Lantana (*Lantana camara*) poses a threat through structural alteration, invasion and allelopathic suppression of rainforest seedlings (Gentle and Duggin 1997b). African Olive (*Olea europaea* subsp. *cuspidata*) also poses a significant threat through invasion (Peake 2006) as well as exotic perennial grasses (Peake 2006). 'Clearing of native vegetation', 'Invasion, establishment and spread of Lantana (*Lantana camara* L. *sens. lat.*)', 'High frequency fire resulting in the disruption of life cycle processes in plant and animals and loss of vegetation structure and composition', and 'Invasion of native plant communities by exotic perennial grasses', are listed as Key Threatening Processes under the Threatened Species Conservation Act 1995. Collectively, these threats indicate a moderate reduction of the ecological function of the community.
10. Hunter Valley Foothills Slaty Gum Woodland in the Sydney Basin Bioregion is not eligible to be listed as an Endangered or Critically Endangered Ecological Community.
11. Hunter Valley Foothills Slaty Gum Woodland in the Sydney Basin Bioregion is eligible to be listed as an Vulnerable Ecological Community as, in the opinion of the Scientific Committee, it is facing a high risk of extinction in New South Wales in the medium-term future, as determined in accordance with the following criteria as prescribed by the Threatened Species Conservation Regulation 2002:

Clause 26

The ecological community's geographic distribution is estimated or inferred to be:

- (c) moderately restricted,

and the nature of its distribution makes it likely that the action of a threatening process could cause it to decline or degrade in extent or ecological function over a time span appropriate to the life cycle and habitat characteristics of the ecological community's component species.

Section 8 Notification – Fishing Closure

The Clarence River and Lake Wooloweyah

I, PAUL O'CONNOR, Principal Director, Fisheries & Compliance, with the delegated authority of the Minister for Primary Industries and the Director-General of the Department of Industry and Investment pursuant to sections 227 and 228 of the Fisheries Management Act 1994 ("the Act"), and pursuant to s 8 of the Act do by this notification, prohibit the taking of all species of fish, by all endorsement holders in the Estuary Prawn Trawl Fishery, by the methods of fishing specified in Column 1 of the Schedule to this notification, from the waters described opposite in Column 2 of that Schedule.

Otter trawl net (prawns)	<i>Clarence River</i> All waters from the confluence of the Clarence River and the South Pacific Ocean (i.e. the easternmost extremity of the breakwalls) upstream to the vehicular ferry at Ulmarra and including the waters of Lake Wooloweyah and all creeks, rivers, lakes, lagoons and tributaries flowing into or from Lake Wooloweyah.

In this fishing closure, Estuary Prawn Trawl Fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

The provisions of this fishing closure in respect of endorsement holders in the Estuary Prawn Trawl fishery have effect despite any provisions in the Fisheries Management (Estuary Prawn Trawl Share Management Plan) Regulation 2006.

This fishing closure is effective immediately and remains in force until 22 February 2010 unless sooner amended or revoked.

PROCLAMATION P208

PROCLAMATION to regulate the importation, introduction and bringing into specified parts of New South Wales of certain fruit originating from or which has moved through other specified parts of New South Wales on account of an outbreak of Queensland fruit fly at Mildura, Victoria.

Her Excellency Professor MARIE BASHIR, AC, CVO,
Governor

I, Professor MARIE BASHIR, AC, CVO, Governor of the State of New South Wales, being of the opinion that the importation, introduction or bringing of Host Fruit into specified portions of New South Wales is likely to introduce

the pest Queensland fruit fly (*Bactrocera tryoni*) into New South Wales, with the advice of the Executive Council and pursuant to section 4 (1) of the Plant Diseases Act 1924 ("the Act"), do by this Proclamation regulate the importation, introduction or bringing of Host Fruit into specified portions of New South Wales as follows:

1. Host Fruit that originates from or has moved through the:
 - (a) Outbreak Area must not be imported, introduced or brought into the Suspension Area; and
 - (b) Outbreak Area or the Suspension Area must not be imported, introduced or brought into the Outer Area.
2. Paragraph 1 does not apply if:
 - (a) in the case of Host Fruit originating in the Outbreak Area or the Suspension Area and moving to the Outer Area, the Host Fruit:
 - (i) remains under secure conditions from postharvest to the time of dispatch and transport, except when impractical during packing and grading activities; and
 - (ii) is treated in the manner specified in Schedule 5 prior to moving out of the Outbreak Area or the Suspension Area; and
 - (iii) if destined for a packing facility in the Outer Area, is kept segregated throughout the packing process and labelled to ensure that it is not mixed with any untreated Host Fruit which has originated from within the Outer Area; and
 - (iv) is accompanied by a Plant Health Certificate or a Plant Health Assurance Certificate specifying the origin of the Host Fruit and certifying that paragraphs 2 (a) (i), (ii) and (iii) have been satisfied; and
 - (b) in the case of Host Fruit originating in the Outbreak Area or the Suspension Area and moving to a facility in the Outer Area for processing (including grapes for wine making), the Host Fruit:
 - (i) remains under secure conditions from postharvest to the time of dispatch and transport, except when impractical during packing and grading activities; and
 - (ii) is transported and processed in the manner specified in Schedule 6; and
 - (iii) is accompanied by a Plant Health Certificate or a Plant Health Assurance Certificate specifying the origin of the Host Fruit and certifying that paragraphs 2 (b) (i) and (ii) have been satisfied; and
 - (c) in the case of Host Fruit originating in the Outer Area and moving through the Outbreak Area or the Suspension Area for processing or packing at a facility located in the Outer Area, the Host Fruit is:
 - (i) securely transported to the processing or packing facility; and
 - (ii) accompanied by a Plant Health Certificate or a Plant Health Assurance Certificate specifying the origin of the Host Fruit and certifying that paragraph 2 (c) (i) has been satisfied; and

- (d) in the case of Host Fruit originating in the Outer Area and moving to a packing facility within the Outbreak Area or the Suspension Area for packing prior to export:
- (i) the Host Fruit is transported into and managed within the Outbreak Area or the Suspension Area in the manner specified in Schedule 7; and
 - (ii) the Host Fruit is accompanied by a Plant Health Certificate or a Plant Health Assurance Certificate certifying that:
 - (A) the property the Host Fruit was sourced from is in the Outer Area; and
 - (B) the property the Host Fruit was sourced from is currently the subject of an Area Freedom Certificate in respect of Queensland fruit fly; and
 - (C) paragraph 2 (d) (i) has been satisfied; and
 - (iii) where the consignment of the Host Fruit is to be re-consigned or split, the Plant Health Certificate or the Plant Health Assurance Certificate is endorsed by an inspector or a person authorised pursuant to section 11 (3) of the Act.
3. Any covering or packaging containing Host Fruit that is being moved in accordance with paragraph 2 must comply with the conditions specified in Schedule 8.
4. A Plant Health Certificate or a Plant Health Assurance Certificate referred to in paragraph 2 must be produced on demand to an inspector or a person authorised pursuant to section 11 (3) of the Act.

Definitions

accompanied by means the certificate is in the possession of the driver of the vehicle transporting the Host Fruit or the person otherwise having custody or control of the Host Fruit while it is in the Suspension Area or the Outer Area as the case may be.

APVMA means the Australian Pesticides & Veterinary Medicines Authority.

Area Freedom Certificate means a certificate issued by the Chief Plant Protection Officer of the relevant State or Territory certifying the State or Territory concerned or part thereof is free from Queensland fruit fly.

Department means Industry and Investment, NSW – Primary Industries.

Host Fruit means the fruit specified in Schedule 1.

Interstate Certification Assurance Scheme means a system of nationally approved arrangements which enable an accredited business to certify products which satisfy quarantine requirements for movement to interstate and intrastate markets.

Lot means a discrete quantity of fruit received from one grower at one time.

Outbreak Area means the part of New South Wales described in Schedule 2.

Outer Area means the area known as the New South Wales Fruit Fly Exclusion Zone, as specified in Proclamation P184 published in Government Gazette No 152 of 28 November 2008, at pages 11434 and 11435, excluding the Suspension Area and the Outbreak Area.

Plant Health Assurance Certificate means a certificate issued by a business accredited under an Interstate Certification Assurance Scheme arrangement approved by the Department certifying that the Host Fruit has been treated and moved in a manner specified in this Proclamation.

Plant Health Certificate means a certificate issued by an inspector or a person authorised pursuant to section 11 (3) of the Act certifying that the Host Fruit has been treated and moved in a manner specified in this Proclamation.

Suspension Area means the part of New South Wales described in Schedule 3, excluding the Outbreak Area.

free of broken skin means the skin has no preharvest cracks, punctures, pulled stems or other breaks which penetrate through the skin and have not healed with callus tissue.

Note: “covering or package” and “inspector” have the same meaning as in the Act.

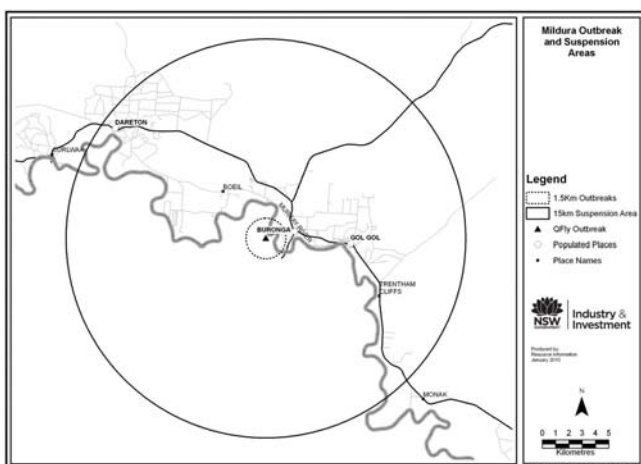

SCHEDULE 5

Treatments

Preharvest Treatment and Inspection

1. Tomatoes:
 - (a) treated preharvest with an application of dimethoate or fenthion or trichlorfon in accordance with all label directions for the control of Queensland fruit fly, and
 - (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and broken skins.
2. Capsicums and chillies:
 - (a) treated preharvest with an application of dimethoate in accordance with all label directions for the control of Queensland fruit fly, and
 - (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and broken skins.
3. Stonefruit:
 - (a) treated preharvest with an application of fenthion in accordance with all label directions for the control of Queensland fruit fly; and
 - (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and broken skins.

4. Table grapes:

- (a) treated preharvest for the control of Queensland fruit fly, with a program of:
 - (i) bait sprays with an insecticide containing 0.24 g/L spinosad as the only active constituent in accordance with all label directions; or
 - (ii) bait sprays with an insecticide containing 1150 g/L maldison as the only active constituent in accordance with all label and APVMA permit (PER10805) directions; or
 - (ii) cover sprays using an insecticide containing 550 g/L fenthion as the only active constituent in accordance with all label and APVMA permit (PER11643) directions; and
- (b) inspected postharvest where a sample of the fruit is inspected and found free of fruit fly larvae and broken skins.

Postharvest Dimethoate Dip

5. Any Host Fruit excluding capsicum (hollow-fruited), chilli (hollow-fruited), cumquat and strawberries, treated with a postharvest dip using an insecticide containing 400 g/L dimethoate as its only active constituent in accordance with all label and APVMA permit (PER10534) directions; where dipping is the last treatment before packing except in the case of:
 - (a) Citrus, where a non-recovery gloss wax coating and or a compatible fungicide as specified on the label may be applied within 24 hours of treatment; and
 - (b) Pomefruit, where a non-recovery gloss wax and or a compatible fungicide as specified on the label may be applied within 3 hours of treatment.

Postharvest Dimethoate Flood Spray

6. Any Host Fruit excluding cumquat, eggplant and strawberries, treated with a postharvest flood spray using an insecticide containing 400 g/L dimethoate as its only active constituent in accordance with all label and APVMA permit (PER10534) directions, where spraying is the last treatment before packing except in the case of:
 - (a) Citrus, where a non-recovery gloss wax coating and or a compatible fungicide as specified on the label may be applied within 24 hours of treatment; and
 - (b) Pomefruit, where a non-recovery gloss wax coating and or compatible fungicide as specified on the label may be applied within 3 hours of treatment.

Postharvest Methyl Bromide Fumigation

7. Any Host Fruit fumigated postharvest with a fumigant containing 1000 g/Kg methyl bromide as its only active constituent in accordance with all label and APVMA permit (PER10699) directions, at the following rates:
 - (a) 10°C – 14.9°C @ 48g/m³ for 2 hours; or
 - (b) 15°C – 20.9°C @ 40g/m³ for 2 hours; or
 - (c) 21°C – 25.9°C @ 32g/m³ for 2 hours; or
 - (d) 26°C – 31.9°C @ 24g/m³ for 2 hours.

Postharvest Cold Treatment

8. Any applicable Host Fruit treated postharvest at a temperature of:
 - (a) 0°C ± 0.5°C for a minimum of 14 days; or
 - (b) 0.5°C to 3.5°C for a minimum of 16 days (Lemons minimum 14 days).

SCHEDULE 6

Manner of Transporting and Processing

1. Before dispatch:
 - (a) all bins or containers, trucks and trailers intending to be used for the transportation of Host Fruit must be free from all plant debris and soil prior to packing and loading; and
 - (b) the consignment must be covered by a tarpaulin, shade cloth, bin covers or other coverings or contained within the covered vehicle so as to prevent infestation by Queensland fruit fly and spillage during transportation; and
 - (c) the bins and containers must be loaded onto or into a transport vehicle on a hard surface and must not be loaded in the orchard from which the Host Fruit was sourced; and
 - (d) the transport vehicle must:
 - (i) be cleaned free of all soil and plant matter after loading the consignment and before leaving the orchard from which the Host Fruit was sourced; and
 - (ii) travel by the most direct route to the processor; and
2. upon receipt of the consignment at the processor:
 - (a) the Host Fruit must be processed within 24 hours of receipt; and
 - (b) all measures must be taken to avoid spillage of Host Fruit at the processor and spillages must be disposed of in a manner generally accepted as likely to prevent the spread of Queensland fruit fly; and
3. processing wastes must be disinfected by heat, freezing or burial.

SCHEDULE 7

Manner of Transporting and Packing

1. Before dispatch from the Outer Area:
 - (a) all bins or containers, trucks and trailers intending to be used for the transportation of Host Fruit must be free from all plant debris and soil prior to packing and loading; and
 - (b) the consignment must be covered by a tarpaulin, shade cloth, bin covers or other coverings or contained within the covered vehicle so as to prevent infestation by Queensland fruit fly and spillage during transportation; and
2. the consignment must be transported through the Outer Area into the Outbreak Area and the Suspension Area by the most direct route; and
3. during transit:
 - (a) the Host Fruit must not be unloaded from the truck; and
 - (b) all measures must be taken to prevent spillage and if spillage does occur, the Host Fruit must be collected, bagged and buried at the nearest garbage disposal centre; and
4. prior to receipt of the Host Fruit at the facility within the Outbreak Area or the Suspension Area, the packing shed must:
 - (a) be cleared of any Host Fruit which was sourced from an area free of Queensland fruit fly; and
 - (b) be thoroughly cleaned and free of plant debris; and

5. within the packing facility within the Outbreak Area or the Suspension Area, the Host Fruit:
 - (a) must be kept segregated at all times from any other Host Fruit that has originated from within the Outbreak Area or the Suspension Area; and
 - (b) must be kept covered until just before packing; and
 - (c) after packing, must be stored in such a manner so as to prevent infestation by Queensland fruit fly.

SCHEDULE 8

Conditions of Packaging

1. Packaging must be free of soil, plant residues and other organic matter; and
2. any individual package must contain only one kind of Host Fruit; and
3. all previous incorrect information displayed on the outer covering of the package must be removed or obliterated; and
4. the outer covering of the package is to be legibly marked with:
 - (a) the district of production; and
 - (b) the name, address, postcode and the State or Territory of:
 - (i) both the grower and the packer, or
 - (ii) in the case of businesses sourcing from multiple growers, the packer; and
 - (c) a brief description of the contents of the package; or
5. if packed in accordance with an approved Interstate Certification Assurance Scheme (ICA) arrangement, legibly marked with:
 - (a) the "IP Number" of the accredited business certifying the produce "Meets ICA ##"; and
 - (b) the date (or date code) in accordance with the requirement of the ICA arrangement; and
 - (c) a brief description of the contents of the package.

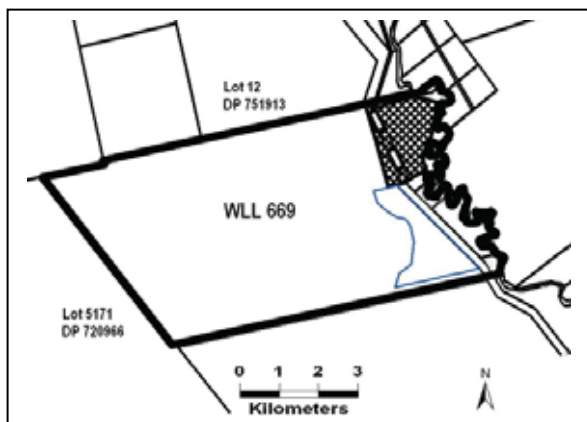

The notice board, gates and facilities must be erected and maintained to the satisfaction of the Commissioner. The lessee must not overstock, wholly or in part, the areas leased within the reserve, the decision as to overstocking resting with the Commissioner.
- (25) The Crown shall not be responsible to the lessee or the lessee's successors in title for provision of access to the land leased.
- (26) The lessee must comply with the provisions of the Native Vegetation Act 2003 and any regulations made in pursuance of that Act.
- (27) The lessee must comply with requirements of section 18DA of the Western Lands Act 1901 which provides that except in circumstances referred to in subsection (3) of that section, cultivation of the land leased or occupied may not be carried out unless the written consent of the Authority has first been obtained and any condition to which the consent is subject under sub section (6) is complied with.
- (28) Notwithstanding any other condition annexed to the lease, the lessee must, in removing timber for the purpose of building, fencing or firewood, comply with the routine agricultural management activities listed in the Native Vegetation Act 2003.

- (30) The lessee must undertake any fuel management and/or provision of fire trail access in accordance with fire mitigation measures to the satisfaction of the NSW Rural Fire Service.
- (31) The lessee must, as the Commissioner may from time to time direct, foster and cultivate on the land leased such edible shrubs and plants as the Commissioner may consider can be advantageously and successfully cultivated.
- (32) Whenever so directed by the Commissioner, the lessee must, on such part or parts of the land leased as shall be specified in the direction, carry out agricultural practices, or refrain from agricultural practices, of such types and for such periods as the Commissioner may in the direction specify.
- (33) The lessee must not overstock, or permit or allow to be overstocked, the land leased and the decision of the Commissioner as to what constitutes overstocking shall be final and the lessee must comply with any directions of the Commissioner to prevent or discontinue overstocking.
- (34) The lessee must, if the Commissioner so directs, prevent the use by stock of any part of the land leased for such periods as the Commissioner considers necessary to permit the natural reseeded and regeneration of vegetation and, for that purpose, the lessee must erect within the time appointed by the Commissioner such fencing as the Commissioner may consider necessary.

- (35) The lessee must furnish such returns and statements as the Commissioner may from time to time require on any matter connected with the land leased or any other land (whether within or outside the Western Division) in which the lessee has an interest.
- (36) The lessee must, within such time as may be specified by the Commissioner take such steps and measures as the Commissioner shall direct to destroy vermin and such animals and weeds as may, under any Act, from time to time be declared (by declaration covering the land leased) noxious in the Gazette and must keep the land free of such vermin and noxious animals and weeds during the currency of the lease to the satisfaction of the Commissioner.
- (37) The lessee must not remove or permit any person to remove gravel, stone, clay, shells or other material for the purpose of sale from the land leased unless the lessee or the person is the holder of a quarry license under regulations made under the Crown Lands Act 1989 or, in respect of land in a State forest, unless the lessee or the person is the holder of a forest materials licence under the Forestry Act 1916, and has obtained the special authority of the Minister to operate on the land, but the lessee may, with the approval of the Commissioner, take from the land such gravel, stone, clay, shells or other material for building and other purposes upon the land as may be required by the lessee.
- (38) The lessee must not clear any native vegetation within the area shown cross-hatched on the diagram hereunder unless written approval has been granted by the local Catchment Management Authority.
- (39) The lessee must only cultivate an area of **266 hectares** (WLL 669) as indicated by the cross hatched area on the diagram hereunder.

- (46) Stubble shall be retained on the soil surface and shall not be burnt, except with the approval of the Commissioner or his delegate. Where such approval is granted, stubble burning is to be carried out as per requirements of the NSW Rural Fire Service.
- (47) The lessee must undertake any appropriate measures, at his/her own expense, ordered by the Commissioner to rehabilitate any degraded cultivated areas.

- (51) The lessee must ensure that sandhills and other soils with a surface texture of loamy sand or coarser are left uncultivated unless specifically approved by the commissioner.
- (52) The lessee must ensure that land within 60 metres of any texture contrast or duplex soil area remains uncultivated except in accordance with a plan approved by the Commissioner. Texture contrast (or duplex) soils are soil types which have a sandy to loamy topsoil abruptly overlaying a clay subsoil and are prone to scalding (producing claypans and hummocks).
- (53) Areas with a slope greater than 2% must not be cultivated until any soil conservation measures documented in a plan approved by the Commissioner have been implemented at the lessee's expense.

- (e) The Safety Management System must contain a Risk Assessment Analysis identifying areas in which the vessel is non compliant with the current construction standards as set out in the Uniform Shipping Laws Code 2008 and/or the National Standard for Commercial Vessels as published by the National Marine Safety Committee, and such Risk Assessment Analysis must assess how any such non-compliance is to be managed from a safety perspective;
- (f) The vessel must be registered under the Marine Safety Act 1998;
- (g) The vessel must carry as a minimum, safety equipment as prescribed by the Marine Safety (General) Regulation 2009, in addition to any specialty safety equipment recommended in the Safety Management System for the vessel;
- (h) The Master of the vessel must hold as a minimum, a valid NSW Maritime General Boat Driving Licence or Personal Watercraft Licence or the equivalent issued by a Marine Authority in another State, and any additional qualification that may be specified as a requirement in the Safety Management System for the vessel;

- (i) The vessel must not carry any fare-paying passengers, unless an appropriate risk warning is given, in accordance with section 5M of the Civil Liability Act 2002, to each fare paying passenger before they embark the vessel. The warning must clearly state that the vessel is a heritage vessel that has been exempted from complying with requirements of the Commercial Vessels Act 1979 and may not meet current safety standards for construction and operation.
- (j) The vessel must not tow any persons behind the vessel, including but not limited to persons engaged in water skiing and wake boarding activities;
- (k) The Owner of the vessel must indemnify NSW Maritime against, and release NSW Maritime from, all liability associated with the issue and application of this Exemption; and
- (l) A copy of this Exemption Notice must be carried on board the vessel whenever the vessel is being used, and be produced to any NSW Maritime or Police Officer on demand.

NOTE:

If ANY of the conditions listed in Schedule 2 is not complied with, then the Exemption ceases to apply, and the Act applies to the subject vessel.

In this Order:

“Safety Management System” means a detailed plan identifying and addressing the safety risks likely to be encountered in the operation of the vessel, and may be included as an Annexure to the Vessel Management Plan.

“Australian Register of Historic Vessels” (ARHV), means the register developed by the Australian National Maritime Museum in association with the Sydney Heritage Fleet to record the details of significant heritage vessels, built before 1965, and having a known history of ownership.
