





CHARITABLE TRUSTS ACT 1993

Order Under Section 12

Cy-Pres Scheme Relating to the Putty Community Association

SECTION 12 of the Charitable Trusts Act 1993 permits the Attorney General by order to establish a scheme for the administration of any charitable trust.

On 21 February 2012, in proceedings brought by John Laycock against the Attorney General and others, the

Supreme Court declared that there is no validly appointed trustee or trustees to the trust established over land, in the NSW town of Putty ("the Trust"), upon which a community hall has been built in accordance with the original trust purpose. Consequentially, the Court ordered that the matter be referred to the Attorney General, pursuant to section 13 (2) of the Charitable Trusts Act 1993 ('the Act') for the establishment of a scheme pursuant to sections 13 (1) (c) and 12 of the Act. The Court also ordered that, pursuant to section 71 (1) of the Trustee Act 1925, the trust property vest in the trustee or trustees appointed by the Attorney General.

The Attorney General has authorised the following administrative scheme:

- 1. The land described in Title Folio 1/960250 is held upon trust for the stated trust purpose: "for the use of the residents of Putty for public, religious and social gatherings and for such other purposes as the said residents may from time to time determine" ("the Trust").
- 2. The Putty Community Association Inc. is appointed as trustee of the Trust and any powers conferred upon the trustee in the administration of the Trust is subject to the terms of the Trust;
- 3. The land, the subject of the Trust, is to vest in the Putty Community Association Inc as trustee but is not available for distribution by the Putty Community Association Inc or any other organisation;
- 4. In the event of the winding up of Putty Community Association Inc., the appointment of a replacement trustee must be approved by the Attorney General or the Supreme Court;
- 5. It is noted that the Constitution of the Putty Community Association Inc. provides that:

The objects of the Association shall be:

- (a) to provide for the social, religious and public needs of the residents of Putty (whether or not members of this association), and
- (b) to promote and foster community spirit and friendship within the district, and
- (c) to provide a place of meeting at the Putty Community Hall of a suitable standard to achieve these objectives, and
- (d) to ensure that the Putty Hall is managed at all times in a manner consistent with the provision of the trust under which the Putty Hall is held, subject to the Rules of the Association.

Plus: Rule 44: Use of the Hall

The Association must make the Putty Hall available for use by any resident of Putty (whether or not a member of the Association), subject to:

- (a) reasonable availability of the Putty Hall;
- (b) reasonable conditions of hire (which shall not discriminate between members of the Association and non-members);
- (c) either the proposed use of the hall falling within the scope of the Association's insurance, or the applicant for use arranging insurance for the reasonable satisfaction of the Committee:
- (d) any other condition or limitation the Committee considers should reasonably be imposed, subject to any such condition or limitation not being

inconsistent with the terms of the trust under which the Putty Hall is held.

This Order will take effect at the time of publication in the *NSW Government Gazette*, in accordance with section 16 (3) of the Charitable Trusts Act 1993.

UNDER section 11 (2) of the Director of Public Prosecutions Act 1986, I do by this my Order:

 - Clause 55 of Schedule 11 No prosecution for an offence under section 78H, 78I, 78K, 78L, 78M, 78N, 78O or 78Q or for an offence of attempting, or of conspiracy or incitement, to commit an offence under any of those sections shall, if the accused was at the time of the alleged offence under the age of 18 years, be commenced without the sanction of the Attorney General
 - Section 316 (1) concealing serious indictable offence.
 - Real Property Act 1900 section 143

All offences against the provisions of the Real Property Act may be prosecuted, and all penalties or sums of money imposed or declared to be due or owing by or under the provisions of the same may be sued for and recovered in the name of the Attorney General.

• *Oaths Act 1900* – section 33 (2)

Any person who, having made an affidavit under section 32 Oaths Act, wilfully makes a false statement in the affidavit, knowing the statement to be false, is taken to be guilty of perjury if the making of the statement, had it been on oath, would by law have been perjury.

No prosecution for an offence referred to in subsection (1) is to be commenced without the sanction of the Attorney General.

 Proceedings for an offence against this Act or the regulations may not be instituted without the written consent of the Attorney General.

- (4) The scheme shall, where an approval has been granted, provide the applicant, by written notice, with the following particulars
 - (a) the name of the approval holder;
 - (b) a description of the model (including marked brand or trade name);
 - (c) the fact that the scheme has approved the article;
 - (d) the date of the approval;
 - (e) the duration of the approval;
 - (f) the mark to be applied to the article to evidence that approval;
 - (g) the model reference code; and
 - (h) the declared class
- (5) The scheme shall, where an approval of a modified article has been granted, provide the applicant for that approval with written notice of the granting of that approval and of the details of the modification.
- (6) The scheme shall, where an approval has been renewed, provide the applicant for that renewal with written notice of that renewal.
- (7) The scheme shall maintain a computerised record of all approvals (including modifications and renewals). The record shall contain
 - (a) the approval particulars listed in clause 4 above;
 - (b) details of any modified or renewed approval; and
 - (c) details of any changes in the name of the approval holder, in the model reference code or in the description of an approved article.

- (8) The scheme shall provide to the Commissioner and other relevant authorities as directed, the computerised records described in item 7 above.
- (9) The scheme shall not grant an approval period (including any renewal period) of longer than five years. A modified approval shall not alter the date of expiry of the approval.
- (10) The scheme may extend an approval but only where the Commissioner's written authorisation has been provided. The extension period is determined by the Commissioner.
- (11) The scheme shall cancel or suspend an approval within five working days of written advice from the Commissioner to cancel or suspend an approval. The scheme shall advise the approval holder and other relevant authorities as directed, in a form acceptable to the Commissioner, within five working days of a cancellation or suspension.
- (12) The scheme shall advise the Commissioner and other relevant authorities as directed, in the form acceptable to the Commissioner, within five working days, of the details where it becomes aware that an article, marked with the scheme's mark, has been sold or is on sale without the approval of the scheme.
- (13) The scheme shall advise the Commissioner and other relevant authorities as directed, in the form acceptable to the Commissioner, within 5 working days, of the details of any cancellation of an approval.
- (14) The scheme shall allow the Commissioner to make an assessment of the scheme, which may include an inspection of the premises and examination of documentation in relation to the schemes approval processes and issued approvals, as determined by the Commissioner.
- (15) The scheme shall only authorise the use of the mark accepted by the Minister or the Regulatory Compliance Mark, where the requirements of all the relevant parts of AS/NZS 4417 are fulfilled, to evidence an approval of a declared article.
- (16) The scheme shall on request provide the Commissioner with all records, including test reports and photographs, submitted to the scheme associated with an approval granted by the scheme. These records shall be maintained for at least 10 years from the date of expiry of the approval or any subsequent renewal.
- (17) The scheme agrees to pay the Commissioner in accordance with the attached "Schedule of Payment".
