#### **VEXATIOUS PROCEEDINGS ACT 2008**

##### Evangelos Rouvinetis

ON 12 June 2012, Justice Adams ordered that:

Orders made pursuant to s.8(7) of the Vexatious Proceedings Act 2008:

1. The defendant is prohibited from instituting proceedings in any tribunal or court in New South Wales without leave of this Court.

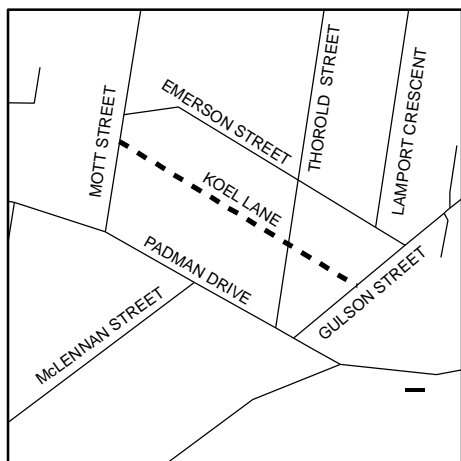
