## **FISHERIES MANAGEMENT ACT 1994**

### Section 76

#### Instrument of Determination of Management Charge for Lobster Fishery

I, DOUGLAS FERRELL, A/Director, Commercial Fisheries with the delegated authority of the Minister for Primary Industries and the Secretary of the Department of Trade and Investment, Regional Infrastructure and Services, pursuant to sections 227 and 228 of the Fisheries Management Act 1994 ("the Act") and pursuant to sections 76(1) and (2) of the Act, do hereby determine the management charge for the period 1 July 2014 to 30 June 2015, payable by holders of shares in the lobster fishery (as described in Schedule 1 to the Act) to be \$52.81 per share.
