**MENTAL HEALTH ACT 2007**

Section 109

Declaration of Mental Health Facility

I, Dr Mary Foley, Secretary of the NSW Ministry of Health, pursuant to section 109 of the *Mental Health Act 2007*, do hereby

- (a) DECLARE the Royal North Shore Community Health Centre (Mental Health), situated at 2C, Level 1, Herbert Street, St Leonards NSW 2065, to be a declared mental health facility under the *Mental Health Act 2007*; and
- (b) DECLARE this facility to be designated in the class of facilities known as “community or health care agency class” for the purposes of section 109 (2) (a); and
- (c) RESTRICT the facility to the provision of services and performance of functions necessary for or associated with the administration or management of community treatment orders under the following provisions of the *Mental Health Act 2007*:
  - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
  - ii. Chapter 4; and
  - iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2)

**MENTAL HEALTH ACT 2007**

Section 109

Declaration of Mental Health Facility

I, Dr Mary Foley, Secretary of the NSW Ministry of Health, pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, do hereby

- (a) REVOKE the Order published in the *New South Wales Government Gazette* No 77 of 28 July 2011, declaring certain premises of Royal North Shore Hospital to be a declared mental health facility in accordance with section 109 of the *Mental Health Act 2007*,
- (b) DECLARE the following premises of Royal North Shore Hospital to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:
  - the Psychiatric Emergency Care Centre of the Royal North Shore Hospital**, located in the Emergency Department of the Royal North Shore Hospital, on the Royal North Shore Campus, Reserve Road, St Leonards NSW 2065; and
  - C J Cummins Unit** located on Level 2 of the Clinical Services Building, Royal North Shore Hospital, Lancelley Avenue, St Leonards NSW 2065.
- (c) DECLARE this facility to be designated as a “mental health assessment and inpatient treatment” facility.
