The Scientific Committee established under the *Threatened Species Conservation Act 1995* has made a final determination to insert the ecological community referred to in paragraph (a) as a critically endangered ecological community under that Act and, as a consequence, to omit reference to the ecological community referred to in paragraph (b) as an endangered ecological community and, accordingly:

- (a) Schedule 1A to that Act is amended by inserting in alphabetical order in Part 2:

Agnes Banks Woodland in the Sydney Basin Bioregion (as described in the final determination of the Scientific Committee to list the ecological community)

- (b) Schedule 1 to that Act is amended by omitting the following from Part 3:

Agnes Banks Woodland in the Sydney Basin Bioregion (as described in the determination of the Scientific Committee under Division 5 of Part 2)

## THREATENED SPECIES CONSERVATION ACT 1995

## FINAL DETERMINATION

The Scientific Committee, established by the *Threatened Species Conservation Act 1995* (the Act), has made a Final Determination under Section 23 of the Act to list the Agnes Banks Woodland in the Sydney Basin Bioregion as a CRITICALLY ENDANGERED ECOLOGICAL COMMUNITY in Part 2 of Schedule 1A of the Act, and as a consequence to omit reference to Agnes Banks Woodland in the Sydney Basin Bioregion from Part 3 of Schedule 1 of the Act.

**This determination contains the following information:**

**Parts 1 & 2:** Section 4 of the Act defines an ecological community as “an assemblage of species occupying a particular area”. These defining features of Agnes Banks Woodland in the Sydney Basin Bioregion are described in Parts 1 and 2 of this Determination, respectively.

**Part 3:** Part 3 of this Determination describes the eligibility for listing of this ecological community in Part 2 of Schedule 1A of the Act according to criteria as prescribed by the *Threatened Species Conservation Regulation 2010*.

**Part 4:** Part 4 of this Determination provides additional information intended to aid recognition of this community in the field.

**Part 1. Assemblage of species**

1.1 Agnes Banks Woodland in the Sydney Basin Bioregion, hereafter known as Agnes Banks Woodland, is characterised by the assemblage of species listed below.

1.2 The total species list of the community across all occurrences is likely to be considerably larger than that given above. Due to variation across the range of the community, not all of the above species are present at every site and many sites may also contain species not listed above.

Characteristic species may be abundant or rare and comprise only a subset of the complete list of species recorded in known examples of the community. Some characteristic species show a high fidelity (are relatively restricted) to the community, but may also occur in other communities, while others are more typically found in a range of communities.

The number and identity of species recorded at a site is a function of sampling scale and effort. In general, the number of species recorded is likely to increase with the size of the site and there is a greater possibility of recording species that are rare in the landscape.

Species presence and relative abundance (dominance) will vary from site to site as a function of environmental factors such as soil properties (chemical composition, texture, depth, drainage), topography, climate and through time as a function of disturbance (eg fire, logging, grazing) and weather (eg flooding, drought, extreme heat or cold).

At any one time, above ground individuals of some species may be absent, but the species may be represented below ground in the soil seed bank or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers.

The species listed above are vascular plants, however the community also includes micro-organisms, fungi, cryptogamic plants and a diverse vertebrate and invertebrate fauna. These components of the community are less well documented.

## **Part 2. Particular area occupied by the ecological community**

- 2.1 The assemblage of species listed in Part 1.1 above which characterises the Agnes Banks Woodland occurs within the Sydney Basin Bioregion. This Bioregion is defined by SEWPaC (2012) Interim Biogeographic Regionalisation for Australia, Version 7. Department of Sustainability, Environment, Water, Population and Communities. <http://www.environment.gov.au/parks/nrs/science/bioregion-framework/ibra/maps.html>
- 2.2 It is the intent of the Scientific Committee that all occurrences of the ecological community (both recorded and as yet unrecorded, and independent of their condition) that occur within this bioregion be covered by this Determination.

## **Part 3. Eligibility for listing**

- 3.1.1 The extent of occurrence and area of occupancy (AOO) of Agnes Banks Woodland are estimated to be 16 km<sup>2</sup>. This estimate of AOO is based on four 2 x 2 km grid cells, the scale recommended for assessing AOO by IUCN (2014). The geographic distribution of Agnes Banks Woodland in the Sydney Bioregion is considered to be very highly restricted.
- 3.1.2 Remnants of Agnes Banks Woodland are threatened with further clearing and sand extraction for rural and rural-residential development; while most of the area that has been cleared was lost prior to 1998, 15 ha were cleared between 1998 and 2011 (M. Tozer *in litt.* October 2013). Any future clearing for sand mining may target Agnes Banks Woodland on well-drained sand dunes that are floristically distinct from the surrounding Castlereagh Woodlands (M. Tozer *in litt.* October 2013). Other continuing threats include weed invasion by African Lovegrass (*Eragrostis curvula*), Black Locust (*Robinia pseudoacacia*), Camphor Laurel (*Cinnamomum camphora*) and Privet (*Ligustrum* spp.) (J. Sanders *in litt.* October 2013; G. Steenbeeke *in litt.* October 2013). 'Loss and degradation of native plant and animal habitat by invasion of escaped garden plants, including aquatic plants', 'Clearing of native vegetation' and 'Invasion of native plant communities by exotic perennial grasses' are listed as Key Threatening Processes under the Act. Illegal rubbish dumping and access by four-wheel drive vehicles and motorbikes are an ongoing threat.
- 3.2 Criteria for listing

Agnes Banks Woodland in the Sydney Basin Bioregion is eligible to be listed as a Critically Endangered Ecological Community in accordance with Section 12 of the Act as, in the opinion of the Scientific Committee, it is facing an extremely high risk of extinction in New South Wales in the immediate future, as determined in accordance with the following criteria as prescribed by the *Threatened Species Conservation Regulation 2010*:

### **Clause 18 Restricted geographic distribution of the ecological community**

The ecological community's geographic distribution is estimated or inferred to be:

- (a) very highly restricted,

and the nature of its distribution makes it likely that the action of a threatening process could cause it to decline or degrade in extent or ecological function over a time span appropriate to the life cycle and habitat characteristics of the ecological community's component species.

### **Clause 19 Reduction in ecological function of the ecological community**

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

- (a) a very large reduction in ecological function, as indicated by any of the following:
  - (d) change in community structure,
  - (e) change in species composition,
  - (g) invasion and establishment of exotic species,
  - (h) degradation of habitat.

**Part 4. Additional information about the ecological community**

The following information is additional to that required to meet the definition of an ecological community under the Act, but is provided to assist in the recognition of Agnes Banks Woodland in the field. Given natural variability, along with disturbance history, Agnes Banks Woodland may sometimes occur outside the typical range of variation in the features described below.

- 4.1 The vegetation of Agnes Banks Woodland is described under the same name in Benson (1992), James (1997), National Parks and Wildlife Service Threatened Species Unit (2000), Tozer (2003) and Tozer *et al.* (2010).
- 4.2 Agnes Banks Woodland is restricted to small areas of sand dunes overlying Tertiary Alluvium at Agnes Banks on the east bank of the Hawkesbury River in Western Sydney. 'The vegetation of the Agnes Banks sand deposit includes several assemblages which intergrade in a continuum along soil drainage gradients and collectively comprise the Endangered Ecological Community' (M. Tozer *in litt.* Oct. 2013). Stands of Agnes Banks Woodland found on deep, well-drained sands are recognised as a separate community from the surrounding communities of Castlereagh Ironbark Forest and Castlereagh Scribbly Gum Woodland (Tozer *et al.* 2010).
- 4.3 Agnes Banks Woodland is a low woodland dominated by *Eucalyptus sclerophylla* and *Angophora bakeri* with a diverse understorey of sclerophyllous shrub species including *Acacia brownii*, *Acacia elongata*, *Amperea xiphoclada*, *Baeckea diosmifolia*, *Banksia aemula*, *Banksia oblongifolia*, *Bossiaea rhombifolia*, *Callistemon citrinus*, *Callistemon linearis*, *Conospermum taxifolium*, *Dillwynia floribunda*, *Hibbertia fasciculata*, *Kunzea capitata*, *Leptospermum trinervium*, *Leucopogon virgatus*, *Monotoca scoparia*, *Olax stricta*, *Persoonia nutans*, *Philothea salsolifolia*, and *Ricinocarpus pinifolius*. Ground layer species include *Caleana major*, *Haemodorum corymbosum*, *Leptocarpus tenax*, *Mitrasacme polymorpha*, *Pimelia linifolia*, *Platysace ericoides*, *Stylidium graminifolium* and *Trachymene incisa*. The species listed above were identified as diagnostic for this community (M. Tozer *in litt.* 2003, revised by M. Tozer *in litt.* October 2013). A diagnostic species is defined as one with a higher probability of occurring in the target community than expected, based on their frequency of occurrence in the data set for the Cumberland Plain (Tozer 2003).
- 4.4 Two of the plant species found in Agnes Banks Woodland (*Acacia bynoeana* and *Persoonia nutans*) are listed as Endangered species under the Act. James *et al.* (1999) identify a further five species that occur in Agnes Banks Woodland as being of conservation importance in western Sydney (*Banksia aemula*, *Callistemon linearis*, *Dillwynia glaberrima*, *Lepidosperma longitudinale* and *Xyris complanata*).
- 4.5 Agnes Banks Woodland has been heavily cleared in the past. The original extent of the community is uncertain as much of the community has been cleared due to sandmining. Independent estimates of the pre-European extent range from 475 to 627 ha (Benson 1981, Tozer 2003, M. Tozer *et al.* 2010). A reappraisal of a range of primary data including quantitative survey plots, field-verified aerial photo-pattern and soil landscape mapping (Bannerman and Hazelton 1990) suggests that the original extent of the community was at the low end of this range (475 ha; M. Tozer *in litt.* October 2013). Agnes Banks Woodland has been extensively cleared for sand extraction (68–84%; M. Tozer *in litt.* October 2013). About 75–151 ha still survive (M. Tozer *in litt.* October 2013) and the community has limited representation (45 ha) in Agnes Banks Nature Reserve.
- 4.6 Agnes Banks Woodland has currently been recorded in the local government area of Penrith however unrecorded stands of the ecological community may occur elsewhere in the Bioregion.

- 2.1 The assemblage of species listed in Part 1.1 above which characterises the Artesian Springs Ecological Community is known from the Mulga Lands, Cobar Penepain, Darling Riverine Plains, Channel Country and Brigalow Belt South Bioregions, but may occur within other bioregions within the Great Artesian Basin. These Bioregions are defined by SEWPaC (2012) Interim Biogeographic Regionalisation for Australia, Version 7. Department of Sustainability, Environment, Water, Population and Communities.

- 2.2 It is the intent of the Scientific Committee that all occurrences of the ecological community (both recorded and as yet unrecorded, and independent of their condition) that occur within these bioregions be covered by this Determination.
- 2.3 The Artesian Springs Ecological Community is associated with artesian springs within the Great Artesian Basin (Silcock *et al.* 2013).

## **Part 3. Eligibility for listing**

### **3.1 Reasons for determining eligibility for listing**

- 3.1.1 The Artesian Springs Ecological Community was listed as an Endangered Ecological Community under the Act in 2001 (NSW Scientific Committee 2001). Since this time new data and analyses have become available and the Committee is of the opinion that the determination of this community should be revised.
- 3.1.2 Major threats to the Artesian Springs Ecological Community are trampling and grazing by stock and feral animals such as pigs, goats and rabbits; and hydrological alteration or unsustainable extraction of water from artesian bores reducing flows (Westbrooke *et al.* 2003; Caddy *et al.* 2010; Fensham *et al.* 2010; Powell *et al.* 2013; Silcock *et al.* 2013).
- 3.1.3 Trampling and digging, particularly by feral pigs, is a major disturbance around the edges of artesian spring wetlands (Fensham *et al.* 2010). Soil disturbance from feral pigs in and around wetlands can cause disruption of the seed bank via deeper burial of seeds and encouragement of weeds (Bell *et al.* 2012). These effects can be particularly severe in small spring wetlands where animals have unrestricted access and the vegetation of individual small wetlands can be completely destroyed by a single incident. Pigs may also degrade the habitat for specialised fauna through sediment disturbance that causes increases in water turbidity (Fensham *et al.* 2010). 'Predation, habitat degradation, competition and disease transmission by Feral Pigs, *Sus scrofa* Linnaeus 1758' is listed as a Key Threatening Process under the Act.
- 3.1.4 Human induced changes to artesian discharge and destruction of spring wetlands through excavation negatively impact the Artesian Springs Ecological Community. Although the Great Artesian Basin Sustainability Initiative bore capping program has made considerable progress (SKM 2008), a number of springs have dried in the past 100 years due to falling water pressure caused by over-extraction (Fensham *et al.* 2010, Silcock *et al.* 2013). Prolonged exposure to disturbance and aquifer drawdown constrains artesian spring vegetation community succession and has caused the extinction of aquatic invertebrate and plant species (Ponder 1986, 1999; Fensham *et al.* 2010). Powell *et al.* (2013) recently visited 45 of the 54 spring groups in New South Wales and found that over three-quarters of the springs had become inactive, with all springs in the Paroo Overflow group, except Peery Lake, recorded as extinct. The extinction of two populations of the Endangered Salt Pipewort, *Eriocaulon carsonii*, is known to have occurred as a consequence of artesian springs becoming inactive (Fensham *et al.* 2010). 'Alteration to the natural flow regimes of rivers, streams, floodplains and wetlands' is listed as a Key Threatening Process under the Act.

3.2 Criteria for listing

The Artesian Springs Ecological Community in the Great Artesian Basin is eligible to be listed as a Critically Endangered Ecological Community in accordance with Section 12 of the Act as, in the opinion of the Scientific Committee, it is facing a very high risk of extinction in New South Wales in the near future, as determined in accordance with the following criteria as prescribed by the *Threatened Species Conservation Regulation 2010*:

**Clause 19 Reduction in ecological function of the ecological community**

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

- (a) a very large reduction in ecological function, as indicated by any of the following:
- (e) change in species composition,
- (f) disruption of ecological processes,
- (g) invasion and establishment of exotic species,
- (h) degradation of habitat.

**Part 4. Additional information about the ecological community**

The following information is additional to that required to meet the definition of an ecological community under the Act, but is provided to assist in the recognition of the Artesian Springs Ecological Community in the field. Given natural variability, along with disturbance history, the Artesian Springs Ecological Community may sometimes occur outside the typical range of variation in the features described below.

- 4.1 The 'community of native species dependent on natural discharge of groundwater from the Great Artesian Basin' is listed as Endangered under the Commonwealth *Environmental Protection and Biodiversity Conservation Act 1999*.  
The Artesian Springs Ecological Community supports a suite of organisms that are distinct from those in seasonal wetlands, including perennial wetland plants (Fensham *et al.* 2010). The Artesian Springs Ecological Community is variable as each individual spring varies in shape, water flow, topographic and geographic location. The vegetation within the community frequently consists of sedges or similar vegetation (Pickard 1992) with *Cyperus laevigatus* dominating most spring wetlands (Powell *et al.* 2013). Trees and shrubs occur on the edges of, or near, the springs. The locations of all known springs (dry and active) are provided in Silcock *et al.* (2013).
- 4.2 Artesian springs are often characterised by mounds of sediment and salts deposited as water evaporates (Ponder 1986, 1999) or they may be depressions.
- 4.3 Where artesian groundwater pressure has been adequate to maintain the Artesian Springs Ecological Community, it can be distinguished from most other wetland communities of the region because it is not subject to seasonal drying out and is sustained by a relatively constant water supply. However, rapid reductions in spring flow and habitat condition can lead to a loss of water-dependent species. The soil seed bank and extant vegetation of degraded springs often consist only of common flora similar to an overgrazed terrestrial plant community (Pickard 1992; H. Caddy, unpublished data).
- 4.4 Three artesian spring 'supergroups' are recognised in New South Wales: Bourke, Bogan River and Eulo. The Bourke group extends 500 km from White Cliffs north-east to Culgoa Floodplain National Park just over the Queensland border. The Bogan River group is comprised of widely-spaced springs west of Walgett. Four springs in New South Wales south of Hungerford are regarded as part of the Eulo supergroup (Powell *et al.* 2013; Silcock *et al.* 2013).
- 4.5 The Artesian Springs Ecological Community corresponds to plant community ID66 Artesian Mound Spring sedgeland wetland mainly of the Mulga Lands Bioregion (Benson *et al.* 2010).
- 4.6 The Artesian Springs Ecological Community has a highly restricted geographic distribution. The extent of occurrence of the Artesian Springs Ecological Community was estimated to be between 25000 km<sup>2</sup> (active springs only) to 89000 km<sup>2</sup> (active and non-active springs). The area of occupancy was estimated to be 44 km<sup>2</sup> (active springs only) to 232 km<sup>2</sup> (active and non-active springs) based on 2 x 2 km grid cells, the scale recommended for assessing area of occupancy by IUCN (2014).
- 4.7 The Peery Lake artesian springs are within Paroo-Darling National Park (Westbrooke *et al.* 2003). Although this is a reserved area the springs are not likely to be well protected from the threat of alteration of flows. The unsustainable extraction of artesian water occurs outside the reserve, and is likely to influence all springs within the region. The endangered Salt Pipewort, *Eriocaulon carsonii*, is known to occur in artesian springs (Fensham *et al.* 2010) and is endemic to the Artesian Springs Ecological Community (Silcock *et al.* 2013).

## FINAL DETERMINATION

The Scientific Committee, established by the *Threatened Species Conservation Act 1995* (the Act), has made a Final Determination under Section 23 of the Act to list the Coolac-Tumut Serpentinite Shrubby Woodland in the NSW South Western Slopes and South Eastern Highlands Bioregions as an ENDANGERED ECOLOGICAL COMMUNITY in Part 3 of Schedule 1 of the Act.

**This determination contains the following information:**

**Parts 1 & 2:** Section 4 of the Act defines an ecological community as “an assemblage of species occupying a particular area”. These features of Coolac-Tumut Serpentinite Shrubby Woodland in the NSW South Western Slopes and South Eastern Highlands Bioregions are described in Parts 1 and 2 of this Determination, respectively.

**Part 3:** Part 3 of this Determination describes the eligibility for listing of this ecological community in Part 3 of Schedule 1 of the Act according to criteria as prescribed by the *Threatened Species Conservation Regulation 2010*.

**Part 4:** Part 4 of this Determination provides additional information intended to aid recognition of this community in the field.

**Part 1. Assemblage of species**

1.1 Coolac-Tumut Serpentinite Shrubby Woodland in the NSW South Western Slopes and South Eastern Highlands Bioregions (hereafter referred to as Coolac-Tumut Serpentinite Shrubby Woodland) is characterised by the assemblage of species listed below.

- 1.2 The total species list of the community across all occurrences is likely to be considerably larger than that given above. Due to variation across the range of the community, not all of the above species are present at every site and many sites may also contain species not listed above.

Characteristic species may be abundant or rare and comprise only a subset of the complete list of species recorded in known examples of the community. Some characteristic species show a high fidelity (are relatively restricted) to the community, but may also occur in other communities, while others are more typically found in a range of communities.

The number and identity of species recorded at a site is a function of sampling scale and effort. In general, the number of species recorded is likely to increase with the size of the site and there is a greater possibility of recording species that are rare in the landscape.

Species presence and relative abundance (dominance) will vary from site to site as a function of environmental factors such as soil properties (chemical composition, texture, depth, drainage), topography, climate, and through time as a function of disturbance (eg fire, logging, grazing) and weather (eg flooding, drought, extreme heat or cold).

At any one time, above ground individuals of some species may be absent, but the species may be represented below ground in the soil seed bank or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers.

The species listed above are vascular plants, however the community also includes micro-organisms, fungi and cryptogamic plants as well as vertebrate and invertebrate fauna. These components of the community are less well documented.

## **Part 2. Particular area occupied by the ecological community**

- 2.1 The assemblage of species listed in Part 1.1 above which characterises Coolac-Tumut Serpentinite Shrubby Woodland occurs within the NSW South Western Slopes and South Eastern Highlands Bioregions. These Bioregions are defined by SEWPaC (2012) Interim Biogeographic Regionalisation for Australia, Version 7. Department of Sustainability, Environment, Water, Population and Communities.

- 2.2 It is the intent of the Scientific Committee that all occurrences of the ecological community (both recorded and as yet unrecorded, and independent of their condition) that occur within these bioregions be covered by this Determination.
- 2.3 Coolac-Tumut Serpentinite Shrubby Woodland is associated with serpentinite geology formations (Lyons *et al.* 1974; Benson *et al.* 2010; Mackenzie 2014).

## **Part 3. Eligibility for listing**

### **3.1 Reasons for determining eligibility for listing**

- 3.1.1 The geographic distribution of Coolac-Tumut Serpentinite Shrubby Woodland is highly restricted. Using serpentinite mapped in the Coolac/Gundagai/Tumut area in the NSW Statewide Geological Database Geology 250k (2001) layer as a surrogate for the distribution of the community, the extent of occurrence is estimated at 1721 km<sup>2</sup>. The extent of occurrence is based on a minimum convex polygon enclosing all mapped occurrences of the ecological community, the method of assessment recommended by IUCN (2014). The upper bound for Area of Occupancy (AOO) is estimated at 460 km<sup>2</sup> based on 115 2 x 2 km grid cells, the scale recommended for assessing area of occupancy by IUCN (2014). Due to extensive clearing throughout the community's range, the AOO is likely to be much less than this, but it is not likely to be < 10 km<sup>2</sup>. The community is not protected within any conservation reserves and reductions due to the action of threatening processes are likely to continue.
- 3.1.2 The Coolac-Tumut Serpentinite Shrubby Woodland has been extensively cleared and heavily impacted by weed invasion and grazing. This has led to changes in community structure and composition, degradation and fragmentation of habitat, and invasion and establishment of exotic species. Collectively, these threats indicate a large reduction in ecological function. Benson *et al.* (2010) cite major alteration to species composition and geographic distribution due to weed invasion, grazing and clearing. Benson *et al.* (2010) note that some areas of potential habitat have recently been converted to pine plantations, while Mackenzie (2014) found the Coolac Serpentinite outcrop and surrounding landscapes have been extensively cleared for grazing and agriculture. The community is highly fragmented with most remaining stands small and with high edge to area ratios (average polygon size of 4.8 ha, OEH *in litt.* 2012). Armstrong *et al.* (2013) note the adverse effects of grazing by domestic livestock and introduced animals such as rabbits, hares, horses, deer, pigs and goats on the structure and floristic composition of plant communities in the upper Murrumbidgee catchment. Mineral prospecting and mining may have local impacts; past mining took place at Tumut Gold Mine and McAlpine Mine and significant areas of serpentinite are covered by current mineral exploration licences (Armstrong *et al.* 2013). Weed species affecting heavily grazed locations include Saffron Thistle (*Carthamus lanatus*), St John's Wort (*Hypericum perforatum*), *Avena barbata*, *Petrorhagia nanteuilii*, *Briza maxima*, *Hypochaeris radicata* and, in gullies, Blackberry (*Rubus* spp.) (Benson *et al.* 2010). Armstrong *et al.* (2013) recorded the following



exotic taxa in 30% or more of plots assigned to the community: *Acetosella vulgaris*, *Avena barbata*, *Briza maxima*, *Bromus diandrus*, *Bromus hordeaceus*, *Carthamus lanatus*, *Hypericum perforatum*, *Hypochaeris glabra*, *Petrorhagia nanteuilii*, *Rosa rubiginosa*, *Rostraria cristata*, *Sonchus oleraceus*, *Trifolium angustifolium*, *Trifolium arvense*, *Trifolium campestre*, *Trifolium dubium* and *Trifolium glomeratum*. ‘Clearing of native vegetation’ and ‘Loss and degradation of native plant and animal habitat by invasion of escaped garden plants, including aquatic plants’ are listed as Key Threatening Processes under the Act. Due to the small patch size of remnant areas the Coolac-Tumut Serpentinite Shrubby Woodland is likely to be subject to stochastic changes in its immediate environment.

### 3.2 Criteria for listing

Coolac-Tumut Serpentinite Shrubby Woodland is eligible to be listed as an Endangered Ecological Community in accordance with Section 12 of the Act as, in the opinion of the Scientific Committee, it is facing an extremely high risk of extinction in New South Wales in the immediate future, as determined in accordance with the following criteria as prescribed by the *Threatened Species Conservation Regulation 2010*:

#### Clause 18 Restricted geographic distribution of the ecological community

The ecological community’s geographic distribution is estimated or inferred to be:

(b) highly restricted,

and the nature of its distribution makes it likely that the action of a threatening process could cause it to decline or degrade in extent or ecological function over a time span appropriate to the life cycle and habitat characteristics of the ecological community’s component species.

#### Clause 19 Reduction in ecological function of the ecological community

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

(b) a large reduction in ecological function.

as indicated by any of the following:

- (d) change in community structure,
- (e) change in species composition,
- (f) disruption of ecological processes,
- (g) invasion and establishment of exotic species,
- (h) degradation of habitat,
- (i) fragmentation of habitat.

### Part 4. Additional information about the ecological community

The following information is additional to that required to meet the definition of an ecological community under the Act, but is provided to assist in the recognition of Coolac-Tumut Serpentinite Shrubby Woodland in the field. Given natural variability, along with disturbance history, Coolac-Tumut Serpentinite Shrubby Woodland may sometimes occur outside the typical range of variation in the features described below.

- 4.1 The structure of Coolac-Tumut Serpentinite Shrubby Woodland varies between tall open heath and low sparse woodland. It is usually dominated by the small tree *Allocasuarina verticillata* and shrubs *Acacia implexa*, *Ricinocarpus bowmannii* and the grasstree *Xanthorrhoea glauca* subsp. *angustifolia*. Scattered taller trees include *Eucalyptus nortonii* and *E. albens*. The ground is rocky and the vegetative ground cover is sparse on exposed slopes and dense in creeklines. Ground cover species include the grasses *Themeda australis*, *Aristida ramosa* var. *ramosa*, *Rytidosperma pilosum*, *R. laeve*, *R. racemosum*, *Bothriochloa macra*, *Poa sieberiana* var. *sieberiana*, *Panicum effusum*, *Austrostipa scabra* and *Elymus scaber* (Benson *et al.* 2010; Armstrong *et al.* 2013). *Senecio quadridentatus*, *Cheilanthes sieberi* and *Carex breviculmis* are common components of the understorey (Armstrong *et al.* 2013). In protected gullies and footslopes where the soil is deeper *Eucalyptus bridgesiana* and *E. melliodora* can be found. *Banksia marginata* is restricted to protected gullies and occurs with *Dodonaea viscosa* subsp. *spatulata*, *Bursaria spinosa* subsp. *lasiophylla*, *Leptospermum brevipes*, *Abutilon oxycarpum*, *Acacia decora*, *Ricinocarpos bowmannii* and *Exocarpos cupressiformis*. In these situations the ground cover is dense to mid-dense with *Acaena novae-zelandiae*, *Rumex brownii*, *Geranium solanderi* var. *solanderi*, *Hypericum gramineum*, *Viola betonicifolia* and *Clematis microphylla* var. *leptophylla* common (Benson *et al.* 2010).
- 4.2 Coolac-Tumut Serpentinite Shrubby Woodland corresponds to plant community ID301 ‘Drooping Sheoke – *Ricinocarpus bowmannii* – grasstree tall open shrubland of the Coolac – Tumut Serpentinite Belt’, and plant community ID337 ‘Apple Box – Silver Banksia – Drooping Sheoak open woodland – tall shrubland in protected gullies of the Coolac – Tumut serpentinite belt, confined to the NSW South-western Slopes Bioregion’ in Benson *et al.* (2010). Coolac-Tumut Serpentinite Shrubby Woodland includes the following: u43 ‘Mealy Bundy – *Acacia implexa* – *Allocasuarina verticillata* – *Ricinocarpos bowmannii* tall grassy open woodland on serpentinite in the Coolac-Goobarragandra area primarily of the upper South Western Slopes Bioregion’ of Armstrong *et al.* (2013);

Biolandscape HonS29 'Western Slopes Dry Sclerophyll Forests' and Biolandscape HonS84 'Upper Riverina Dry Sclerophyll Forests' of Priday (2007); Vegetation Group 182 'Western Slopes Dry Shrub Forest on Serpentinite' of Gellie (2005); and 'Serpentine Woodland' of Mulvaney *et al.* (2005). Coolac-Tumut Serpentinite Shrubby Woodland is most closely aligned with Upper Riverina Dry Sclerophyll Forests vegetation class (VC 84) (Keith's 2004) although it has elements in common with Western Slopes Grassy Woodlands (VC 42), Southern Tableland Grassy Woodlands (VC 86) and Southern Tableland Dry Sclerophyll Forests (VC 28).

- 4.3 Coolac-Tumut Serpentinite Shrubby Woodland is associated with soils derived from the Coolac Serpentinite formation. These soils are relatively rich in magnesium and iron-group elements (cobalt, chromium, iron, manganese and nickel) and poor in calcium and potassium (Lyons *et al.* 1974, cited in Armstrong *et al.* 2013), inhibiting the growth of some plant species. Soils are commonly shallow to skeletal with much exposed rock (Armstrong *et al.* 2013).
- 4.4 Coolac-Tumut Serpentinite Shrubby Woodland has been recorded in the Gundagai and Tumut local government areas (within the NSW South Western Slopes and South Eastern Highlands Bioregions) however unrecorded stands of the ecological community may occur elsewhere in these Bioregions. It is not known to be represented in any conservation reserves.
