### AIR TRANSPORT (DEREGULATED ROUTES) ORDER 2015

I, Andrew Constance, the Minister for Transport and Infrastructure, in pursuance of section 4A (1) of the *Air Transport Act 1964*, make the following Order.

#### Explanatory note

Under section 4A (1) of the *Air Transport Act 1964 (the Act)*, the Minister for Transport and Infrastructure may, by order published in the Gazette, declare specified routes to be deregulated routes for the purposes of the Act. Certain routes were declared to be deregulated routes by an Order made under section 4A (1) of the Act and published in the Gazette on 28 March 2008.

The object of this Order is to declare a further route to be a deregulated route, namely the route between Sydney (Kingsford-Smith) Airport and Mudgee. As a consequence, the declaration in the Order published in the Gazette on 28 March 2008 is repealed and re-made in this Order.

#### 1 Name of Order

This Order is the *Air Transport (Deregulated Routes) Order 2015*.

#### 2 Commencement

This Order commences on the date of publication in the *NSW Government Gazette* and continues in force until revoked.

#### 3 Definitions

In this Order:

*the Act* means the *Air Transport Act 1964*.

#### 4 Declaration of deregulated routes

In pursuance of section 4A (1) of the Act, the following routes are declared to be deregulated routes for the purposes of the Act:

- (a) the routes between Sydney (Kingsford-Smith) Airport and each of the following localities, namely, Albury, Armidale, Ballina, Coffs Harbour, Dubbo, Griffith, Lismore, Mudgee, Orange, Port Macquarie, Tamworth, Wagga Wagga and Williamtown, and
- (b) any routes that do not begin or end at, or pass through, Sydney (Kingsford-Smith) Airport.

#### 5 Repeal

The Order made in pursuance of section 4A (1) of the Act and published in the Gazette on 28 March 2008 is repealed.

**1 Name of Direction**

This Direction is the *Environmental Planning and Assessment (Local Infrastructure Contributions – Warriewood Valley) Revocation Direction 2015*.

**2 When Direction takes effect**

This Direction takes effect on and from its date of publication in the *Gazette*.

**3 Consent authorities to which Direction is given**

- (1) This Direction is given to Pittwater Council.
- (2) This Direction also applies to Sydney East Joint Planning Panel or any other joint regional planning panel when exercising consent authority functions of Pittwater Council.

**4 Revocation of existing Direction in respect of local infrastructure contributions for development in Warriewood Valley**

The *Environmental Planning and Assessment (Local Infrastructure Contributions – Warriewood Valley) Direction 2011*, given by the then Minister for Planning and Infrastructure, the Honourable Brad Hazzard, MP, and dated 13 May 2011, is revoked.

**5 Savings and transitional arrangements**

The revocation of the *Environmental Planning and Assessment (Local Infrastructure Contributions – Warriewood Valley) Direction 2011* does not affect the operation of a condition of a development consent imposed in accordance with that Direction.

**Note.** Section 94EC (1A) of the *Environmental Planning and Assessment Act 1979* provides as follows:

The imposition of a condition by an accredited certifier as authorised by a contributions plan is subject to compliance with any directions given under section 94E (1) (a), (b) or (d) with which a council would be required to comply if issuing the complying development certificate concerned.

**FEES FOR AMBULANCE SERVICES – PAYMENT RULES ORDER 2014**

**1 Name of the Order**

This Order is the *Fees for Ambulance Services – Payment Rules Order 2014*.

**2 Commencement**

This Order commences on the day on which it is published in the Gazette.

**3 Exemption from the payment of ambulance fees**

(1) For the purposes of section 67N (c) of the Act, a person is exempt from the requirement to pay an ambulance fee if:

- (a) the person who received the ambulance service is a child or young person who, at the relevant time, was in the care responsibility or parental responsibility of the State or in receipt of financial assistance for their care under the *Children and Young Person's (Care and Protection) Act 1998*,
- (b) the person required an ambulance service following a sexual assault,
- (c) the person required an ambulance service following domestic violence or child abuse, or
- (d) at the time of the ambulance service the person was being taken to a declared mental health facility as it was considered the person may need to be involuntarily detained pursuant to the *Mental Health Act 2007* or the *Mental Health (Forensic Provisions) Act 1990*.

**4 Waiver of fees and change of payment arrangements**

(1) For the purposes of sections 67O (2) and 67ZC (4) of the Act, the Health Secretary may, but is not required to, waive the payment of an ambulance fee by a person where the Secretary is satisfied:

- (a) the person is experiencing financial hardship or non-financial hardship;
- (b) the person had, at the time the ambulance service was provided, made an application for a concession card within the meaning of section 67N (b) of the Act and the application has not been finalised,
- (c) the person has applied for refugee status, or has been granted refugee status,
- (d) the injury requiring an ambulance service arose from an act or omission done or made by the person as a good samaritan within the meaning of the *Civil Liability Act 2002*,
- (e) the liability to pay the fee arose in respect of an ambulance service provided to a child or young person as a result of an accident or incident in which the child or young person's parent or parents died, or
- (f) the person is the parent of a deceased child or young person and the ambulance fee arose in relation to an ambulance service provided to that child or young person.

(2) Where the Health Secretary is satisfied the requirements of paragraph (1) (a) are met, the Secretary may, in the alternative to waiving payment of the fee, change the payment arrangements for the fee by:

- (a) reducing the amount payable,
- (b) extending the time to pay, or
- (c) permitting the fee to be paid by instalments or reducing instalments.

(3) In this clause:

- (a) a person is experiencing "financial hardship" where he or she does not have the financial capacity, either permanently or temporarily, to pay the fee within the time frames required;
- (b) a person is experiencing "non-financial hardship" where he or she is unable to attend to his or her personal affairs for a period of time due to circumstances beyond his or her control.

**5 Applications to the Secretary for review of an ambulance fee**

(1) A person may make an application to the Secretary for review of an ambulance fee under section 67Y (1) of the Act by making a submission in writing to the Secretary or the Secretary's lawfully authorised delegate.

- (2) An application under (1) must include the following supporting information or evidence:
- (a) in the case of an application on the basis of financial hardship:
    - (i) proof of identity,
    - (ii) a statement in support of the application,
    - (iii) recent bank statements,
    - (iv) income tax assessment notice for the most recent financial year
  - (v) information about any income received by the applicant for the 8 week period prior to making the application to the Secretary, including:
    - A. employment income – wages, salary and self employment income
    - B. rental income,
    - C. income from financial investments such as bank accounts, interest bearing deposits and fixed term deposits,
    - D. income from income stream products such as allocated pensions, annuities and superannuation pensions,
    - E. financial support from the Australian Government, such as the disability support pension or rent assistance and includes subsidies and allowances allocated for specific purposes,
    - F. funds, compensation or like lump sum payments held in trust on behalf of the individual,
  - (b) in any other case, a written statement in support of the application including any relevant information and documentation,
  - (c) any further information or documentation reasonably requested by the Secretary or lawfully authorised delegate.

#### SUPREME COURT PRACTICE NOTE SC EQ 12

##### Real Property List

###### Commencement

1. This Practice Note was issued on 20 May 2015 and commences on 1 June 2015.

###### Introduction

2. The objective of the Real Property List in the Equity Division (the List) and this Practice Note is to facilitate the prompt and efficient resolution of the real issues in dispute in Real Property Matters.
3. Real Property Matters are proceedings involving claims in respect of land or interests in land, including claims:
  - (a) in respect of contracts for the sale of land;
  - (b) in respect of leases of land;
  - (c) in respect of easements or covenants over land;
  - (d) pursuant to or in relation to the provisions of statutes relating to real property including the *Real Property Act 1900* (NSW), the *Conveyancing Act 1919* (NSW), the *Crown Lands Act 1989* (NSW) and the legislation governing the creation and management of strata schemes and community schemes.
4. Real Property Matters do not include proceedings in, or to be commenced in the Possession List in the Common Law Division.
5. All proceedings in the List will be case managed by the Real Property List Judge (the List Judge).

###### Application

6. This Practice Note applies to new and existing Real Property Matters that are entered in the List.
7. The Court may, if it is satisfied that it is appropriate to do so, order that proceedings be entered in or removed from the List.

###### Case Management

8. Any Summons or Statement of Claim in relation to a Real Property Matter must record on the front sheet that it is in the Real Property List. The Court encourages electronic filing of all pleadings and affidavits.
9. All Real Property Matters will be allocated a first return date before the List Judge on a Friday. The first listing date shall be not less than 21 days, nor more than 35 days after the date of the filing of the Summons or the Statement of Claim.
10. It is expected that on the first return date the legal representatives for the respective parties will be in a position to clearly identify the real issues that will be

in dispute and to provide to the Court an agreed regime for preparing the matter for trial, including reference to mediation at a suitable time.

11. Directions hearings will be listed before the List Judge on Fridays at 9.15 am.
12. Interlocutory applications are not encouraged. Motions may not be filed without the leave of the List Judge. Any Motions for which leave is granted will be listed before the List Judge on a Friday not before 10.15 am.
13. Practice Note SC Eq 5 (Expert Evidence) and Practice Note SC Eq 11 (Disclosure) apply to proceedings in the List. Practice Note SC Eq 1 (Case Management) does not apply to proceedings in the List.
14. Any urgent application in Real Property Matters must be made by arrangement with the List Judge's Associate to obtain a suitable time for the hearing of the application.
15. When proceedings are listed for final hearing, the Court will generally make the Usual Order for Hearing set out in Annexure A.
16. Consent orders will be made by the List Judge in Chambers on days other than Friday by application in writing to the List Judge's Associate.
17. If proceedings settle prior to hearing, the orders disposing of the proceedings will be made by the List Judge (including in Chambers). Any Terms of Settlement and/or Notices of Discontinuance should be filed with the List Judge's Associate.

- the entitlement of certain persons to access adoption information
- classes of reviewable decisions.

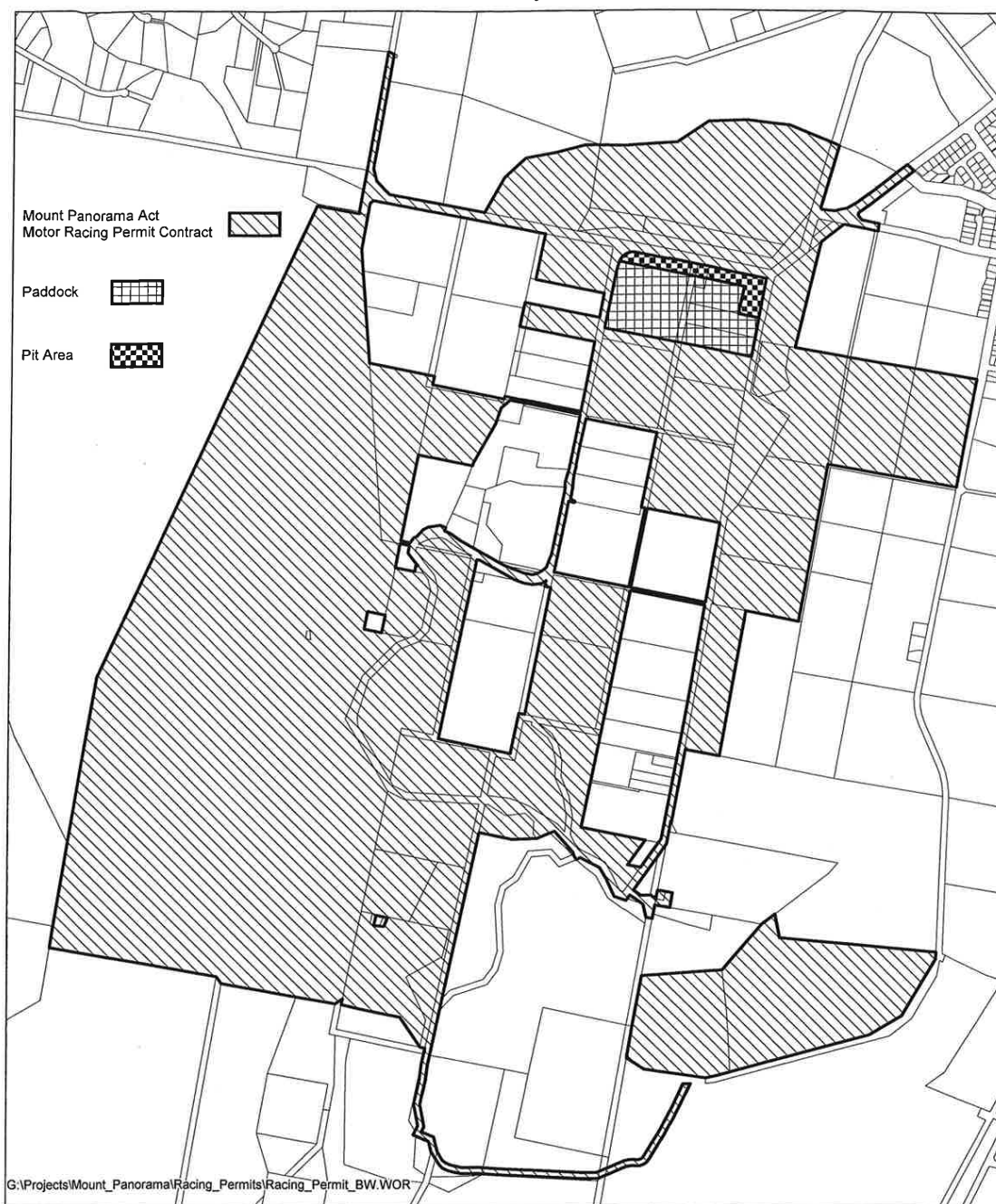

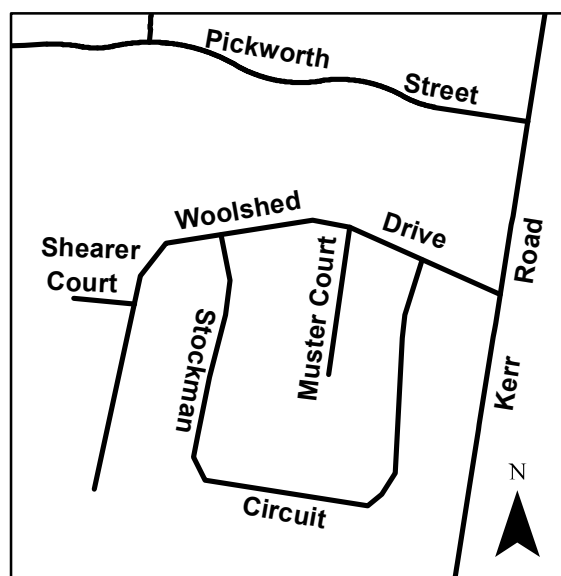
