PROTECTION OF THE ENVIRONMENT OPERATIONS (WASTE) REGULATION 2014

Notice of Exemption from Clause 79: Reporting on
Transportation of Asbestos Waste Solely
Within New South Wales

I, Rob Hogan, Acting Director Waste and Resource Recovery, Environment Protection Authority, grant an exemption to any transporter or recipient of a load of asbestos waste from clause 79 of the *Protection of the Environment Operations (Waste) Regulation 2014* in relation to asbestos contaminated soil.

This exemption only applies to:

- excavated soil contaminated with asbestos waste; and
- soil contaminated with asbestos waste prior to excavation.

In this Exemption:

Asbestos contaminated soil means soil that is contaminated with asbestos waste and that consists predominantly of soil.

This exemption is granted under clauses 79 (7) and 91 of the *Protection of the Environment Operations (Waste) Regulation 2014*. Words and expression used in this exemption have the same meaning as they have in the *Protection of the Environment Operations Act 1997* and the *Protection of the Environment Operations (Waste) Regulation 2014*.

This exemption has effect on and from the date that it is published in the Government Gazette to 31 August 2016 inclusive.

PROTECTION OF THE ENVIRONMENT OPERATIONS (WASTE) REGULATION 2014

Notice of Exemption from Clause 76: Reporting on
Transportation of Waste Tyres Solely
Within New South Wales

I, Stephen Beaman, Director Waste and Resource Recovery, Environment Protection Authority, grant an exemption to any consignor or transporter of waste tyres, or occupier of any premises to which a load of waste tyres is delivered, from clause 76 of the *Protection of the Environment Operations (Waste) Regulation 2014* in relation to the transportation of waste tyres:

- from their place(s) of generation to a tyre retail outlet, without being unloaded at any intermediary facility or other premises or location, for sale as seconds or for storage as run outs, or
- to a tyre retail outlet from their place(s) of generation for temporary storage prior to transportation to a waste facility for disposal or recycling, or
- from their place(s) of generation to a retreader for recovery and resale as retreads.

In this Exemption:

- **place of generation** means the premises or other location at which the waste tyre(s) were generated
- **retreader** means a premises where the only tyre or waste related activity is retreading tyres or waste tyres for recovery and resale as retreads
- **run-outs** are waste tyres that are partially worn, which are received by a tyre retail outlet from a customer, and stored by that tyre retail outlet for future use by that customer
- **seconds** are waste tyres, other than run-outs, that are partially worn and are stored by a tyre retail outlet for future re-sale to a customer
- **temporary storage** means the storage of waste tyres for no more than 6 weeks
- **tyre retail outlet** means a site at which the part of the business undertaken is the removal of tyres from vehicles and sale of new tyres to customers

This exemption is granted under clauses 76 (8) and 91 of the *Protection of the Environment Operations (Waste) Regulation 2014*. Words and expression used in this exemption have the same meaning as they have in the *Protection of the Environment Operations Act 1997* and the *Protection of the Environment Operations (Waste) Regulation 2014*.

This exemption has effect on and from the date that it is published in the Government Gazette.
