## CHARITABLE TRUSTS ACT 1993

### ORDER UNDER SECTION 13

#### CY PRÈS SCHEME RELATING TO THE ESTATE OF THE LATE EMILY CLAUGHTON

Section 9(1) of the *Charitable Trusts Act 1993* permits the application of property cy près where the spirit of the original trust can no longer be implemented.

Section 13 (1)(c) of the *Charitable Trusts Act 1993* allows the Attorney General to establish a scheme in accordance with a referral from the Court under subsection (2) of that Act.

The trustees of the estate of the late Emily Claughton have applied to the Attorney General seeking that he establish a scheme under section 12 of the *Charitable Trusts Act 1993*.

Sub clauses 5(d) and 5(e) in the Will of Ms Claughton bequeathed one thousand pounds upon trust to invest and pay the income thereof to the Ladies Benevolent Society at Hay and the Ladies Benevolent Society at Echuca, for the purposes of each respective Society. The value of the two trusts amounted to a corpus of \$4000 in total which earned a net income of \$55.70 for the financial year ended 30 June 2016.

The Will, in clause 6, bequeathed the residue of the estate to be held on trust with the residue to be applied:

‘towards the maintenance and support of any Hospital or Benevolent Institutions now or hereafter provided and maintained by the Church of England or Presbyterian Church in the States of New South Wales and Victoria as my Trustees shall think fit’.

On 20 May 1930, the Supreme Court, in proceedings 8440/1930, established a scheme in relation to clause 6 on the grounds that it was expedient and necessary for the administration of the trust ‘that the ambit of the powers affecting the distribution of the income of the said Residuary Trust Fund conferred by the said Will on the Trustees of the said trust should be defined’. The balance of the corpus of the residue fund for the financial year ended 30 June 2016 was \$243,021.80 and the total net income was \$24,185.51.

As delegate of the Attorney General, I have formed a view that all three bequests in the Will are trusts for a charitable purpose. It is apparent that a cy près scheme is required for the gifts made to the Ladies’ Benevolent Societies at Hay (which is no longer in existence) and Echuca (which has changed its name, legal status and purposes). The funds that were applied to the Ladies’ Benevolent society at Hay were applied, when it ceased to function, to a new committee which was formed in 2009, known as the Hay Community Fund. This Fund was wound up in approximately 2013, and all the funds transferred to the organisation ‘Can Assist’, which is an organisation which raises funds to assist persons in the Hay community with cancer.

The Echuca Ladies’ Benevolent Society is now the Echuca Benevolent Society Incorporated and operates as the Echuca Community for the Aged (‘ECA’). Its purposes are more focussed on aged care than were those of the original Society. However, the ECA’s purposes are still charitable purposes, namely, assistance to the needy.

In respect of the gift of the residue of the estate, it is no longer possible to apply the fund for the purposes set out in the Court ordered scheme (proceedings 8440/1930) because the institutions that were previously entitled to receive the funds have gradually ceased to provide their services or facilities exclusively for ex-servicemen and women, necessitating an application of the fund cy près. The two nominated bodies for the application of the funds are the Anglican Retirement Villages Diocese of Sydney Foundation for Aged Care and the Presbyterian Church (New South Wales) Property Trust, for the purpose of maintenance and support of aged care programs. These organisations have a stronger aged care focus than was present in the original bequest purpose, but they are as close as possible to the original purposes and therefore are appropriate organisations for the cy près application of the funds.

I consider that the original charitable purpose has failed and that this is an appropriate matter in which the Attorney General should approve a cy près scheme under section 12(1)(a) of the *Charitable Trusts Act 1993* in respect of the three bequests in the Will of Emily Claughton. The scheme would apply, cy près, the corpus the subject of the following trusts in the Will:

- (a) In relation to the gift in cl. 5(e) of the Will, \$2,000 to be applied to the 'Echuca Benevolent Society Incorporated' ABN 20 851 915 039 (trading as 'Echuca Community for the Aged'); and
- (b) In relation to the gift in cl. 5(d) of the Will, \$2,000 to be applied to the Hay Branch of Can Assist (Cancer Patients Assistance Society of New South Wales) ABN 76 000 412 715 for the benefit of residents of the town of Hay in New South Wales; and
- (c) In relation to the gift in cl. 6 of the Will, constituting the residue of the estate, to be applied in equal portions to:
  - (i) The Anglican Retirement Villages Diocese of Sydney Foundation for Aged Care ABN 24 086 334 058 for the purpose of maintenance and support of that Foundation's Aged Care programs; and
  - (ii) The Presbyterian Church (New South Wales) Property Trust for the purpose of supporting and maintaining benevolent institutions run by Presbyterian Aged Care ABN 70282579844.

The above scheme was advertised by way of Notice in the New South Wales Government Gazette on 13 October 2017. As no representations have been received within one month following that publication, I now hereby Order the establishment of the scheme.

This Order will take effect 21 days after its publication in the Government Gazette, in accordance with section 16(2) of the *Charitable Trusts Act 1993*.

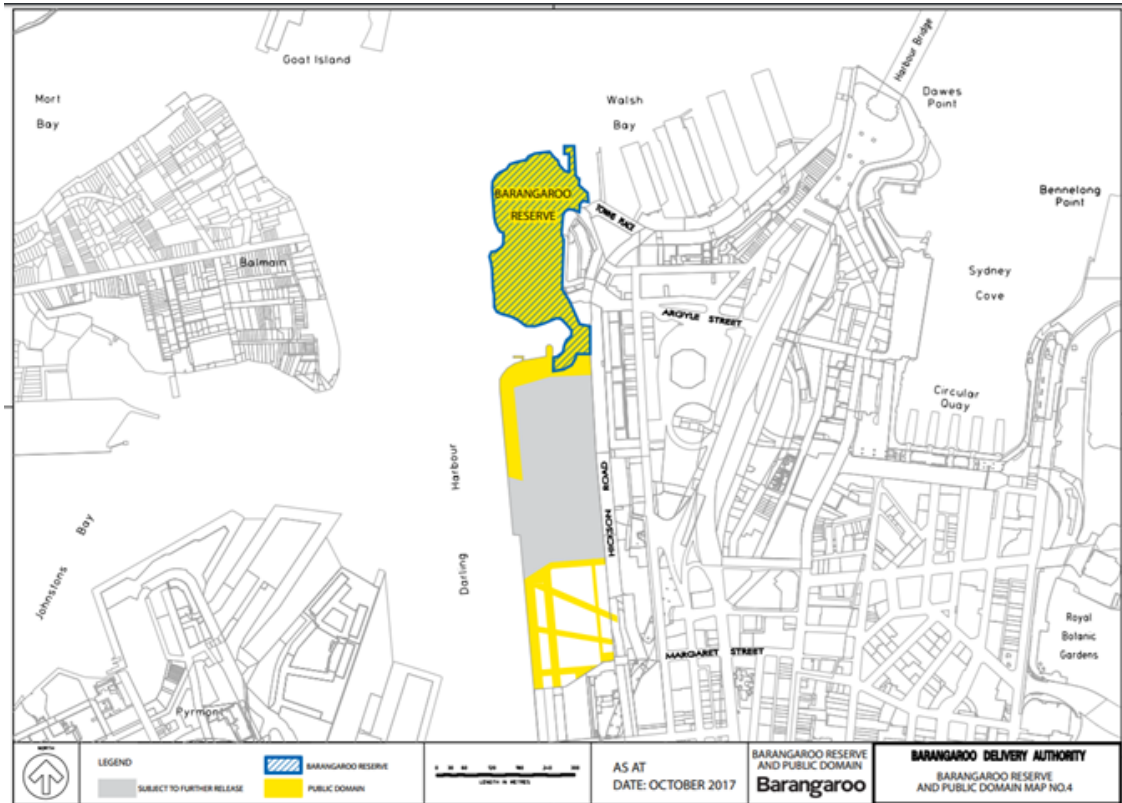

**1. DEFINITIONS AND INTERPRETATION**

**Acquisition Notice** means the acquisition notice in respect of this lease published in the Government Gazette.

**Business Day** means any day other than:

- (a) a day that is a Saturday, Sunday or public holiday generally in Sydney; or
- (b) 27, 28, 29, 30 or 31 December.

**Claim** means any claim, action, demand or proceeding for payment of money (including damages):

- (a) under, arising out of, or in any way in connection with, this lease; and
- (b) otherwise at law including:
  - (i) under or for breach of any statute;
  - (ii) in tort for negligence or otherwise, including negligent misrepresentation; or
  - (iii) for restitution, including restitution based on unjust enrichment.

**Commencing Date** means the date shown as the "Commencing Date" in Item 2 of the Reference Schedule.

**Contractor** means the contractor or contractors, as the case may be, engaged by TfNSW from time to time to carry out the Works.

**Government Authority** includes any governmental or semi-governmental or local government authority, administrative or judicial body or tribunal, department, commission, public authority, agency, Minister, officer, statutory corporation or instrumentality.

  - (ii) **person** includes an individual, the estate of an individual, a corporation, an authority, an association or a joint venture (whether incorporated or unincorporated), a partnership and a trust;
  - (iii) a reference to a party includes that party's executors, administrators, successors and permitted assigns, including persons taking by way of novation and, in the case of a trustee, includes a substituted or an additional trustee;
  - (iv) a reference to a document (including this lease) is to that document as varied, novated, ratified or replaced from time to time;
  - (v) a reference to a statute includes its delegated legislation and a reference to a statute or delegated legislation or a provision of either includes consolidations, amendments, re-enactments and replacements;
  - (vi) a word importing the singular includes the plural (and vice versa), and a word indicating a gender includes every other gender;
  - (vii) a reference to a party, clause, schedule, exhibit, attachment or annexure is a reference to a party, clause, schedule, exhibit, attachment or annexure to or of this lease, and a reference to this lease includes all schedules, exhibits, attachments and annexures to it;
  - (viii) if a word or phrase is given a defined meaning, any other part of speech or grammatical form of that word or phrase has a corresponding meaning;
  - (ix) **includes** in any form is not a word of limitation;
  - (x) a reference to **\$** or **dollar** is to Australian currency; and
  - (xi) terms defined in the GST Law have the same meaning in this document unless the context otherwise requires.
  - (xii) if a party is a member of a GST group, references to GST which the party must pay and to input tax credits which the party is entitled to claim include GST which the representative member of the GST group of which the party is a member must pay and input tax credits to which the representative member is entitled.

1.3 **Business Day**

If the day on or by which anything is to be done under this lease is not a Business Day, that thing must be done no later than the next Business Day.

1.4 **Excluding liability**

Any provision of this lease which seeks to limit or exclude a liability of a party is to be construed as doing so only to the extent permitted by law.

1.5 **Exclusion of implied covenants and powers**

The covenants and powers implied by section 84, section 84A, section 85, section 86, section 132, section 133, section 133A and section 133B of the *Conveyancing Act 1919* (NSW) do not apply to this lease.

2. **TFNSW'S OBLIGATIONS**

2.1 **Permitted Use**

TfNSW must use the Premises only for the Permitted Use.

2.2 **Utilities and services**

TfNSW must pay all costs for the supply of any services consumed by it on the Premises during the Term.

2.3 **Handover obligations**

- (a) On or before the end of the Term, TfNSW will:
- (i) vacate the Premises and remove from the Premises all its property, scaffolding, loose materials, waste and rubbish;
  - (ii) return the Premises to the Landlord:
    - (A) with the stairway located between Elizabeth Street and Castlereagh Street, Sydney, at the Commencing Date removed and the surface of the Premises made good;
    - (B) to the standard and finish equivalent to the area immediately adjacent to the stairway that was removed pursuant to clause 2.3(a)(ii)(A) as at the Commencing Date or as otherwise agreed by the parties; and
    - (C) in a condition that satisfies the requirements of any consent or approval granted under the *Environmental Planning and Assessment Act 1979* in respect of the Works that apply to the Premises; and
  - (iii) subject to clauses 2.3(c) and 2.3(d), ensure that any damage caused to the Premises by the carrying out of the Works is made good or repaired.
- (b) If the parties have entered into a further lease for the Premises which commences immediately after the end of the Term, then clause 2.3(a) will apply at the end of the term of the further lease.
- (c) The obligation in clause 2.3(a)(iii) does not apply to the extent of any damage caused by or contributed to by:

- (i) any act of the Landlord or its employees, agents or contractors, or any negligence for which the Landlord is responsible; or
  - (ii) the act or omission of a third party, unless that third party is one of TfNSW's Agents.
- (d) The Landlord and TfNSW acknowledge and agree that:

**3. COMPLIANCE WITH LEGISLATIVE AND WHS REQUIREMENTS**

TfNSW must, and must procure that the Contractor will, at all times fully comply with all Legislative Requirements in any way affecting or applicable to the Works.

**3.2 Principal Contractor**

- (a) In this clause 3.2, the terms "construction work", "construction project", "principal contractor" and "workplace" have the same meanings given to those terms under the WHS Legislation.
- (b) Without limiting TfNSW's obligations under any other provision of this lease:
  - (i) to the extent that the work under this lease or any contract or subcontract relating to the Works includes construction work, TfNSW:
    - (A) is, for the purpose of Chapter 6 of the WHS Regulation, a person conducting a business or undertaking that has commissioned the construction project(s) that form the whole or part of the work under this lease, the contract or subcontract;
    - (B) will engage the Contractor (as notified to the Landlord by TfNSW) in accordance with clause 293(2) of the WHS Regulation as the principal contractor for the work under this lease, the contract or subcontract; and
    - (C) will authorise the Contractor to have management and control of each workplace at which the work under this lease, the contract or subcontract is to be carried out and to discharge the duties of a principal contractor under the WHS Legislation; and
  - (ii) TfNSW will procure that the Contractor accepts the engagement as principal contractor and agrees to discharge the duties imposed on a principal contractor by the WHS Legislation,

and the Contractor's engagement and authorisation as a principal contractor will continue:

- (iii) subject to clause 3.2(b)(iv), until completion of the works (unless sooner revoked by TfNSW); and
- (iv) in respect of any rectification of defects that is construction work, during the period any such work is carried out.

3.3 **Work Health and Safety**

TfNSW must carry out any works on the Premises;

- (a) safely and in a manner that does not put the health and safety of persons at risk; and
- (b) in a manner that protects property.

4. **QUIET ENJOYMENT AND RIGHTS OF INSPECTION**

Subject to TfNSW complying with its obligations under this lease, TfNSW may occupy the Premises during the Term without interference from the Landlord.

5. **RISK AND INDEMNITY**

- (a) TfNSW enters, occupies, uses and keeps the Premises, and TfNSW's Agents are permitted to access, occupy, use and keep the Premises, at the risk of TfNSW.

- (b) TfNSW must indemnify the Landlord against:

- (i) the loss, destruction or damage of any of the Landlord's real or personal property; or

- (ii) any Claim against the Landlord or liability the Landlord may have to third parties in respect of or arising out of or in connection with:

- (A) any illness, personal injury to, or death of, any person; or

- (B) the loss, destruction or damage of any real or personal property,

to the extent caused by, arising out of, or in any way in connection with, the construction of the Works or any failure by TfNSW to comply with its obligations under this lease, except to the extent caused or contributed to by the act or omission of the Landlord or the Landlord's employees, agents, contractors or officers.

- (c) TfNSW has no liability, nor will the Landlord be entitled to make any Claim against TfNSW or TfNSW's Agents in respect of:

- (i) loss of income, loss of revenue, loss of profit, loss of financial opportunity, loss of business or loss of business opportunity, loss of contract, loss of goodwill, loss of use or loss of production (whether the loss is direct or indirect); or

- (ii) direct or indirect financing costs,

whether present or future, fixed or unascertained, actual or contingent incurred or sustained by the Landlord as a result of any act or omission of TfNSW (whether negligent or otherwise).

6. **GST**

6.1 **Payment of GST**

If GST is or will be payable on a supply made under or in connection with this document, to the extent that the consideration otherwise provided for that supply under this document is not stated to include an amount in respect of GST on the supply:

- (a) the consideration otherwise provided for that supply under this document is increased by the amount of that GST; and
- (b) the recipient must make payment of the increase as and when the consideration otherwise provided for, or relevant part of it, must be paid or provided or, if the consideration has already been paid or provided, within seven days of receiving a written demand from the supplier.

6.2 **Tax invoice/adjustment note**

The right of the supplier to recover any amount in respect of GST under this document on a supply is subject to the issuing of the relevant tax invoice or adjustment note to the recipient within the time period within which the recipient is otherwise entitled to the relevant input tax credits.

6.3 **Change in the GST Law**

If the GST Law changes (including without limitation as a result of a change in the GST rate) after the date of this document, any consideration that expressly includes GST must be adjusted to reflect the change in the GST Law.

6.4 **Indemnities and reimbursement**

- (a) Costs actually or estimated to be incurred or revenue actually or estimated to be earned or lost by a party that is required to be reimbursed or indemnified by another party or used as the basis for calculation of consideration for a supply under this document must exclude the amount of GST referable to the cost to the extent to which an entitlement arises or would arise to claim an input tax credit and in relation to revenue must exclude any amount in respect of GST referable to the revenue.
- (b) The parties each indemnify the other against all GST, and losses, liabilities and expenses (including legal liabilities on a full indemnity basis) that the other incurs (directly or indirectly) as a result of a breach of a warranty or other provision in this document relating to GST.

7. **FURTHER LEASE**

7.1 **Parties to negotiate**

If TfNSW gives the Landlord a notice before the Terminating Date that it requires a further lease over the Premises for the purposes of the Project, the parties will negotiate in good faith to agree the terms of that further lease.

7.2 **Holding over**

If the Landlord has not granted TfNSW a new lease of the Premises as contemplated under clause 7.1 and TfNSW continues to occupy the Premises after the Terminating Date with the Landlord's consent, TfNSW occupies the Premises under a monthly lease that:

- (a) either party may terminate on 1 month's notice ending on any day by giving notice in writing to the other; and
- (b) is on the same terms as this lease (with any changes appropriate to a monthly lease).

8. **TERMINATION**

- (a) TfNSW may terminate this lease at any time during the Term by giving the Landlord one month's prior written notice specifying the date that the lease will come to an end (the **Surrender Date**).

- (b) With effect from but not including the Surrender Date:
  - (i) TfNSW, as beneficial owner, surrenders TfNSW's interest in this lease and the Premises to the Landlord; and
  - (ii) the Landlord accepts that surrender.
- (c) On or before the Surrender Date, TfNSW must leave the Premises and return the Premises to the Landlord in the condition required by clause 2.3.
- (d) With effect from the Surrender Date, each party releases the other from any liability relating to events or circumstances occurring or arising after the Surrender Date.

9. **GENERAL**

9.1 **Governing law**

This lease is governed by and must be construed according to the law applying in New South Wales.

9.2 **TfNSW and the Landlord as public authorities**

The Landlord and TfNSW acknowledge and agree that nothing in this lease will in any way unlawfully restrict or otherwise unlawfully affect the unfettered discretion of either of TfNSW or the Landlord to exercise any of its functions and powers pursuant to any legislation.

## Practice Note No. SC CA 1

### Court of Appeal

- 1 This Practice Note was issued on 13 December 2017 and commences on 1 January 2018. It replaces the previous Practice Note issued on 27 March 2009.
- 2 The procedural rules for appeals are contained in Part 51 of the Uniform Civil Procedure Rules 2005 (NSW) (UCPR). All parties to proceedings in the Court of Appeal are required to comply with the requirements of the rules which contain detailed provisions governing appeals. The procedural rules for judicial review are contained in Part 59 of the UCPR. This practice note makes additional provision for the preparation and conduct of proceedings in the Court of Appeal.

#### LEAVE TO APPEAL

- 3 Appeals from the Supreme Court, District Court, Dust Diseases Tribunal and the Workers Compensation Commission are subject to monetary limits. Where the subject matter is less than the statutory amount, parties must seek leave to appeal. Where the subject matter of an appeal is not a monetary sum or the matter at issue amounts to the value of less than \$100,000, parties must seek leave to appeal: s 101(2)(r) *Supreme Court Act 1970* (NSW).

#### CONCURRENT HEARING OF LEAVE APPLICATION AND APPEAL

- 4 The Court will determine whether to decide the question of leave at a separate hearing, or concurrently with the substantive appeal.
- 5 Each party should indicate in the summary of argument whether (and if so why) the matter is thought appropriate for a concurrent hearing: UCPR, r 51.12(4)(g). In particular, it should address the following matters:
  - (1) the extent to which the argument on the application for leave is expected to canvas the merits of the appeal;
  - (2) the extent to which the application for leave will require reference to materials which would be relevant to the appeal;
  - (3) whether the appeal will involve an issue of public importance;
  - (4) any prejudice which may be suffered as a result of delay flowing from a separate leave application; and

- (5) any matter relevant to the reason why leave is required in the circumstances of the case.
- 6 Parties will be advised as to whether a summons for leave to appeal will proceed by way of a leave only hearing or will be heard concurrently with the appeal by the Registrar, usually at the first directions hearing.
- 7 If a summons for leave to appeal is to be heard concurrently with the appeal, the Registrar will determine whether appeal books are to be filed or whether the White Book will be sufficient to constitute the appeal books.

## MANAGEMENT OF PROCEEDINGS

### (a) Interlocutory applications

- 8 Unless otherwise ordered, an interlocutory application will be listed at 9.00am in the motion list before the Registrar on a Monday. The parties should expect that the application will proceed to a hearing on the return date. Where an application has resolved or will not proceed, the Registrar should be promptly advised by email.
- 9 Applications for the following may be dealt with by the Registrar: consent orders, extensions of time, competency of appeals, security for costs and non-compliance with directions.
- 10 The following applications will be assigned to the Referrals Judge for hearing:
- (1) expedition of the hearing of proceedings (where there is no consent);
  - (2) contested applications for stay or injunction; and
  - (3) other matters as determined by the Registrar.

### (b) Case management

- 11 Parties to an appeal from the Commercial List and Corporations List should be prepared at the first directions hearing to be allocated a hearing date accompanied by a timetable.
- 12 A hearing date will be allocated for all other appeals by the Registrar having regard to the readiness of the matter. Parties should be in a position to accept a hearing date no later than the second directions hearing.

### (c) Expedition

- 13 Expedition may be sought at a directions hearing, on an application for a stay or when leave to appeal is granted.

- 14 If an opposing party does not object to an appeal being expedited, it should promptly email the Registrar of the Court of Appeal to notify their non-objection.
- (d) Extensions of time: appeals, summons seeking leave to appeal, summons for judicial review**
- 15 An application for an extension of time to lodge an appeal or a summons will generally be heard concurrently with the hearing of the appeal or summons.

#### **MATTERS OF WHICH THE COURT MUST BE INFORMED**

**(a) Amendments to grounds of appeal**

- 16 If substantial grounds of appeal are abandoned prior to the hearing, the other parties and the Court should be informed immediately. If a party seeks to add to the grounds of appeal and those additions are not consented to a notice of motion seeking leave to rely upon the amended grounds must be filed.

**(b) Challenges to earlier decisions of the Court of Appeal or other intermediate appellate courts**

- 17 A party who proposes to seek leave to challenge the correctness of a decision of the Court of Appeal or of another Australian intermediate appellate court should notify the Registrar in writing by letter or email at the earliest opportunity, and no later than **6 weeks** prior to the hearing date. The letter should indicate the decision(s) likely to be challenged and their materiality to the notifying proceedings.

#### **PREPARING MATERIALS FOR COURT**

**(a) Appeal books**

- 18 Appellants are encouraged to file one of the four copies of the appeal books (the court copies) electronically. Acceptable forms of electronic delivery include a DVD or USB or as otherwise directed by the Court or the Registrar. Email is not an acceptable form of electronic delivery.
- 19 If the court copy of the appeal books is delivered electronically, appellants must file in hard copy 3 copies of each of the red, black, blue and orange books or such additional number of appeal books as is directed by the Registrar.
- 20 If a DVD or USB is the mode of electronic delivery, the DVD or USB must be placed inside a sealed A4 envelope. The envelope should clearly state the matter name, the matter number, and a list of the books that are contained on the DVD or USB. In addition, the DVD or USB should *itself* be labelled with the matter number (and matter name where practicable).
- 21 If the court copy of the appeal book is delivered electronically, each appeal book (red, orange, black and blue) should be saved as a separate PDF file. Where an

appeal book is separated into multiple volumes, the party should include a separate PDF file for each volume.

- 22 If an electronic version of the appeal books is used, the documents uploaded must be in text searchable format (i.e, by way of optical character recognition (OCR) or similar).
- 23 Parties to an appeal are encouraged to liaise in relation to the provision to the other of an electronic version of the appeal books, either in addition to or substitution for hard copies as they may agree.

**NOTE:** These provisions of the practice note apply to a respondent who undertakes responsibility for filing the appeal books or files any supplementary book.

**(b) Written submissions**

- 24 If used, footnotes in the written submissions are only to be used for citing references.
- 25 In written submissions, references to the judgment below should be to paragraph numbers. Reference may also be made to the page number of the red book. References to the transcript should note the page number of the black book and the line number of the relevant passage.

**(c) Chronology**

- 26 The chronology should be an objectively correct statement of “the principal events leading up to the litigation” and should not be a chronology merely of those matters of assistance to one party or the other: *Woods v Harwin* [1993] NSWCA 291. The chronology should also include key events in the litigation, such as the commencement of the proceedings in the court below. Reference should be made to the Red, Blue and Black books. The following is the suggested form for chronologies:

**(d) List of authorities: appeals, concurrent hearings and Judicial Review**

- 27 No later than **10:00 AM** on the business day before the hearing, each party must supply a list of authorities. A template list of authorities is available [here](#).

- 
- 28 The list should be supplied via email to the President's Researcher: [coa.researcher@courts.nsw.gov.au](mailto:coa.researcher@courts.nsw.gov.au), and should be in word document or text searchable format.
- 29 Where email facilities are not available, four copies must be lodged in the authorities' box provided on level 12 of the Supreme Court building.
- 30 The list of authorities must identify:
- (1) any Commonwealth or New South Wales statutes, identifying the relevant reprint or date and relevant sections;
  - (2) any legislation from other jurisdictions;
  - (3) cases from which passages will be read in the course of oral submissions, being:
    - (a) cases reported in the CLRs and NSWLRs (maximum 10 without leave);
    - (b) up to five cases from other reports;
    - (c) other cases, whether reported or unreported; and
  - (4) cases to be cited but not read in oral submissions.
- 31 The party providing the list of authorities must place their name and contact details (including email and telephone number) at the foot of the list.
- 32 Where a party intends to rely on:
- (1) legislation from other jurisdictions;
  - (2) cases not reported in the CLRs or NSWLRs; or
  - (3) other secondary sources (eg sections of textbooks or second reading speeches),
- the party must lodge four copies of each authority in the authorities' box on level 12 of the Supreme Court Building, by **10:00 AM** on the business day before the hearing. Where it is impractical to provide the entire authority, the relevant section or chapter should be provided.
- 33 If a party decides to read from a case not included in its list of authorities, copies are to be provided to the Court at the hearing. For reported cases, only the headnote and relevant passage are to be copied.

**NOTE:** A separate list of authorities is not required for leave only hearings.

## **JUDICIAL REVIEW**

- 34 Judicial review invokes the Court's supervisory jurisdiction over an inferior court or tribunal. Note that where a matter is heard on appeal from the Local Court to the District Court, there is no appeal from the District Court to the Court of Appeal. Parties must proceed by way of judicial review.
- 35 The Court or Tribunal whose decision is to be judicially reviewed must be joined as a respondent in the summons for judicial review, and should be listed as the last party on the summons.
- 36 In judicial review proceedings in relation to matters under the *Children and Young Persons (Care and Protection) Act 1998* (NSW), an independent legal representative should not be joined as a party.

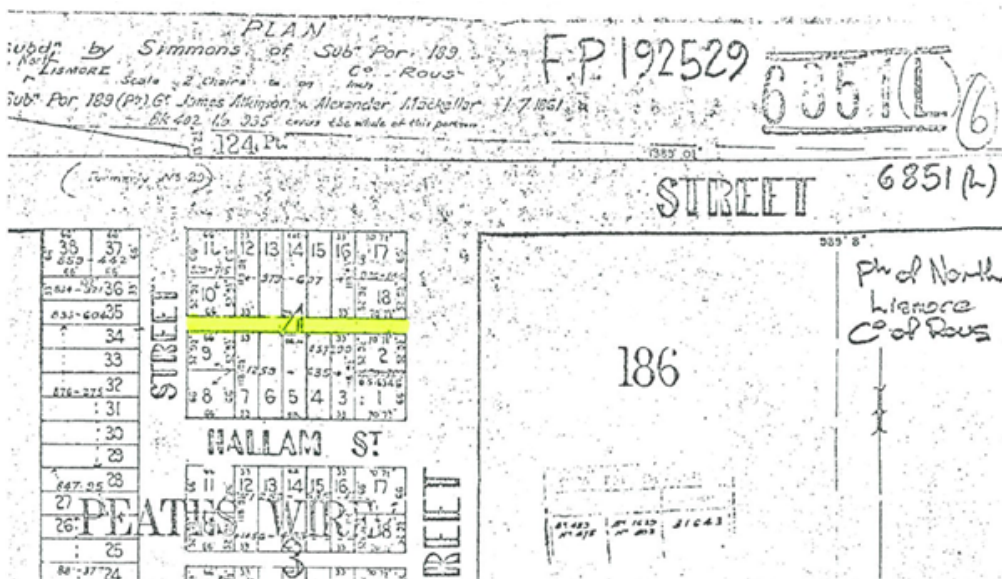
