PROTECTION OF THE ENVIRONMENT OPERATIONS (WASTE) REGULATION 2014

Notice of Exemption from Clause 79:

Reporting on transportation of asbestos waste solely within New South Wales

I, Stephen Beaman, Executive Director Waste and Resource Recovery, Environment Protection Authority, grant an exemption to any transporter or recipient of a load of asbestos waste from clause 79 of the *Protection of the Environment Operations (Waste) Regulation 2014* in relation to asbestos contaminated soil.

This exemption only applies to:

- excavated soil contaminated with asbestos waste; and
- soil contaminated with asbestos waste prior to excavation.

In this Exemption:

Asbestos contaminated soil means soil that is contaminated with asbestos waste and that consists predominantly of soil.

This exemption is granted under clauses 79(7) and 91 of the *Protection of the Environment Operations (Waste) Regulation 2014*. Words and expression used in this exemption have the same meaning as they have in the *Protection of the Environment Operations Act 1997* and the *Protection of the Environment Operations (Waste) Regulation 2014*.

This exemption has effect on and from the date that it is published in the Government Gazette to 30 September 2017 inclusive.

Richmond River – Between the areas of the Coraki Boat ramp downstream rounding near the locality of the Woodburn NSW, within an area bounded by:

- The Coraki Boatramp at the confluence of the Richmond and Wilson's River, then
- Downstream a distance of approximately twenty kilometres,
- The event rounding at a buoyed area approximately one kilometre upstream of the Woodburn Bridge.

Detail

Competitive water ski racing will be conducted on the waters of the upper reaches of the Richmond River-Coraki – as specified above – involving the use of high speed power vessels which will be active in the area on both days during the above times.

There will also be support vessels on the water to manage the event. Competing vessels with skiers will race at high speed which will present a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** for the course is specified during the event, which will be marked by buoys at the location specified above.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will also be patrolled by Roads and Maritime and Police patrol vessels.

All vessel operators and persons using the waters of Richmond River, Coraki should keep a proper lookout, keep well clear of competing and support vessels, and exercise extreme caution.

Transit lane

Provision may be made (where necessary) for a patrol vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to section 12(3) of the Act, vessels using the transit lane must do so at a speed not exceeding 4 knots, must produce minimal wash, and must comply with any direction given.

This Order is the *Plant Diseases (Tomato Potato Psyllid) Order 2017*.

2 Commencement

This Order commences on the date it is published on the Department's internet website.

3 Definitions

In this Order:

APVMA means the Australian Pesticides and Veterinary Medicines Authority.

Convolvulaceae host plant material means any plant or part of a plant (including fruit and vegetables) belonging to the Convolvulaceae family.

host plant material means Convolvulaceae host plant material and Solanaceae host plant material.

Plant Health Certificate means a document (known as a Plant Health Certificate) issued by:

- (a) an inspector or a person authorised under section 11(3) of the Act; or
- (b) a person authorised to issue such a certificate under a law of another State or Territory that relates to plant biosecurity.

planting media means soil or growing media that has contained host plant material and is from a State or Territory in which tomato potato psyllid has been detected or is suspected to be present.

secure conditions means one of the following:

- (a) unvented packages; or
- (b) vented packages with the vents secured with gauze or mesh with a maximum aperture of 1.0mm; or
- (c) fully enclosed under tarpaulins, hessian, shade cloth, mesh or other covering which provides a maximum aperture of 1.0mm; or
- (d) fully enclosed or screened buildings, rooms, vehicles or other facilities free from gaps or other entry points greater than 1.0mm.

Solanaceae host plant material means any plant or part of a plant (including fruit and vegetables) belonging to the Solanaceae family.

the Act means the *Plant Diseases Act 1924*.

tomato potato psyllid means the pest *Bactericera cockerelli*.

used agricultural machinery means any machinery or equipment that has been used in the growing, handling, harvesting or processing of host plant material in a State or Territory in which tomato potato psyllid has been detected or is suspected to be present.

used packaging means any covering or packaging that has contained host plant material grown in a State or Territory in which tomato potato psyllid has been detected or is suspected to be present.

Note: *covering or package, fruit, inspector, pest, plant* and *vegetable* have the same meaning as in the Act.

4 Prohibition on the introduction of tomato potato psyllid

Pursuant to section 4(1) of the Act, the importation, introduction or bringing of these things into New South Wales is prohibited:

- (a) tomato potato psyllid;
- (b) any thing that is infested with tomato potato psyllid; and
- (c) any Solanaceae host plant material grown in a State or Territory in which tomato potato psyllid has been detected or is suspected to be present.

5 Regulation of the movement of Convolvulaceae host plant material

Pursuant to section 4(1) of the Act, Convolvulaceae host plant material must not be imported, introduced or brought into New South Wales unless:

- (a) the Convolvulaceae host plant material was grown in a State or Territory in which tomato potato psyllid has not been detected and is not suspected to be present; or
- (b) the Convolvulaceae host plant material is accompanied by a Plant Health Certificate certifying that the Convolvulaceae host plant material has been:
 - (i) treated with an APVMA approved insecticide for the control of psyllids in accordance with all label and APVMA permit directions for the control of psyllids;
 - (ii) inspected and no tomato potato psyllid has been detected; and
 - (iii) placed in secure conditions before it is dispatched from the property on which it was grown and it remains in secure conditions until it arrives in New South Wales;or

- (c) the Convolvulaceae host plant material is a vegetable and is accompanied by a Plant Health Certificate certifying that the Convolvulaceae host plant material which is a vegetable has been:
 - (i) brushed and washed free of soil whilst traversing on rollers using water and mechanical brushes or high pressure jets; and
 - (ii) inspected and no tomato potato psyllid has been detected.

6 Regulation of the movement of used agricultural machinery or used packaging

Pursuant to section 4(1) of the Act, used agricultural machinery or used packaging must not be imported, introduced or brought into New South Wales unless it is accompanied by a Plant Health Certificate certifying that:

- (a) the used agricultural machinery or used packaging has been thoroughly cleaned and is free from all planting media, organic material and tomato potato psyllids; and
- (b) the used agricultural machinery has been washed with high pressure hot water heated to a temperature of at least 70°C.

7 Regulation of the movement of planting media

Pursuant to section 4(1) of the Act, planting media must not be imported, introduced or brought into New South Wales unless the planting media is accompanied by a Plant Health Certificate certifying that it has been treated with an APVMA approved insecticide for the control of psyllids in accordance with all label and APVMA permit directions for the control of psyllids.
