##### Location

Hawkesbury River, Windsor – between Windsor Road Bridge and the furthest downstream end of Windsor Reach.

##### Duration

9:00am to 5:00pm on the following days:

- Saturday 19 January 2019, and

##### Detail

Competitive power boat races will be held on the navigable waters of the Hawkesbury River at the location specified above, involving the use of high speed power vessels racing at speed, presenting a significant potential hazard to other waterway users.
