#### REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Budgewoi Lake, Budgewoi – navigable waters west of Budgewoi Lake between Buff Point and Third Avenue, Toukley.

**Duration**

9:00am to 5:00pm on the following days:

- Saturday 30 November 2019 and Sunday 1 December 2019;
- Saturday 1 February and Sunday 2 February 2020;

**Detail**

Competitive waterski races will be conducted on the navigable waters of Budgewoi Lake as specified above. This will involve the use of high speed powered vessels, persons being towed at speed using tow-lines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by control vessels.

It is proposed that the Trust funds be applied cy pres to establish a Nursing and Midwifery Leadership Development Scholarship ('the Scholarship'). The Scholarship will fund entry into post-graduate courses in clinical leadership and management in the areas of health sciences, nursing or education at the University. Registered nurses and midwives who are current employees of the WSLHD and who have at least five years of experience in nursing and/or midwifery will be eligible to apply for the Scholarship. The Scholarship aligns with the original purpose of the Trust as it will encourage and assist clinical staff to undertake formal studies to develop their leadership skills and understanding of senior management roles.

In circumstances where the funds held on trust cannot be applied to the original purpose of the Trust, due to the cessation of the courses jointly offered by WSAHS and the University, the Solicitor General, as the Attorney General's delegate, recommends the establishment of a cy pres scheme to apply the funds held on Trust to the Nursing and Midwifery Leadership Development Scholarship, that being as close as possible to the original purposes of the Trust.

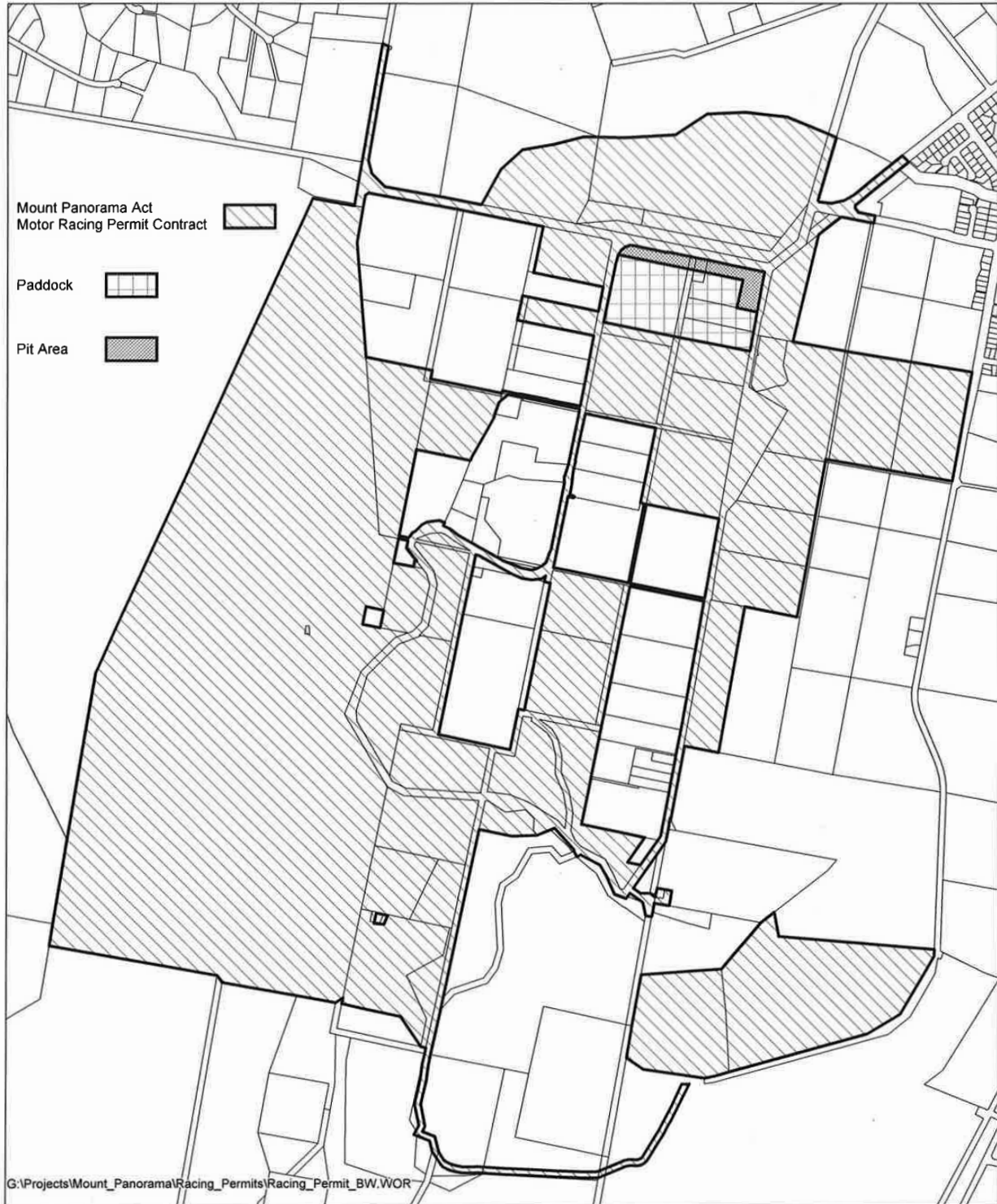
