#### Order - Sections 46, 49, 54 and 67

Snowy Valleys Council and Snowy Monaro Regional Council Areas

Declaration as Controlled Access Road of part of the Snowy Mountains Highway between Talbingo and Nungar

I, the Minister for Regional Transport and Roads, by this order pursuant to Sections 46, 49, 54 and 67 of the *Roads Act, 1993*:

- 1. dedicate as public road the land described in Schedules 1 and 2 under;
- 2. declare to be a main road the said public road described in Schedules 1 and 2 and the public road described in Schedules 3 and 4 under;
- 3. declare to be a controlled access road the said main road described in Schedules 1, 2, 3 and 4 under;
- 4. declare that access to the said controlled access road is restricted; and
- 5. specify in Schedules 5 and 6 under, the points along the controlled access road at which access may be gained to or from other public roads.

# Notice of Proposed Closure of Level-crossing from 451.400km to 491.492km on the Parkes to Narromine Line
