ONE MILLION DOLLAR (\$1,000,000) REWARD

On 17 February 2005, the naked and decomposed body of German tourist Simone Strobel, aged 25 years, was located on the grounds of the Continental Club in Lismore, NSW. Simone had been reported missing six days earlier from the Lismore Tourist Caravan Park.

Notice is hereby given that a reward of up to one million dollars (\$1,000,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the murder of Simone Strobel.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.

ERRATUM

In the notice published in the NSW Government Gazette No [260] of [09 October 2020], page/number [n2020-4212], the words '[Under section 62TBC (2) of the *Land Tax Management Act 1956*, the premium rate threshold for the 2020 land tax year is **\$4,434,000**.]' are replaced with '[Under section 62TBC (2) of the *Land Tax Management Act 1956*, the premium rate threshold for the 2020 land tax year is **\$4,488,000**.]'

Further, the words '[It is hereby notified that pursuant to Section 62TBC (4) of the Land Tax Management Act 1956, that the amount of **\$4,416,000** has been determined as the premium rate threshold for the 2021 land tax year.]' are replaced with '[It is hereby notified that pursuant to Section 62TBC (4) of the Land Tax Management Act 1956, that the amount of **\$4,616,000** has been determined as the premium rate threshold for the 2021 land tax year.]'

This notice corrects these errors.
