REGULATION OF VESSELS – EXCLUSION ZONE

Location

Blowering Dam, Tumut

Duration

8:00am to 6:00pm – Saturday 7 November 2020

8:00am to 6:00pm – Sunday 8 November 2020

Detail

Trials involving the use of a high speed vessel powered by a jet engine will be conducted on the waters of Blowering Dam at varying times on the days specified above. The jet powered vessel will be operating at very high speed and will present a significant potential hazard to other waterway users. There will be support and official vessels present to manage the trials.

An **EXCLUSION ZONE** is specified during the event, which will comprise of the entirety of Blowering Dam, and will be patrolled by Transport for NSW vessels.

At varying times between trials, such as when the jet powered vessel is not being operated, Transport for NSW officers on-site may lift the Exclusion Zone to allow boaters to use the waterway for periods of time. Other than during these interim periods, unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
