Electoral Distribution in New South Wales

Public submissions and comments

The Electoral Districts Redistribution Panel (the Panel) has been appointed by the Governor and directed to distribute New South Wales into electoral districts in accordance with the *Electoral Act* 2017.

The Panel has prepared a draft determination of the names and boundaries of electoral districts.

Pursuant to section 25(2) of the *Electoral Act 2017*, the Panel gives notice that the following are available for inspection on the Electoral Commission's website, www.elections.nsw.gov.au/redistribution:

- (i) a map setting out the Redistribution Panel's proposed names and boundaries of electoral districts; and
- (ii) the Panel's reasons for making the draft determination.

The Panel now invites written submissions relating to the draft determination, and any comments on such submissions.

Submissions must be lodged with the Panel within 30 days after the date of this notice, that is, no later than **9 December 2020**. Any submissions lodged with the Panel will be made available for public inspection on the NSW Electoral Commission's website as soon as practicable after the close of the submission period www.elections.nsw.gov.au/redistribution

A comments period will be open for 14 days after the expiry of the submission period. Comments relating to any submissions received must be lodged with the Panel no later than **23 December 2020**. All comments lodged will be available for public inspection on the NSW Electoral Commission's website as soon as practicable after the close of the comments period www.elections.nsw.gov.au/redistribution

The Panel will consider all submissions and comments lodged by the respective due dates before determining the final names and boundaries of electoral districts.
