**EXEMPTION (UNAUTHORISED CARRYING OUT OF DESIGNATED ANCILLARY
MINING ACTIVITY) ORDER 2020**

under the

MINING REGULATION 2016

I, Michael Wright, Deputy Secretary, Mining, Exploration and Geoscience, Department of Regional New South Wales, with the delegated authority of the Minister for Regional New South Wales, Industry and Trade, under clause 11 of the Mining Regulation 2016, exempt the class of persons specified in Column 1 of Schedule 1 from the operation of section 6 of the *Mining Act 1992* with respect to the carrying out of the class of designated ancillary mining activities specified in Column 2 of Schedule 1 where those activities are being carried out at a location specified in Schedule 2.

This exemption has effect from 15 November 2020 until 15 November 2021.
