Cudgen Creek, Kingscliff - from Jack Julius Park downstream to the north training wall at Kingscliff

**Duration**

6:00 am to 10:30am — Sunday 29 November 2020

**Detail**

The swimming leg of the Kingscliff Triathlon events will be held on navigable waters of Cudgen Creek during the above date and time and at the location specified above.

An **EXCLUSION ZONE** is specified during the event. The exclusion zone will be marked by buoys and patrolled by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Budgewoi Lake, Budgewoi - all navigable waters west of an imaginary line between Buff Point and Third Avenue, Toukley.

**Duration**

9:00am to 5:00pm on the following dates:

- Saturday 12 and Sunday 13 December 2020
- Saturday 16 and Sunday 17 January 2021
- Saturday 30 and Sunday 31 January 2021
- Saturday 13 and Sunday 14 March 2021
- Saturday 22 and Sunday 23 May 2021

**Detail**

Competitive ski racing will be conducted on the waters of Budgewoi Lake at the location specified above. The event will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of buoys, and control vessels stationed on the perimeter. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.
