REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Clarence River, Yamba - adjacent to Whiting Beach

**Duration**

- 3:00pm to 4:00pm – Saturday 5 December 2020
- 7:00am to 9:30am – Sunday 6 December 2020

**Detail**

The swimming leg of a triathlon will be conducted on the navigable waters of Clarence River at the location specified above. This will involve a number of swimmers and support vessels, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys and patrolled by control vessels.


Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

**Location**

Clarence River, Grafton - adjacent Memorial Park

**Duration**

- 7:00am to 5:00pm – Saturday 5 December 2020
- 7:00am to 5:00pm – Sunday 6 December 2020

**Detail**

A rowing regatta will be conducted in the location specified above. In support of the regatta an **EXCLUSION ZONE** is specified during the event, which will be marked by buoys at the above location.

Unauthorised vessels and persons are prohibited from entering the exclusion zone which will be patrolled by control vessels.

**Special Restrictions - Transit lane**

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to vessels using the transit lane:


- Maximum speed limit of 6 knots, and
- Minimal wash must be produced.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

**Location**

Manning River, Taree - between Martin Bridge and Dumaresq Island.

**Duration**

- 8:00am to 5:30pm – Saturday 5 December 2020
- 8:00am to 5:30pm – Sunday 6 December 2020
- 8:00am to 5:30pm – Sunday 7 March 2021
- 8:00am to 5:30pm – Friday 2 April 2021
- 8:00am to 5:30pm – Saturday 3 April 2021
- 8:00am to 5:30pm – Sunday 4 April 2021
- 8:00am to 5:00pm – Saturday 15 May 2021
- 8:00am to 5:00pm – Sunday 16 May 2021

**Detail**

Competitive powerboat races will be conducted on the navigable waters of the Manning River as specified above, involving the use of high speed power vessels racing at speed, presenting a significant potential hazard to other waterway users.

There will also be support vessels present to manage the event.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

**Special Restrictions - Transit lane**

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to vessels using the transit lane:

- Maximum speed limit of 6 knots, and
- Minimal wash must be produced.

Penalties may apply (Section 12(5) - *Marine Safety Act 1998*)
