Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 7) 2020* in relation to the following—

- (a) requiring compliance with relevant COVID-19 Safety Plans as in force for the time being,
- (b) requiring organisers of outdoor rehearsals or performances to ensure that all persons attending the outdoor rehearsals or performances as spectators are assigned to specific seats or to seating areas,
- (c) other minor clarifications and changes.

Omit "approved on the date specified in column 4 of Schedule 1" from clause 7(a). Insert instead "as in force for the time being".

[3] Clause 16 Direction of Minister requiring COVID-19 Safety Plans

Omit "approved on the date specified in column 4 of Schedule 1" from clause 16(1)(a). Insert instead "as in force for the time being".

[4] Clause 18 Direction of Minister requiring COVID-19 Safety Plans

Omit "approved on the date specified in column 4 of Schedule 1" from clause 18(a). Insert instead "as in force for the time being".

[5] Clause 22 Direction of Minister about COVID-19 Safety Plans

Omit "approved on the date specified in column 4 of Schedule 1" from clause 22(a). Insert instead "as in force for the time being".

[6] Clause 23A

Insert after clause 23—

23A Direction of Minister about allocated seating

The Minister directs that the organiser of an outdoor rehearsal or performance must ensure that all persons attending the rehearsal or performance as spectators of the outdoor rehearsal or performance are assigned to a specific seat or to a seating area.

[7] Part 2, Division 6, heading

Omit "Regional agricultural". Insert instead "Agricultural".

[8] Clause 25 Definitions

Omit the definition of *organiser* from clause 25. Insert instead—

organiser, in relation to an agricultural show or agricultural field day, means—

- (a) for an agricultural show or agricultural field day conducted by or on behalf of an entity that is registered under the *Associations Incorporation Act 2009*—the public officer of the entity, or
- (b) for an agricultural show or agricultural field day conducted by or on behalf of an entity other than an entity referred to in paragraph (a)—the chief executive officer of the entity, however described, or

(c) otherwise—the person who made the arrangements for the agricultural show or agricultural field day.

Omit "a regional" from clause 26. Insert instead "an".

[11] Clause 26(a)

Omit "approved on the date specified in column 4 of Schedule 1".

Insert instead "as in force for the time being".

[12] Clause 27 Direction of Minister about maximum number of participants

Omit "regional" from clause 27.

[13] Clause 28 Regional agricultural shows and agricultural field days to which this Division does not apply

Omit "Regional agricultural" from the heading to clause 28.

Insert instead "Agricultural".

[14] Clause 28(c)

Omit "a regional". Insert instead "an".

[15] Clauses 29 Direction of Minister about outdoor public gatherings

Omit "a regional" from clause 29(3)(k). Insert instead "an".

[16] Clause 29(4)(c)(i)

Omit "approved on the date specified in column 4 of Schedule 1".

Insert instead "as in force for the time being".

[17] Clause 30 Directions of Minister about controlled outdoor public gatherings

Omit "approved on the date specified in column 4 of Schedule 1" from clause 30(2)(a).

Omit "approved on the date specified in column 4 of Schedule 1" from clause 34(a).

Insert instead "as in force for the time being".

[20] Clause 35 Directions of Minister about Lord Howe Island

Omit "approved on 4 December 2020" from clause 35(1)(a).

Omit "Regional agricultural" from item 24 in Schedule 3. Insert instead "Agricultural".
