

That part of the Crown Public road known as Vincent Street as denoted by blue shading in the diagram below.





That part of the Crown Public road known as Quarry Road as denoted by blue shading in the diagram below.



That part of the Crown Public road known as Turon Gully Road as denoted by blue shading in the diagram below.




