This Instrument is made under section 40H of the *Fisheries Management Act 1994*. The object of this Instrument is to notify the making of fishing determinations by the TAF Committee under section 40D of that Act.

1. Name of Instrument

This Instrument is the Fisheries Management (Fishing Determinations – Ocean Trawl Fishery) Notification 2020.

2. Interpretation

(1) In this Instrument:

ocean trawl fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

TAC determination has the same meaning as in section 40A of the Act.

the Act means the *Fisheries Management Act 1994*.

(2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act have the same meaning in this Instrument.

3. Notice of TAC determinations in the Ocean Trawl Fishery

(1) Pursuant to section 40H of the Act, the amount specified in Column 1 of the Table to this clause is determined to be the total allowable catch of the species of fish described opposite in Column 2 of the Table that may be taken in the ocean trawl fishery during the period 1 May 2020 to 30 April 2021.

(2) These fishing determinations have effect for the period 1 May 2020 to 30 April 2021.
