EXEMPTION ORDER

SECTION 18

Ministerial (Digital Metered Parking Scheme Trial) Exemption Order 2020

I, Andrew Constance, Minister for Transport and Roads, pursuant to section 18(1) of the *Road Transport Act 2013*, make this Order.

1. Citation

This Order is the *Ministerial (Digital Metered Parking Scheme Trial) Exemption Order 2020*.

2. Commencement

This Order has effect on and from the date it is published in the NSW Government Gazette

3. Effect

This Order remains in force until 2 years from the date of publication, unless revoked earlier.

4. Interpretation

Words and expressions used in this Order have the same meaning as in the *Road Transport Act 2013* and the statutory rules under that Act, unless otherwise stated.

5. Application

This Order applies to any area set aside as a Pay Parking Scheme Area by a parking authority pursuant to Part 5 of the *Road Transport (General) Regulation 2013* (the Regulation), within which a trial approved by Transport for NSW is conducted of a parking scheme which provides for a method of payment of fees for parking by a means other than cash.

6. Declaration

The requirements set out in NSW Rule 207-1(3) and NSW Rule 207-1(4) of the *Road Rules 2014*, being:

- The requirement that an ordinary metered parking area be designated by a permissive parking sign where information on or with the sign includes the word "METER"; and
- The requirement that a registration metered parking area be designated by a permissive parking sign where information on or with the sign includes both the words "METER" and "REGISTRATION"

DO NOT APPLY, and by default, Rule 207 of the *Road Rules 2014* applies - and any such parking area subject to a permissive parking sign which requires payment to be made pursuant to Rule 207(1) may be taken to be a 'metered parking area' for the purposes of the trial of the use of a mobile application approved by Transport for NSW as a 'parking meter'.

7. Publication

This Order is published in the NSW Government Gazette.

Explanatory notes:

Pursuant to clause 32 of the Regulation, a parking meter must be approved by Transport for NSW.

Transport for NSW has approved as parking meters, certain digital mobile applications which meet the requirements of clause 62 of the Regulation.

This Order excludes certain areas from the operation of statutory rules which require a 'metered parking area' (as defined) to be indicated by permissive parking signs that display the words "METER" and/or "REGISTRATION".

This Order thereby allows digital mobile applications to be used to pay for parking where a 'metered parking area' has been established by a parking authority for the purposes of the trial of a mobile application, but where such area is currently subject to an overlapping pay parking scheme and the permissive parking signage displayed in the area

reflects the operation of the other parking scheme (by the words "TICKET", "PHONE" or "COUPON" being displayed on the signage).

Under clause 85 of the Regulation, a parking authority may establish overlapping parking schemes.

The statutory rules exempt a driver from compliance with permissive parking signs under a signposted pay parking scheme in cases where the area is subject to an overlapping parking scheme and where the driver complies with the requirements of the overlapping scheme (in this case paying for parking using the mobile application under a metered parking scheme)

Under s.18 of the *Road Transport Act 2013*, the Minister may declare by order that specified area open to or used by the public is not subject to provision of the road transport legislation specified in the order.





The object of this Exemption Order is to waive \$500 of the authorisation fee otherwise payable under clause 45 of the *Point to Point Transport (Taxis and Hires Vehicles) Regulation 2017* for the financial year 2018-2019 in response to the COVID-19 pandemic.

Examples:

- If an authorised provider carried out fewer than 20,000 passenger service transactions in the financial year 2018-2019, the fees payable will be nil.
- If the authorised provider carried out 20,000 or more and fewer than 50,000 passenger service transactions in the financial year 2018-2019, the fees payable will be \$250 (\$750 reduced by \$500).

The reduced fee payable will be specified in fee notices issued by the Point to Point Transport Commissioner.
