Part 1 Preliminary

1. Interpretation

(1) In this Instrument:

abalone means the species *Haliotis rubra*.

TAC determination has the same meaning as in section 40A of the Act.

the Act means the *Fisheries Management Act 1994*.

(2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act have the same meaning in this Instrument.

1. Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determinations – Spanner crab) Notification 2020*.

2. Interpretation

(1) In this Instrument:

ocean trap and line fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Spanner crab means the species *Ranina ranina*.

TAC determination has the same meaning as in section 40A of the Act.

the Act means the *Fisheries Management Act 1994*.

(2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act have the same meaning in this Instrument.

3. Notice of TAC determination in the Ocean Trap and Line Fishery

(1) Pursuant to section 40H of the Act, the total allowable catch of Spanner crab that may be taken in the ocean trap and line fishery during the period 1 July 2020 to 30 June 2021 is determined to be 135.5 tonnes.

(2) This fishing determination has effect for the period 1 July 2020 to 30 June 2021.
