GEOGRAPHICAL NAMES ACT 1966

PURSUANT to the provisions of Section 8 of the *Geographical Names Act 1966*, the Geographical Names Board hereby notifies that it proposes to assign the names:

Nancy Hillier Park for a reserve located between Wilson and Kurnell Streets, in the suburb of Botany, Bayside LGA.

Roland Wakelin Reserve for a reserve located on Felton Road, near the intersection of Pennant Hills Road and Jenkins Road, Carlingford, City of Parramatta LGA.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Newcastle Coal Infrastructure Group to advertise, designate and recruit for up to 10 women only for technical and engineering roles and apprentice and graduate trade-based engineering roles.

This exemption will remain in force for 5 years.
