Public Health (COVID-19 Air Transportation Quarantine) Order (No 4) Amendment Order 2021

Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Air Transportation Quarantine) Order (No 4) 2020* concerning requirements for testing for COVID-19 for flight crew and other persons.

Public Health (COVID-19 Air Transportation Quarantine) Order (No 4) Amendment Order 2021

under the

Public Health Act 2010

1 Name of Order

This Order is the *Public Health (COVID-19 Air Transportation Quarantine) Order (No 4) Amendment Order 2021*.

2 Commencement

This Order commences at the beginning of 12 January 2021.

Schedule 1 Amendment of Public Health (COVID-19 Air Transportation Quarantine) Order (No 4) 2020

[1] Clause 7 Directions—entering, remaining and departing quarantine or medical facilities

Omit clause 7(2)(b). Insert instead—

- (b) the person departs on an international flight, including an international flight that stops in another State or a Territory before leaving Australia, in circumstances where the person has—
 - (i) undergone a test for COVID-19 before leaving the airport on arrival in New South Wales, and
 - (ii) complied with any request of the Chief Health Officer to undergo testing for COVID-19 after leaving the airport and before the departure.

[2] Clause 10 Directions—declared flight crew members

Omit clause 10(3)(b). Insert instead—

- (b) the member departs on an international flight, including an international flight that stops in another State or a Territory before leaving Australia, in circumstances where the member has complied with any request of the Chief Health Officer to undergo testing for COVID-19 before the departure.

[3] Clause 11A Directions—interstate flight crew members

Omit clause 11A(4)(a). Insert instead—

- (a) the member departs New South Wales on suitable transport arranged by the member's employer in circumstances where the member has complied with any request of the Chief Health Officer to undergo testing for COVID-19 before the departure, or
