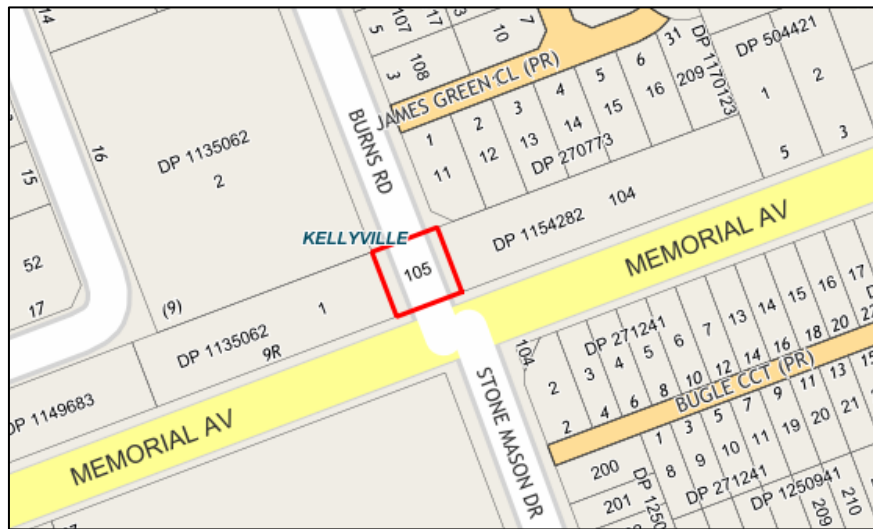

REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Hawkesbury River – between Wisemans Ferry and Liverpool Reach

**Duration**

8:00am to 2:00pm – Sunday, 7 November 2021

**Detail**

Competitive water ski races will be conducted on the navigable waters of the Hawkesbury River at the location specified above, involving the use of high speed power vessels, persons being towed at speed using towlines, and persons in the water from time to time presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event. The zone will be marked by the presence of support vessels on the perimeters. Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone, which will be patrolled by control vessels.
