SCHEDULE 1

EASEMENTS FOR PIPELINE TO BE VESTED IN THE LICENSEE

Easement over pieces or parcels of land as described in Deposited Plans (DP) 1269522, 1269523 and 1269855 as lodged and registered with NSW Land Registry Services.

SCHEDULE 2

RESTRICTIONS AS TO USER

Without affecting the generality of any requirement imposed by the *Pipelines Act 1967* or Pipelines Regulation 2013, the owner or occupier of land over which there is an easement for pipeline must not within the easement, except with the prior consent in writing of the person in whom the easement is vested:

- (a) Excavate (including blasting), drill or dig.
- (b) Erect, place or permit to be erected or placed any building, structure (including fence posts), plant, apparatus or equipment, earthworks, utility services or other improvements whether permanent or temporary on, over or under the land.
- (c) Alter or disturb existing levels, contours or gradients.
- (d) Plant or cultivate any tree within 3 metres of the pipeline or any apparatus or works.
- (e) Place on or use any part of the servient tenement for the transport, carriage or support of any heavy object, vehicle or implement, which could in any way cause or be likely to cause damage to the pipeline.
- (f) Undertake any other activity that represents a danger to the pipeline or is a danger to the operation of the pipeline or its apparatus or works including signs, vent pipes and cathodic protection systems including anode beds and electrolysis test points.



Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 10, 25. 27, 49D, 49F and 51 of the *Anti-Discrimination Act 1977* (NSW), to Transport for NSW, Roads & Maritime Services, the State Transit Authority, Sydney Trains, NSW Trains and their delivery offices (collectively the '*Transport Cluster*') to implement the following diversity and inclusion programs for designated target groups:

1. Women

- 1.1. targeted recruitment of women into senior service roles;
- 1.2. fast track development program for potential female leaders;
- 1.3. capability development, mentoring and connecting programs for female leaders and potential leaders
- 1.4. targeted recruitment of women into entry level employment programs, including through cadetship, graduate, scholarship, trade apprenticeship and traineeship programs.

2. Aboriginal and Torres Strait Islanders

- 2.1. targeted recruitment of Aboriginal and Torres Strait Islander people into senior service roles;
- 2.2. fast track development program for potential leaders who are Aboriginal or Torres Strait Islanders;
- 2.3. capability development, mentoring and connecting programs for Aboriginal and Torres Strait Islander leaders and potential leaders;
- 2.4. capability development, mentoring and connecting programs for Aboriginal and Torres Strait Islander people in entry level employment programs and making the transition from such programs into roles within the Transport Cluster.

3. People with Disability

3.1. capability development, mentoring and connecting programs and events for people with disability at or post entry level and making the transition from entry level programs into roles within the Transport Cluster.

This exemption will remain in force 6 months.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8, 10, 25, 27 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to We Care NSW to advertise, designate and recruit:

- Roles for Aboriginal and Torres Strait Islander persons only in pursuit of a 50% of Aboriginal and Torres Strait Islander workforce participation rate; and
- Disability support worker roles for persons of a particular sex to meet the needs of participants.

This exemption will remain in force for 10 years.
