ACTS OF PARLIAMENT ASSENTED TO

Legislative Council Office Sydney 29 November 2021

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of Her Majesty, this day assented to the undermentioned Acts passed by the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, viz.:

Act No. 39, 2021 - An Act to amend the Modern Slavery Act 2018 to make further provision with respect to slavery, slavery-like practices and human trafficking; and for other purposes. **[Modern Slavery Amendment Bill 2021]**

Act No. 40, 2021 - An Act to amend the Law Enforcement Conduct Commission Act 2016 in relation to the terms of office, and a vacancy in office, of a member of the Commission, an Assistant Commissioner or an alternate Commissioner. **[Law Enforcement Conduct Commission Amendment Bill 2021]**

Act No. 41, 2021 - An Act to amend the Teacher Accreditation Act 2004 to strengthen child protection requirements for teacher accreditation and improve the effectiveness of the teacher accreditation scheme; and for related purposes. **[Teacher Accreditation Amendment Bill 2021]**

Act No. 42, 2021 - An Act to amend the Electoral Act 2017 to provide for by-elections held during the COVID-19 pandemic. **[Electoral Amendment (COVID-19) Bill 2021]**

ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 29 November 2021

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 31 — An Act to prohibit certain items and establish a product stewardship framework for brand owners of certain products; and for related purposes. **[Plastic Reduction and Circular Economy Bill]**

Act No. 32 — An Act to amend legislation administered by the Minister for Customer Service and other Acts for related purposes. **[Customer Service Legislation Amendment Bill]**

Act No. 33 — An Act to amend the Electronic Transactions Act 2000 to make permanent certain provisions about the remote witnessing of documents; to amend the Oaths Act 1900 to expand the classes of persons before whom oaths and statutory declarations may be made; and for other purposes. **[Electronic Transactions Amendment (Remote Witnessing) Bill]**

Act No. 34 — An Act to amend various Acts administered by the Minister for Energy and Environment concerning the supply of energy to the State; and for related purposes. **[Energy Legislation Amendment Bill]**

Act No. 35 — An Act to amend the Service NSW (One-stop Access to Government Services) Act 2013 to provide additional safeguards on certain information collected during the COVID-19 pandemic. **[Service NSW (One-stop Access to Government Services) Amendment (COVID-19 Information Privacy) Bill]**

Act No. 36 — An Act to amend the Crimes Act 1900 to create new offences in relation to causing the loss of a foetus of a pregnant woman; and to make consequential amendments to other Acts. **[Crimes Legislation Amendment (Loss of Foetus) Bill]**

Act No. 37 — An Act to amend the Gaming Machine Tax Act 2001 to make it clear that bets placed on gaming machines using promotional prizes are taxable; and for other purposes. **[Gaming Machine Tax Amendment (Promotional Prizes) Bill]**

Act No. 38 — An Act to encourage persons responsible for property to mitigate risks to access, safety and amenity that may arise from property being left unattended and to ensure public spaces can continue to be used, shared and enjoyed by the community by providing a scheme for dealing with unattended property; and to repeal the Impounding Act 1993. **[Public Spaces (Unattended Property) Bill]**
