### **ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 8 December 2021**

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 43 — An Act to amend the Crimes Act 1900 in relation to consent to certain sexual activities that, in the absence of consent, are sexual offences; to amend the Criminal Procedure Act 1986 in relation to directions to juries; and for other purposes. **[Crimes Legislation Amendment (Sexual Consent Reforms) Bill]**

Act No. 44 — An Act to amend the Callan Park (Special Provisions) Act 2002 and the Parramatta Park Trust Act 2001 to provide for the acquisition of the substratum of certain trust lands under the Acts for a public purpose within the meaning of the Land Acquisition (Just Terms Compensation) Act 1991. **[Greater Sydney Parklands Legislation Amendment (Substratum) Bill]**

Act No. 45 — An Act to amend various Acts relating to children in the Communities and Justice portfolio. **[Stronger Communities Legislation Amendment (Children) Bill]**

Act No. 46 — An Act to amend the Crimes Act 1900, the Crimes (High Risk Offenders) Act 2006, the Law Enforcement (Powers and Responsibilities) Act 2002, the Surveillance Devices Act 2007, the Terrorism (High Risk Offenders) Act 2017 and the Terrorism (Police Powers) Act 2002 for particular purposes. **[Crimes Legislation Amendment Bill]**

Act No. 47 — An Act to amend the National Parks and Wildlife Act 1974 and other legislation to streamline processes for plans of management; to enable the Minister to approve priority conservation actions; to establish an entity to receive donations; to allow the Minister to create and trade in carbon sequestration rights and biodiversity credits for certain land; to reserve land; and for other purposes. **[National Parks and Wildlife Amendment Bill 2021]**
