**POISONS AND THERAPEUTIC
GOODS REGULATION 2008**

ORDER

Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 7 June 2019, on **Dr Peita Louise MELVILLE (MED0000982608)** of Tweed Heads NSW 2485, prohibiting her as a medical practitioner from supplying or having possession of drugs of addiction as authorised by clauses 101 of the Regulation, and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation, shall cease to operate on and from 5 February 2021.

MENTAL HEALTH ACT 2007
Section 109
Declaration of Mental Health Facility

I, MAUREEN LEWIS, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:

(a) DECLARE the following premises of **Westmead Hospital** to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

- **Westmead Hospital Adults Emergency Department**, located on Level 1, Building K, Westmead Hospital campus, Hawkesbury Road, Westmead NSW 2145; and

(b) DECLARE this facility to be designated as a "**mental health emergency assessment class**" facility; and

(c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the Mental Health Act 2007, with the exception of:

- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and
