Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Mandatory Face Coverings) Order 2021* to remove the requirement for persons to wear fitted face coverings other than—

- (a) on public transport and in public transport waiting areas in Greater Sydney, and
- (b) in airports and on aircraft in New South Wales.

1 Name of Order

This Order is the *Public Health (COVID-19 Mandatory Face Coverings) Amendment (No 4) Order 2021*.

2 Commencement

This Order commences at the beginning of 12 February 2021.

Schedule 1 Amendment of Public Health (COVID-19 Mandatory Face Coverings) Order 2021

[1] Clause 3 Definitions

Omit the definitions of *hospitality venue* and *residential aged care facility* from clause 3(1).

[2] Clause 5 Direction of Minister to wear fitted face coverings

Omit clause 5(1), (3) and (4).

[3] Clause 5(5)

Omit “Subclauses (1)–(4) do”. Insert instead “Subclause (2) does”.

[4] Clause 5(7)

Omit “subclauses (1)–(4)”. Insert instead “subclause (2)”.

[5] Clause 6 Relationship of Order with other orders

Omit clause 6(b).

[6] Clause 6(c)

Omit “or (b)”.

- [5] Part 2, Division 4B Major sporting events**
Omit the Division.
