**ORDER UNDER SECTION 57(2)  
TO GRANT SITE SPECIFIC EXEMPTIONS FROM APPROVAL**

I, the Minister administering the *Heritage Act 1977*, on the recommendation of the Heritage Council of New South Wales, in pursuance of s.57(2) of the *Heritage Act 1977*, do, by this my order, grant an exemption from s.57(1) of that Act in respect of the engaging in or carrying out of any activities described in Schedule "C" by the owner, mortgagee or lessee of the land described in Schedule "B" on the item described in Schedule "A".

The item known as National Art School Group, Former Darlinghurst Gaol, Former East Sydney Technical College, situated on the land described in Schedule "B".

**SCHEDULE "B"**

All those pieces or parcels of land known as Lot 1 DP 568755 in Parish of Alexandria, County of Cumberland shown on the plan catalogued HC 3259 in the office of the Heritage Council of New South Wales.

**SCHEDULE "C"**

1. All standard exemptions as set out under Section 57(2) of the *Heritage Act 1977* (NSW)
2. All works and activities which are in accordance with a valid development consent in force at the date of gazettal for listing the National Art School Group on the State Heritage Register under the *Heritage Act 1977* (NSW)
3. Installation of and alterations to lightweight partitions required to accommodate student studios and gallery spaces, as long as this work will have no adverse impact on heritage significance and/or obscure or alter significant views towards fabric of exceptional, high or moderate significance. Partitions to be reversible. No fixings to be made into masonry walls or window joinery.
4. Erection of temporary hoardings (up to 12 months) and scaffolding associated with maintenance or conservation of facades, windows and roof sheeting and drainage where no physical impact to heritage fabric occurs.
5. Excavation outside the mapped zones of archaeological sensitivity as shown on an approved Archaeological Management Plan. This does not permit the removal of historical

archaeological 'relics' or Aboriginal objects if found. Notifications would still be required under relevant legislation.

6. Removal of non-illuminated external signs and decorations, such as flags, rigging, banners, merchandising, holiday livery and associated decorations providing that the signs and decoration are not elements remaining from the significant periods of the site's history.
7. Replacement of non-illuminated external signs and decorations, such as flags, rigging, banners, merchandising, holiday livery and associated decorations where the size, scale and impact of the new items is the same or does not exceed that being replaced and providing that the signs and decoration are not elements remaining from the significant periods of the site's history.
8. Replacement or installation of temporary signage for events, exhibitions and other cultural activities provided there are no fixings into significant fabric and provided that no archaeological 'relics' would be disturbed, exposed or harmed.
9. Installation of new interpretation and/or waymarking signs or relocation or interpretive and/or waymarking signs. Signage must be in accordance with the following Relevant Standards related to Standard Exemptions – Signage: (j) (i) (iii) (iv) (v) and k)
10. Installation of temporary and reversible structures for the operation of special events and activities lasting less than six (6) month duration (i.e. for markets, art shows, gallery exhibitions, filming), as long as this work will have no adverse impact on heritage significance and/or obscure or alter fabric of exceptional, high or moderate significance and provided that no archaeological 'relics' would be disturbed, exposed or harmed.
11. Display of student works and other art works. Minor works such as hanging system for display of works or shelving where the display system relies on recently constructed walls and partitions or on portable display units, as long as this work will have no adverse impact on heritage significance and/or on significant views towards fabric of exceptional, high or moderate significance and provided that no archaeological 'relics' would be disturbed, exposed or harmed.
