Anti-Discrimination Act 1977

VARIATION OF EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), the exemption Order granted to **Australian Indigenous Minority Supplier Office trading as Supply Nation** on 29 April 2019 is HEREBY VARIED as follows:

1. With effect from the date of this Order, the exemption Order of 29 April 2019 is amended to permit **Australian Indigenous Minority Supplier Office trading as Supply Nation** to designate and recruit the positions of:
 - Manager, Indigenous Business Engagement,
 - Manager, Certification and Audit,
 - Manager, Programs, and
 - Manager, Partnerships

for Aboriginal and/or Torres Strait Islander persons only.

2. The duration of the exemption remains the same and will remain in force until the 28 April 2029.
