**MENTAL HEALTH ACT 2007**  
**Section 109**  
**Revocation and Declaration of Mental Health Facility**

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:

(a) REVOKE the Order published in the NSW Government Gazette number 20 of the 14 February 2014, declaring a number of facilities at Hornsby Ku-ring-gai Hospital as declared mental health facilities in accordance with section 109 of the *Mental Health Act 2007*; and

(b) DECLARE the following premises of **Hornsby Ku-ring-gai Hospital** to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

- **Adult Acute Mental Health Inpatient Unit**, located on the Ground Floor of the Mental Health Centre, Building 52, Lowe Road, Hornsby NSW 2077; and
- **Mental Health Intensive Care Unit (MHICU)**, located in Building 51, Lowe Road, Hornsby NSW; and
- **Child and Adolescent Mental Health Inpatient Unit**, located on the first floor of the Mental Health Centre, Building 52, Lowe Road, Hornsby NSW 2077.

(c) DECLARE this facility to be designated as a "**mental health assessment and inpatient treatment class**" facility; and

**MENTAL HEALTH ACT 2007**  
**Section 109**  
**Declaration of Mental Health Facility**

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:

(a) DECLARE the following premises to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

- **The Emergency Department of the Hornsby Ku-ring-gai Hospital** located within Building 50, Hornsby Hospital, Palmerston Road, Hornsby NSW 2077; and

(b) DECLARE this facility to be designated as a "**mental health emergency assessment class**" facility; and

(c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:

- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and

**Declaration of Mental Health Facility**
