


The conditions of Western Lands Leases 1287 & 14315, being the land contained within Folio Identifiers 638/765035 & 6861/47973 respectively have been altered effective from 9 April 2021.

As a consequence of the alteration of conditions rent will be assessed annually in line with the Crown Land Management Act 2016 and Regulations.

The conditions have been altered by the inclusion of the special conditions following.

SPECIAL CONDITIONS ATTACHING TO WESTERN LANDS LEASES 1287 & 14315.

1. In relation to WLL14315, current Conservation conditions remain in place for 10 Hectares set aside and gazetted on 25 May 2007.
2. The lessee must ensure every contractor and/or other persons involved in the irrigation cultivation activities in Stage 1 (on WLLs 1287 & 14315) are aware of the approved additional cultivation boundaries, as shown in the diagram below.
3. All equipment to be operated for the proposed activities should be inspected prior to entering the area and cleaned as required to prevent spread of pest species and weeds.
4. Livestock may be excluded from any parts of the WLLs at the direction of the Department.
5. Areas with a slope greater than 2% shall not be cultivated until any soil conservation measures documented in a plan approved by the Department have been implemented at the lessee's expense.
6. The lessee shall undertake any appropriate measures at his/her own expense, ordered by the Department to rehabilitate any degraded cultivated areas.
7. The lessee shall establish windbreaks at his/her own expense as may be ordered by the Department to provide adequate protection of the soil.
8. The lessee shall ensure no tail water or drainage water run-off will escape onto adjoining lands.
10. The lessee is authorised to Cultivate (Irrigate) **127 hectares** as shown cross - hatched on the diagram below within the boundaries of WLL1287 and **629 hectares** also shown cross-hatched within the boundaries of WLL14315. A total of 756 hectares can be Irrigated.
