REGULATION OF VESSELS – EXCLUSION ZONE

Location

Blowering Dam, Tumut

Duration

- 7.00am to 5.00pm – Saturday 22 May 2021
- 7.00am to 5.00pm – Sunday 23 May 2021

Detail

Trials involving the use of a high speed vessel powered by a jet engine will be conducted on the waters of Blowering Dam at varying times on the days specified above. The jet powered vessel will be operating at very high speed and will present a significant potential hazard to other waterway users. There will be support and official vessels present to manage the trials.

An **EXCLUSION ZONE** is specified during the event, which will comprise of the entirety of Blowering Dam, and will be patrolled by Transport for NSW vessels.

At varying times between trials, such as when the jet powered vessel is not being operated, Transport for NSW officers on-site may lift the Exclusion Zone to allow boaters to use the waterway for periods of time.

Other than during these interim periods, unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

MARINE NOTICE

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Cockle Creek, near the locality of the Teralba at the northern end of Lake Macquarie – between the Teralba Bowling Club and the waterway adjacent to the intersection of The Weir Road and Griffen Road.

Duration

- 7:00am to 3:00pm – Sunday 2 May 2021

Detail

Paddleboat races will be conducted on the navigable waters of Cockle Creek, Teralba during the above date and time, and at the location specified above.

An **EXCLUSION ZONE** is specified during the event at the above location, and will be marked by the presence of buoys and patrolled by control vessels.

Special Restrictions - Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to vessels using the transit lane:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (Section 12(5) - *Marine Safety Act 1998*)

Vessel operators are advised that a Personal Watercraft Racing event will be held by Sydney Jet Sports Boating Association on the navigable waters of Georges River during the above dates and times and at the location specified above.

An **EXCLUSION ZONE** is specified during the event on the waters of Chipping Norton Lake, Georges River from Angle Park to Daruk Island and within 300 metres of the shore, which will be marked by buoys and monitored by control vessels stationed around the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

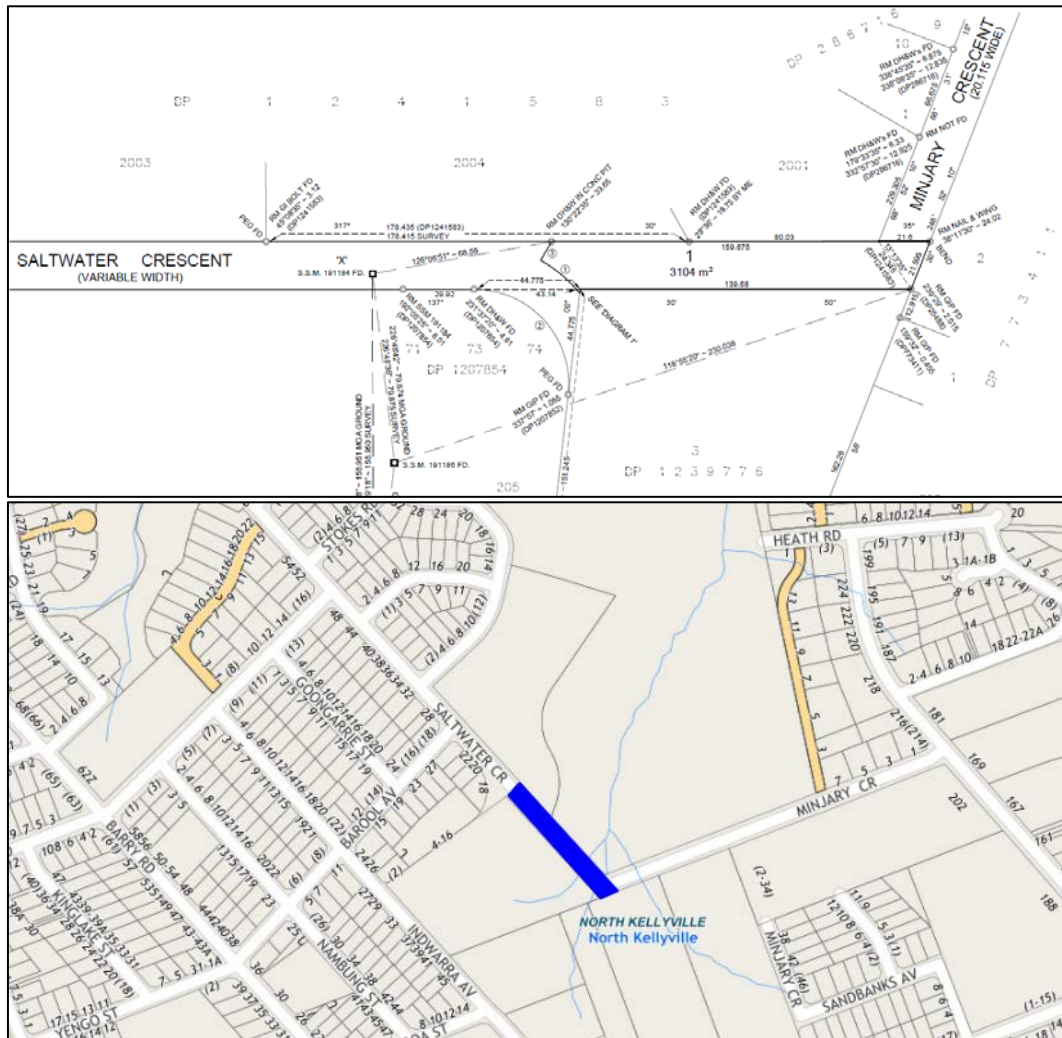
