REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

**Location**

Hunter River, Raymond Terrace – entire width of the river downstream from the Fitzgerald Bridge, generally between the prolongations of Bourke and Swan Streets.

**Duration**

- 9:00am to 5:00pm - Sunday 30 May 2021

**Detail**

A number of high speed powerboat races will be conducted on the navigable waters of the Hunter River at the location and times specified above.

An **EXCLUSION ZONE** is specified during the event, which will be monitored by control vessels stationed on the perimeter.

**Special Restrictions - Transit lane**

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to section 12(3) of the *Marine Safety Act 1998* special restrictions are applicable to vessels using the transit lane:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (Section 12(5) - *Marine Safety Act 1998*)

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

**Location**

Murray River – near the township of Curlwaa 100 metres upstream from the Abbotsford Bridge, near the 846km river marker, downstream to the 840km river marker.

**Duration**

- 7:00am to 4:00pm – Sunday 16 May 2021

**Detail**

A water-skiing event will be conducted on the navigable waters of the Murray River involving the use of high speed power vessels which will be active in the area during the day and time specified above. There will also be support vessels present to manage the event, persons being towed at speed using tow-lines, and persons in the water from time to time – presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event at the respective locations for the entire width of the River between the times specified above.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be marked at each end by the presence of official patrol and control vessels. Vessels that are lawfully moored within the zone at the commencement time may remain in the zone but may not be operated.

**Special Restrictions**

Pursuant to section 12(3) of the *Marine Safety Act 1998*, special restrictions will be imposed on any non-participating vessels already positioned within the exclusion zone:

- Vessels moored or secured to the riverbank within the zone must remain at their position, must be in a safe location well away from river bends and corners and **MUST NOT** be operated during the event;

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Tasman Sea – near the locality of Narooma and within an area (with sides approximately of equal length and a parallelogram in shape) bounded by:

- An imaginary point 0.5 nautical miles seaward from the landmark of Glasshouse Rocks at latitude 36° 14' South (and the northern limit of the Bogola Marine Park Sanctuary Zone), then
- East for a distance of approximately two (2) nautical miles to an imaginary point approximately one (1) nautical mile from the north-western extent of Monatgue Island, then
- North-north-west for a distance of approximately two (2) nautical miles to an imaginary point approximately 2.5 nautical miles east from the southern breakwall of the Narooma Bar, Wagonga Head, then
- West to an imaginary point within 0.5 nautical miles from the shore at the southern breakwall of the Narooma Bar at Wagonga Head.

**Duration**

- 11:00am to 3:00pm – Wednesday 12 May 2021

**Detail**

Aircraft will be used as a part of a marine pollution exercise in the air space over the navigable waters of the Tasman Sea at the location and time specified above. The flightpath will be generally parallel to the shoreline and at a low altitude.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of control vessels stationed around the perimeter of the zone.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by both control vessels and official NSW Maritime vessels.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*).

## **Road Transport Act 2013**

### **APPROVED SPEED MEASURING DEVICE ORDER 2021**

I, the Honourable Margaret Beazley AC QC, Governor of the State of New South Wales, with the advice of the Executive Council, and in pursuance of the *Road Transport Act 2013* (the Act) do, by this my Order, approve the following type of device being designed for uses described hereunder:

An approved traffic enforcement device designed to measure the speed at which a vehicle is travelling (whether or not the vehicle concerned is also photographed), in accordance with section 134(1)(a) of the Act.

#### **Type of approved traffic enforcement device:**

The speed measuring device, **Eagle 3 Radar**, manufactured by Kustom Signals Inc.

REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

**Location**

Main Beach, Byron Bay in an area directly in front of the Byron Bay Surf Lifesaving Club

**Duration**

- 6:00am to 11:00am - Sunday 9 May 2021

**Detail**

The swimming leg of a triathlon will be conducted on the navigable waters of Byron Bay at the location and time specified above.

An **EXCLUSION ZONE** is specified during the event at the above location, which will be marked by a series of high visibility inflatable buoys and rounding marks. Safety and support vessels, powered and passive, will be in attendance managing the event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by Maritime and Police patrol vessels.

**Special Restrictions - Transit Lane**

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'. Pursuant to section 12(3) of the *Marine Safety Act 1998* special restrictions are applicable to vessels using the transit lane:


- Maximum speed limit of 4 knots, and
