## POISONS AND THERAPEUTIC GOODS REGULATION 2008

### ERRATUM

In the notice published in the NSW Government Gazette No 244 of 11 June 2021, page/number n2021-1196 the words 'In accordance with the provisions of clause 175(1) of the Poisons and Therapeutic Goods Regulation 2008 a direction has been issued that the Order that took effect on and from 25 June 2018, on Mr Leonard Ross Devine (MED0001064951) of MALLABULA NSW 2319, prohibiting him as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation, shall cease to operate on and from 11 June 2021.' are replaced with 'In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* an Order has been made on **Dr Leonard Ross Devine MED0001064951** of MALLABULA NSW 2319 prohibiting him, until further notice, as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation. This Order is to take effect on and from 11 June 2021.'. This notice corrects that error.

ORDER

Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 14 December 2018, on **Dr Hasan A Z Al Hashimi (MED0001687473)** of DENHAM COURT NSW 2565, prohibiting him as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation, shall cease to operate on and from 18 June 2021.
