1. Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determination – Eastern Rock Lobster) Notification 2021*.

2. Interpretation

In this Instrument:

Lobster Fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

Lobster Plan means the Appendix to the Fisheries Management (Lobster Share Management Plan) Regulation 2000.

eastern rock lobster means the species *Sagmaraisus verreauxi*.

TAC determination has the same meaning as in section 40A of the Act.

the Act means the *Fisheries Management Act 1994*.
